On 1/4/2023 Officers were dispatched to a welfare check. After investigating and trying to locate the person's involved, Officers were made aware that multiple people inside the house were deceased. Officers entered the home and confirmed that there were multiple deceased individuals. The suspect murdered his 5 children, his wife and his mother-in-law. The suspect then killed himself. There are no other outstanding suspects at this time.

HOMICIDE INVESTIGATION:

INVOLVEMENT FROM EARLIER IN THE DAY:

On 1/4/23 Officer A. Humphreys responded to a welfare check for Tausha Haight.

Stated that Tausha was going through a divorce.

Tausha was believed to be at the home with her soon-to-be ex-husband, Michael Haight. The reporting person stated that she had not made it to an online appointment and can't get in contact with Tausha on the phone. The address provided,

Enoch, Utah) was checked by Officer A. Humphreys, no one appeared to be there.

Officer A. Humphreys and I went to the Enoch City office to see the address where Michael and Tausha had utilities in their name. The address was 4923 N Albert Dr, Enoch. Officer A. Humphreys and I responded to their house. No one answered the door. It didn't appear that anyone was in the home since no noise could be heard. Around this time the Cedar City Police Department took a report of Michael as a missing person. Michael had not shown up for work and missed several appointments. He also left some "personal" documents out on his desk, which was very unusual.

Officer A. Humphreys and I decided to call the Iron County School District to see if any of the children were at school. Officer A. Humphreys made contact with a female from Canyon View Middle School and she advised that the only student that she could see at that time was Briley Haight. She stated that Briley was absent and she was not excused. At this time, I had to leave due to a prior obligation. Officer A. Humphreys continued to attempt contact with Tausha. Please see E23-0012 for further information on the attempted welfare check.

RESPONSE TO THE SCENE AFTER THE DECEASED BODIES WERE LOCATED:

I was at the Children's Justice Center when I received a phone call from Officer A. Humphreys. He stated that they had made entry into the home and there were multiple deceased people in the residence. He informed me that he had already contacted Detective M. Topham to assist as a representative of the Office of the Medical Examiner. I left the Children's Justice Center and headed to the scene.

While en route, I made contact with Detective M. Topham via phone call. I advised him that I was on my way to the scene. He asked if I wanted any additional detectives from the Cedar City Police Department. I told him that I was not aware of what the scene looked like at this time, but additional personnel would likely be helpful.

I also spoke with Officer M. Bleak who advised me that he was already aware and en route. I then made contact with Officer G. Orton as he does crime scene processing for the Enoch City Police Department. He advised that he was aware and had also contacted CSI M. Croft with the Iron County Sheriff's Office, they were both en route.

I arrived on scene and noticed that there was already yellow tape up across the front (East) and side (North) of the home. Officers were also working on blocking both entrances to Albert Drive to keep people out.

I met with Officer M. Bleak, Chief J. Ames, and Chad Dotson, the Iron

County Attorney. I was made aware that a friend of the Haight family, entered the home through an open door after hearing that no one could contact any of them. I also learned that Chief J. Ames, Officer A. Humphreys, and Officer D. Kwiatkowski made entry into the home after advised that he had located multiple deceased bodies inside the house. The home was cleared by responding officers to check for anyone that may need medical attention as well as to ensure there was no longer an active threat. Responding officers located 8 deceased individuals as they went throughout the home. They reported that one of the eight deceased individuals was believed to be the suspect (Michael Haight).

Officer M. Bleak, Chief J. Ames, Chad Dotson, and I determined that we would process the scene with the personnel that were present. Officer M. Bleak, Detective M. Topham, Detective J. Chappell, Officer G. Orton, CSI M. Croft, and I comprised the team that would be doing the initial walk through and processing the scene.

The following assignments were made for processing the scene:

- Lead Investigator: Detective D. Roy, ECPD
- Assisting Investigator/Assisting Medical Examiner: Officer M. Bleak, ECPD
- Lead Medical Examiner: Detective M. Topham, CCPD
- Evidence Technician: CSI M. Croft, ICSO
- Assisting Evidence Technician: Officer G. Orton, ECPD
- OSCAR 3D Photos: Detective J. Chappell, CCPD

Assignments were made to other personnel on scene to assist and follow up with family and friends to gather further information. Officer D. Kwiatkowski offered to write the affidavit for the search warrant to go into the house. A crime scene log was started prior to my arrival and was continued until the home was released back to the family.

ENTRY INTO THE HOME AT 4923 N ALBERT DR, ENOCH:

The Haight home is a single family dwelling with a main level and a basement. The home is on the West side of Albert Dr. and faces East. Albert Dr. is about one block in length and runs North and South between Rachel Lane and Saddleback View Dr.

Once Officer D. Kwiatkowski completed and submitted the affidavit for the search warrant, and it was approved. Entry was then made into the Haight home, through the front door. We set our stuff in the room directly to the South as you enter the front door. This room had a piano, two chairs and a couch in it. I placed the search warrant on the bench of the piano where it was left.

Upon entering the home, there were several photos throughout the home of the Haight family. Some of the photos were older and some of them more recent. The photos helped with determining who the deceased individuals were. The home did not appear to be in disarray.

The initial walk-through took place after entering the home. There were multiple scenes within the home that would need to be processed. We determined that it would be best to process each scene (room) individually. The rooms were labeled A through F and were processed in alphabetical order.

Room "A" was the master bedroom. This room is on the main level in the Northwest corner of the home.

Room "B" was the bedroom on the main level in the Southeast Corner of the home. This was later determined to be Sienna's bedroom.

Room "C" was the bedroom on the main level in the Southwest corner of the home. This was later determined to be Ammon's bedroom.

Room "D" was the bedroom in the Southwest corner of the basement. This was determined to be Briley's bedroom.

Room "E" was in the Southeast corner of the basement. This was determined to be Macie's bedroom.

Room "F" was a room that had exercise equipment in it. It was on the North side of the basement. This is the room where the deceased suspect was located. It appeared that he had been staying/living in this room for a short time.

Each deceased individual was initially referred to by the letter of the room they were located in (A-F) and a number (1-8). This was done due to not initally having positive identification as we began processing the scene's.

A-1: Male child, laying flat on his stomach, his head is turned to the left with his right arm under his head, on the pillow. He was partially covered with a blanket, on the floor, on East side of the bed. This male child was later positively identified as Gavin Haight:

A-2: Adult female, laying on her back, on the bed (East side). Her head was on a pillow and she was partially covered with a blanket. This female was later positively identified as Tausha Haight: 40 years old.

A-3: Adult female, laying on her left side on the bed (West side). Her head was on the pillow and she was partially covered with a blanket. This female was later positively identified as Gail Earl: 78 years old.

B-4: Female child, in her bed, slightly inclined, with her right side down. She was partially covered with a blanket. This female was later positively identified as Sienna Haight: 7 years old.

C-5: Male child, on his stomach, on the floor in the Southwest corner of the room. He did not have a pillow or blanket. This male was later positively identified as Ammon Haight: 7 years old.

D-6: Adolecent female, laying on her left side, located in her bed with her head on the pillow and mostly covered with a blanket. This female was later positively identified as Briley Haight: 12 years old.

E-7: Adolescent female located in her bed with her head on the pillow. She was laying with her right side down and was mostly covered with a blanket. This female was later positively identified as Macie Haight: 17 years old.

F-8: Adult male, located on the floor, on his back. He was on top of a sleeping bag. This male was later positively identified as Michael Haight: 42 years old.

DATE, TIME, CIRCUMSTANCES OF DISCOVERY:

On 1/4/2023, at 1601 hours, a family friend, the entered the home and located several deceased individuals. He entered after several people were concerned that contact could not be made with anyone in the Haight family. Contacted law enforcement and made them aware of his discovery. backed out of the home and let law enforcement clear the home.

DATE, TIME, VICTIM'S WHERE LAST SEEN ALIVE:

On 1/3/2022 each of the deceased individuals were seen and interacted with at different times and different locations. The children were at school and church activities. Tausha was seen at a church activity as well as getting the children to and from school and the church activity. Gail was heard on a video recording obtained from Michael's cell phone that was recorded the evening of 1/3/2023.





asked to meet at CCPD as it was a close location for them. They also requested that Jaden be present during the interview.

on 1/10/2023 Jaden and I met with where and I spoke. Informed me that she and Macie had been friends for a long time. She stated that recently Macie informed her that she had a "secret" phone hidden in her room. She further stated that she was recording her dad when he would "act crazy". Macie told that she was doing this to use as evidence for her parents divorce. Stated that she had not seen any of the videos or files on the phone, she was just told by Macie that they were on the phone.

stated that just before Christmas, Macie's mom found the phone and took it away. Macie was unsure where her mom put the phone.

stated that Macie also talked about her parents divorce and was very excited that they were getting divorced. DCFS FOLLOW UP:

I reached out to Glenn Stockton with DCFS as I had recently been informed that he was the caseworker for a case that was opened just before Christmas. I asked Glenn if he was the one who had spoken with Macie at school. Glenn stated that he was and that it was the same allegations as the case that was opened in 2020. Glenn stated that there were no new accusations. Glenn further stated that he intended to follow up with Tausha on 1/5/2023, but learned about what had happened. He was never able to speak to Tausha in reference to the allegations being brought back up.

Glenn spoke of the allegations and interaction with Macie. He stated that there were no new allegations. He completed the suicide screener with Macie and let her know that he would be contacting Tausha to make her aware of the allegations being reported again and that he spoke with Macie.

I asked Glenn if he would send me a copy of the CANR as well as any other documentation during his visit. Glenn informed me that he would check with his supervisor and send the documents to me if he is allowed. A short time later I received an email from Glenn with the documents.

The CANR and notes from Glenn's conversation with Macie are attached to this case. Please refer to those documents for further information regarding the allegations and action taken by DCFS.

ADDITIONAL INFORMATION:

ECPD never received a CANR for the "new" DCFS case when it was first reported on 12/8/22. I was recently informed that this was due to there being no new disclosures. Everything she disclosed was already investigated in 2020 and was just brought back up again.



On 1/4/23 at about 1450 hours I received a phone call from Officer A. Humphreys. He updated me on the welfare check call that he was on (E23-0012). As of this phone call he hadn't been able to make contact with Tausha or Mike Haight. We discussed other people he could reach out to, to try and get a hold of them. At this point I started getting ready to leave Enoch PD to head to the Haight residence to provide additional help on trying to locate them.


On 1/4/23 at 1559 hours I received a call from and he told me that he went inside the house and law enforcement needs to get to the house quickly because there's dead bodies inside the house. I immediately responded to the scene and updated dispatch and other law enforcement Officers of what I was told.

I arrived on scene and Officer A. Humphrey's was already inside the house. Officer D. Kwiatkowski arrived just seconds behind me. Officer Kwiatkowski and I entered the house through the garage and the three of us Officers cleared the house. Once we knew the house was secure, I then went back through the house again with Officer A. Humphreys to more thoroughly identify exactly how many people were deceased inside the house. After this second check of the house we secured the house with crime scene tape and posted an Officer at the front door.

At this point I worked on coordinating resources and making assignments for the investigation. Sgt. D. Roy was assigned as the lead investigator on this case.

INITIAL RESPONSE:

I was contacted in regards to a missing person call unfolding in Enoch City. Shortly after that I was advised that there were dead bodies. I spoke with Sgt. Roy. He indicated that he was enroute to the scene. He asked if I would respond. While enroute, Chief Ames advised that they had confirmed 8 bodies.

Scene Assignments:

The Iron County Sheriff's Office provided their mobile command center at the scene. We met inside and determined the following:

- Sgt. Dustin Roy of Enoch City PD would do the general investigation.
- Officer Mike Bleak of Enoch City PD would investigate and assist with handling the deceased.
- Detective Matt Topham of the Cedar City Police Department and the Utah State Office of the Medical Examiner.
- CSI Mickelle Crofts of the Iron County Sheriff's Office was lead evidence technician.
- Officer Gary Orton of Enoch City PD assisted Crofts with CSI.
- Detective Justin Chappell of Cedar City PD was asked to assist in 3D crime scene photography.

ENTRY TO THE SCENE:

The scene consisted of a single dwelling residence of the Haight family located at 4923 N. Albert Drive in Enoch City. This residence has a single level main floor with a basement. The various scenes were located in the bedrooms on both levels and an exercise room located in the basement of the house.

The scene was split into 6 labeled rooms. The rooms were as follows:

- "A" The master bedroom was designated as room A.
- "B" The bedroom on the south east corner of the upper level is now determined to be "Sienna's Room."
- "C" The bedroom on the south west corner of the upper level of the house is now determined to be Ammon's room.
- "D" is the bedroom located in the south west corner of the basement. It is now determined to be Briley's room.
- "E" The bedroom on the south east side of the basement is now determined to be Macie's room
- "F" Weight Room located on the north side of the family area is now determined to be the suspect room.

The victims and suspect were originally designated as letters and numbers pending positive identification. They have all been positively identified at this time. These designations are as follows.

- Al, Male child located on the floor, east of master bed. Child was positively identified as Gavin Haight, 4 years old.
- A2, Adult female located in the bed on the east side. Positively identified as Tausha Haight, 40 years old.
- A3, Adult female located in the bed on the west side. Positively identified as Gail Earl, 78 years old.
- B4, female child located in the bed. Positively identified as Sienna Haight, 7 years old.
- C5, Male child located on the floor on the south west corner of the room. Positively identified as Ammon Haight, 7 years old.
- D6, Female Adolescent located on the bed. Positively identified as Briley Haight, 12 years old.
- ${\sf E7}$, Adolescent female located on the bed. Positively identified as Macie Haight, 17 years old.
- ${\tt -}$ F8, Adult male, located on the floor of the room. Positively identified as Michael Haight, 42 years old.

This information was garnered from Utah DL files, Iron County School District Powerschool database, and family documents and photographs located within the scene. We made the designations of identity. Detective Topham was the assigned Investigator from the Utah State Office of the Medical Examiner. I assisted him in those investigations. My role was primarily as an Investigator for the Enoch City Police Department.

URGENT CONSIDERATIONS

This case involves a mass shooting with 8 decedents involved including the suspect. This appears to be a murder suicide perpetrated by the father of this family, Michael Haight. The victims include the suspects wife Tausha Haight, the suspects mother-in-law Gail Earl, and the suspects 5 children. The children are identified as 17-year-old Macie Haight, 12- year-old Briley Haight, twin 7-year-olds Ammon Haight, and Sienna Haight, and 4-year-old Gavin Haight.

IDENTIFICATION

Each of the decedents have been presumptively identified. Enoch City is a small community and several of the responding police officers know this family well, as such they were able to identify each of the family members. In addition to this, officers were provided with photo identification for the 5 children by the Iron County School District as each of these children is a student in the school district. Officers were also able to locate the driver's license photos for the three adult decedents as well as the 17-year-old, Macie. Tausha has recently lost a large amount of weight, therefore her appearance has changed. Officers in addition to recognizing her from previous personal acquaintances also found some recent family photos that show Tausha after she had lost this weight. Each of these photographs of the decedents has been sent to the Office of the Medical Examiner as well. In addition to this I have found that the dentist for Gail, Tausha, Macie, Briley, Sienna, Ammon, and Gavin is

INITIAL CIRCUMSTANCES OF DEATH

This investigation initially began as a welfare check for this family as Tausha had not shown up for an important meeting and Michael had also not shown up for work or any of his meetings either. In addition to this, all 5 children had been absent from school and these absences had not been excused. This is all very abnormal behavior for this family. Officers were unable to contact any of the family members when they knocked on the door. A short time later, responded to the home as well. The entered the home and then quickly called for a police response as they had found multiple deceased individuals in the home. When officers again arrived on scene, they cleared the residence looking for any possible suspects and or threats in the home. They found that Tausha, Gail, and all 5 children were deceased in the home. They also found that Michael was also deceased by what appeared to be a self-inflected gunshot wound to the head. Each of the victims in this case also appeared to have a gunshot wound to the head as well. Some of the victims appear to have been shot multiple times.

SCENE

This crime scene is in the home of the Haight family located in Enoch City. This is a single-family residence that has a main level and a basement. There are three bedrooms on the main floor and two bedrooms in the basement. There are also several storage rooms and a workout room in the basement as well. This home is well kept and well furnished. Each of the bedrooms in this home as well as the workout room in the basement was found to contain a decedent or decedents.

SOCIAL HISTORY

Michael and Tausha have been married for over 20 years. All five of their children were born during this marriage. They have strong religious beliefs and are members of the Church of Jesus Christ of Latter-Day Saints. They attend their church meetings on a consistent basis and the kids are active in school and sports. They have many friends in the community and through school. This family is well liked and respected in the community. Michael is an insurance agent with Allstate. According to several witnesses in the course of this investigation, Michael was recently fired from Allstate. It is reported that he was in the process of opening an independent agency based on the recent termination.

On December 27, 2023, Tausha filed for divorce from Michael. It appears that Gail Earl, Tausha's mother, was staying with them in the home due to safety concerns that Tausha had with Michael being in the home. It appears that Michael has been sleeping in the workout room in the basement as he has a sleeping bag and pillow on the floor of this room as well as all his clothing on hangers that are piled on the couch just outside of this room.

MEDICAL HISTORY

Each of these decedents appear to have been in very good health prior to this incident. It is unknown who the family physician is. It is not known when each of the family members had last been seen by the family doctor. However, the family dentist for everyone, except Michael,

None of the decedents have a history

of tobacco use or military service. Gail has had some college but not earned a degree, while both Michael and Tausha have college degrees.

PSYCHIATRIC HISTORY

There is no known history of mental illness in the family. Michael's father committed suicide in 2018 and his OME Case number was 201800901.

ADDITIONAL INFORMATION

This appears to be a murder suicide with 7 homicide victims and one death by suicide. Each of the homicide victims have deficits to the head that are consistent with gunshot wounds. The suspect also has a deficit to his head that is consistent with a self-inflicted gunshot wound.

Pre-Transport Decedent Examinations:

Gavin Haight:

Gavin who is 4 years old was found to be laying on the floor with part of a blanket underneath him and the rest of the blanket folded on top of him. He was laying in the prone position on the floor on the east side of the bed. His arms were folded up under his head as a pillow. He also had a regular pillow under his head as well. He was wearing blue pajamas with monkeys printed on the pants He has a single contact wound deficit to the back of his head just behind and above his right ear, this has a stellate pattern and muzzle burn around the deficit. He has a corresponding deficit in his face and another one on the back and palm of his right hand. The deficits on his hand are lined up with the deficits on the back of his head and on his face. A bullet fragment was later located inside the pillow that was under his head and in line with the deficits on his head and right hand.

Gavin Haight was transported by Affordable Funeral Services. He was sealed in an OME issue body bag. His hands were bagged, and an identification bracelet affixed to his wrist. A piece of yellow duct tape was affixed to the exterior of the body bag with the case number and the designation of "Al, Unidentified Male", as positive identification was not made at the time. The bag was sealed with #0000633.

Tausha Haight:

The decedent identified as Tausha Haight, is the mother to the deceased children and the wife of the suspect. Tausha was in the master bedroom on the main floor of the house. This decedent was in the supine position on the east side of the bed. She was partially covered with bedding. There was a large amount of

pooled, dry blood surrounding the head area. There was matted blond hair on the pillow. It was hard to determine the details of the deficits on the decedents head currently. Later in the investigation, the decedent was moved, and a more thorough exam was conducted. There was a linear open injury along the jawline leading to the left ear. This injury was consistent with a bullet grazing the skin and causing a deformity near the left ear. There was stippling and tattooing near this injury consistent with a fairly close proximity of the barrel of the gun when fired. There was another deformity just above the right eye in the forehead area. There was stippling and tattooing around the circumference of this deformity. There was blond hair, consistent with this decedent that was pushed through a bullet hole in the pillow. This hair of the decedent protruded out the back side of the pillow. There was a .40 caliber projectile that traveled through the pillow, mattress, and lodged in the wall behind the bed. This projectile was recovered by evidence technicians.

Tausha Haight was transported by Southern Utah Mortuary. She was placed in a white body bag that was procured from Cedar City Hospital mass casualty. Her hands were bagged, and an ID bracelet attached to her wrist with the designation, A2, because she had not been positively identified at that time. A strip of yellow duct tape was affixed to the exterior of the body bag with the designation of A2. The bag was sealed with OME seal #0002014

Gail Earl:

The decedent identified as Gail Earl was in the master bedroom of the main floor of the house. She was located on the west side of the bed. She was dressed in a purple nightgown and LDS temple garments. The decedent had a deformity above the left eye in the forehead area. This deformity was surrounded by a stellate pattern injury. There was a dark soot ring around the injury consistent with a contact gunshot wound. There was a deformity on the right side of the head as well. There was a .40 caliber projectile located on a pillow on the opposite side of the bed. The trajectory of this apparent injury matched the location of the projectile. There was a large amount of blood and gray brain matter surrounding the head of this decedent.

Gail Earle was transported by Southern Utah Mortuary. She was placed in an OME issue body bag. Her hands were bagged, and an ID bracelet affixed to her wrist. The designation on the wristband is "A3" due to the fact that she was unidentified at the time. A yellow duct tape strip was affixed to the exterior of the bag with the designation "A3". The bag was sealed with #0002103.

Sienna Haight:

This decedent is a 7-year-old female identified as Sienna Haight. She was dressed in a long sleeve purple shirt with pink and white heart pattern pants. Sienna was covered with bedding. She appeared to be sleeping at the time of death. There as a single deficit to the upper left cheek, behind the eye. There was stippling and tattooing surrounding the deficit. There were no other deficits located on this decedent. There was a .40 caliber Federal shell casing found on the floor behind the bed.

Sienna was transported by Southern Utah Mortuary. She was placed in a white vinyl body bag acquired from Cedar City Hospital. Her hands were bagged, and an ID wristband affixed to her wrist with the designation B4, because she was not identified at the time. Ammon Haight:

This decedent is identified as Ammon Haight, a 7-year-old male. Ammon is the twin of Sienna, (202200050). Ammon was in his bedroom at the southwest corner of the main floor of the house. This room includes a large wooden bunk bed on the south wall of the room. This is a wooden bunk bed with wooden stairs descending the west side of the frame. The decedent was in the southwest corner of the room, in the corner between the end of the bed and the corner. dressed in Black, red and white bear and moose print pajamas, with white socks. The wall behind the bed had blood spatter that was consistent with originating at the head of the bed. There was a large amount of blood on the west end of the bed and going down the stairs. There were voids in the blood spatter that were consistent with small, socked feet prints. There was also a blood smear on the step that was consistent with the bottom of a small child. The decedent was found face down in what I would describe as an "army crawl' position. There was an obvious deformity on the back of the decedent's head. There was a large amount of blood pooled near the head of the decedent. The decedent's buttocks of the pajamas contained a blood pattern transfer that was consistent with the wipe pattern in the stairs. There was blood on the bottom of the decedent's socks that was consistent with the sock print footprints in the blood on the stairs. There was blood spatter on the top of the decedents socks that was consistent with the void patterns in the stairs. When the decedent was moved and examined further, there was a deformity located between the eyes. There was also a deformity to the left side of the head near the ear. There was obvious damage to the mouth area. There was blood and obviously broken teeth. Upon a search of the bedding and bed frame there were numerous teeth fragments and whole teeth located. There were also teeth and fragments located on the floor near the body. There were projectile fragments recovered from the bedding, and wall behind the bed. There were 2 shell casings located on the floor of the room.

Ammon was transported by Southern Utah Mortuary. He was secured in a white vinyl body bag, procured from the Cedar City Hospital. The hands of the decedent were bagged, and a ID bracelet affixed to the wrist. The bracelet was marked as "C5." At the time the decedent was unidentified. There was a yellow duct tape strip affixed to the outside of the body bag with the designated number C5. The bag was sealed with #0002059

Briley Haight:

This decedent was identified as Briley Haight. She was in the basement, West side bedroom. She was in a bunk bed on the top. She was dressed in a red t-shirt, black yoga pants and orange and gray socks. She had a deformity on the back of the head that had a dark soot ring and stellate pattern surrounding the deformity. There was a .40 caliber shell casing located on the floor near the bed.

Briley was transported by Affordable Funeral Services. She was placed in an OME issue body bag. Her hands were bagged, and an ID bracelet affixed to her wrist. The designation D6 was assigned to the decedent because she was not identified at that time. There was a yellow strip of duct tape affixed to the outside of the body bag with the designation of D6. The bag was sealed with #0002464

Macie Haight:

This decedent was identified as Macie Haight. I recognized this decedent as a victim in a child abuse case that I had previously investigated with her father, Michael Haight being the suspect. I was also able to locate a Utah Driver's License bearing Macie's name and description on the desk in her bedroom. This was consistent with her Utah DL. This decedent was in the prone position on the bed. She was partially covered with bedding. Her left leg was hanging out the side of the bed. There was a large amount of pooled blood by her head dripping to the floor. There was a deformity in the left eye of the decedent. There was a .40 caliber shell casing located on the bed, on top of the comforter.

Macie was transported by Affordable Funeral Services. She was placed in an OME issue body bag. Her hands were bagged, and an ID bracelet affixed to her wrist. The designation E7 was on the bracelet. There was a strip of yellow duct tape affixed to the outside of the body bag with the designation E7. The bag was sealed with #0002395.

Suspect, Michael Haight

This decedent was in a small weight room located on the northern end of the basement family room in this house. The decedent was found in the supine position. There was a deformity on the left side of the head that had a dark soot ring and stellate pattern surrounding it. There was a deformity in the right side of the head. There was a bullet hole in the wall directly in relation to where the decedents head would have been at impact. A .40 caliber projectile was recovered on the back side of that wall in the family room. It was confirmed that the decedent is left-handed. There was a Springfield Armory XD .40 caliber pistol located between the decedent's legs and slightly under him. The decedent had large wads of tissue paper crammed into his ear canal's, presumably to muffle the sound of gunfire. There was a handwritten note next to the body. The note expresses his blame of everyone around him for his shortcomings. He makes the statement, "I would rather rot in hell than to put up with one more day of their manipulation and control over me."

This decedent was transported by Affordable Funeral Services. He was placed in an OME issue body bag. His hands were bagged, and a bracelet affixed to his arm with the designation of F8. There was a strip of duct tape affixed to the exterior of the body bag with the designation of F8. The bag was sealed with #0003174.

INTERVIEW WITH

I received the names of that indicated that they might have some pertinent information. They indicated that and Tausha were particularly close. They spent time daily, walking and hanging out. Tausha would confide in the suspect was very mean. She indicated that he was very concerned about keeping up his appearance socially, personally, and professionally. She stated that he had been very mean to her for a long time. She stated that the abuse was starting to extend to the children more frequently. She stated that this was the reason that she was finally filing for divorce.

Tausha indicated to that each of the children had about \$20,000 dollars in savings accounts. She learned that the suspect had moved that money from those accounts. She was unsure what the motivation was for that action. Tausha told her that she had inherited several firearms from her father when he passed away. There were some hunting rifles and at least one handgun. The handgun was reportedly kept in Tausha's nightstand drawer. Tausha told that the suspect removed her firearms from the house, including the one in her nightstand. She indicated that these firearms were discovered missing on 01/02 or 01/03 2023, (See Sgt. Roy's supplement for more information.)

stated that Tausha was "distraught" with the suspect behind closed doors. She stated that Tausha had to keep up the appearance of a perfect family in public. Tausha told that the suspect would protect his reputation at all costs.

indicated that he has done business with the suspect. He indicated that he had a family member purchase a new vehicle within the last couple of weeks. When they went to purchase insurance from the suspect and Allstate, they were advised that he was no longer an Allstate agent. Called the suspect on 12/23/2022, to see what the situation was. He was told that the suspect was going to be an independent agent. He explained that he would be able to provide a better rate. The suspect stated that he was forced to sign a non-compete agreement with Allstate that was going to expire on 01/01/2023 (9 days). He advised that he would arrange a policy for them at that time. Saked the suspect if he was going to be all right financially with the new arrangement. He indicated that he was fine. He stated that he owned the building that they were in. He stated that he was collecting rent and had other investments.

I asked if they had any idea what kind of handgun Tausha kept in her nightstand. They did not have any idea.

He responded with, "I've got my hands full right now. " text the suspect on 1/4/2023 at 1016 and asked, "Is there anything I can do for you. Are you alright." There was no response. Following the death of the suspect, was approached by outlining the strange circumstances of the meeting that he had with him. At this meeting, the suspect disclosed to that he had been terminated from Allstate with cause. He advised that he had given Allstate his notice to leave. When he asked them about his end of year bonus that he earned, he was told that he would still receive his bonus. A short time later, the suspect was notified by Allstate that he was going to be terminated because there were some improprieties in his books. According to him, this was a way that Allstate did not have to pay him. At the end of this meeting, the suspect produced a non-disclosure document and asked to sign it, agreeing to keep his disclosure quiet. advised that he would have to share this with if he were to be

considered for an appointment with the company. The suspect stated that he especially wanted to keep this information away from After the death of

the suspect, told about the meeting.

went on to explain to me that if there was a termination from Allstate with cause, this information would be attached to the agent license. He explained that with that information it would be very unlikely that a major company would appoint him to an agent position.

In the world of independent agents there is the ability to be appointed to, for instance, 200 agencies. This gives the ability to shop around for a client's needs. In the event of an agent with a termination for cause attached to a license, this would considerably limit the number of smaller insurance agencies that would choose to deal with him. This would in affect end a career as an insurance agent.

indicated that he had reviewed all the suspect's portfolio. He indicated that there were enough assets for the suspect to retire and collect several hundred thousand dollars a year for life. The suspect rejected this option. He was worried about what that would look like to people on the outside.

Aside from any discussion about insurance business, stated that the suspect was very worried about his appearance in every way. He would do nothing to portray anything but a perfect life both personally and professionally.

He indicated to that he was going to try and be out of Allstate by the end of the year. had the conversation with the suspect encouraging him to check out coming to work with a street also connected the suspect with a The suspect agreed to have lunch with and talk about the possibility of The suspect was also considering becoming an independent agent. He indicated that he was weighing the options between the two. contacted the Suspect on the 17th or 18th of December. They met for lunch on Dec 22nd. During that discussion, the suspect indicated that he had been terminated with cause from Allstate. He told that it was a wrongful termination and he was going to get to the bottom of it. The suspect advised that he advised Allstate that he was going to leave the company. When he asked if he was going to receive his bonus for the year, they told him yes. A short time later he stated that they told him that they were not going to give him his bonus. According to the suspect, Allstate advised him that they had reviewed his transactions and found policy violations. They were terminating him instead of paying him the bonus. 

stated that she had a unique relationship with Tausha. She stated that they would often compare marriages.

stated that Tausha had a rocky relationship with She was said to be made to feel inferior because she was not Tausha often reported that she was blamed for anything that might not have been perfect in the marriage or with the family. Stated that Tausha had told her that she had recently set some hard boundaries with This did not go over well and caused contention between she and the suspect.

Tausha spoke with the day that the suspect was served with divorce papers. Tausha told her that the reaction was bizarre. She told her that the suspect called her after he was served with divorce papers and asked, "How's your day going?" Tausha asked him if he had been served divorce papers. He replied that he had been given some papers, he assumed that they were divorce papers. The suspect instructed Tausha that she needed to leave the house before he got home. He also instructed her not to take the children, they needed to be left with him. Tausha left the home and took the children with her to stay at her mother's house in LaVerkin Utah.

they didn't dare speak inside. Tausha believed that there was a possibility that she was being monitored. She stated that when she and Tausha would text back and forth, Tausha would always respond in short, positive messages, in the event that the suspect was monitoring her messages.

indicated that Tausha would speak with every day.

reported to have fled that marriage with her children due to concerns for her and her families safety.

was said to be encouraging Tausha to get out of the marriage. She is reported to have been Tausha's "rock." It should be noted that Det. Roy and I have an interview scheduled with in the near future.

indicated that the suspect was controlling in every way with Tausha. He was reported to have taken her phone and keys to the car and the house at times to prevent her from leaving. There was a recent incident where there was \$300 dollars of groceries and items from Wal-Mart delivered to the house. Earlier in the day there was a rug in the kitchen that had been soiled somehow. Tausha spent \$30 dollars to replace that rug. The suspect became angry because he had given her a \$300 limit to spend. She was in trouble because she should have included that rug purchase within the Wal Mart purchase and gone without something else.

There is another recent incident that reported. She indicated that Tausha was given an allowance of \$100 per child (\$500) for Christmas gifts. She was very proud of herself because she felt that she was able to provide a good Christmas for the kids on that budget. The suspect reportedly did not provide any gifts for the family. Tausha was especially irritated about this

situation. She stated that she knew that they had money because she had seen a sizable check from Allstate Insurance, addressed to the suspect just prior to Christmas.

Tausha had told that she was given a small allowance that she had been putting aside for a long time so that she could move forward with the divorce.

I initially met with During the course of our conversation, she mentioned that she had some background information that she would like to share. During the course of our conversation, she mentioned that she had some background information that she would like to share. During and Tausha have been friends and neighbors for many years. I agreed to meet at her home at a later date when it was a more appropriate environment to talk.

I responded to home and met with her there. She stated that they lived near the Haights before when they were fairly newly married. She stated that Tausha would come over to her house often and ask questions about if situations in her marriage were normal. For example, Tausha told her that the suspect would make her wash out used plastic bags and re-use them. He would also make her cut baby wipes and cleaning wipes in half. If he caught her doing anything different, she was in a lot of trouble.

She stated that in Sept of 2021, Tausha told her that she and Mike were separating and that she had gotten him to move in with his mother for a while. He was required to get counseling and agree to help take care of the children if he were allowed to come back home. The suspect agreed to these stipulations. She stated that when he moved back in to the house that the relationship was much better for a little while. Tausha told her that, "Without Mike here my house is a dream. Everything is so smooth."

She stated that she had been to a youth dance at their church on new years eve. She stated that she had a conversation with Macie at that event. Macie told her, "Dad's being a jerk again. My mom finally filed for divorce, and I couldn't be more excited. He needs to go." Macie also stated that, "My dad keeps love bombing me. He will not leave the house. I just want him to go."

She stated that Sienna was always happy and bubbly. She said that Ammon was more somber. She said that there were times that he would be asked to do something and he would reply, "That's not my job." mentioned this to Tausha

Tausha responded and said that Ammon was acting more and more like his dad. Tausha stated that she was working really hard at home to correct that behavior in Ammon.

compared Tausha to a frog in boiling water. She stated that the tension in her home would slowly build till Tausha didn't realize that she was in trouble. She also told me that Tausha would often tell her that she had made a commitment to her marriage and family and wanted to honor that commitment.

This interview took place at the Enoch City Office. These two ladies contacted me and indicated that they had been involved in several therapy sessions following the murders. They indicated that they were in a more stable emotional state and wanted to talk with me. They indicated that they had some background information about the Haight's.

During the course of the last several years, they would visit with Tausha and the children in their home several times a month. They would also frequently text with and talk with Tausha.

stated that during the summer of 2022, Macie was having suicidal ideations because of the way that the suspect was treating her. There was an out-of-town church activity known as EFY. Tausha was hesitant to let Macie go because she was worried about her health. Macie ended up going to the activity and came home refreshed and feeling better.

She stated that the suspect expecteded Macie to earn straight A's in school. Macie would often bring homework to activities and not participate because it was easier to get the A's and avoid the abuse.

related a conversation that she had recently with Tausha. Macie was depressed and was lying on the couch with her head on Tausha's lap. The suspect came in and ordered Macie to get up and go clean her room. Tausha told him to leave them alone. Macie said, "He looked at me like he hates me. His eyes looked pure evil."

would often go to the house and help Tausha wash the dishes and clean the house so that the suspect wouldn't have anything to yell at her for when he got home from work. Tausha was worried that there might be listening devices in the house. When they would talk, they would turn the water on in the sink and speak in low voices.

They indicated that several months prior to the murders, the family was sitting in the living room. Tausha was reading from the scriptures after church on Sunday. Briley was playing with a charging cable. The suspect told her to quit playing with the cable. She kept playing with it. The suspect stood up and started yelling at Tausha, saying that they had the worst kids in the world. He stated that they were disrespectful and awful kids. He told Tausha that it was her fault. He told her that she was fat and ugly and a terrible mother. This all occurred in front of the children. Tausha told them that she realized that none of the children even flinched or responded when this happened. Tausha said that at that moment she made up her mind that she was going to prepare an exit strategy and go through with the divorce.

During the summer of 2022, they indicated that Tausha began to get really strong. They stated that Tausha had been in therapy steadily since the 2020 incident. The suspect would attend therapy when he would feel like he was losing control. He would attend long enough to placate Tausha then quit. During this time, Tausha went and got her fingernails done. She was really proud that she had the courage to do that. The suspect was angry. He asked her

how much money he was going to have to pay for that. She told him \$25 a month. He told her that would take food away from the children. Tausha told him he would have to sell more insurance. During this time Tausha also began to lose a significant amount of weight. This upset the suspect and he began accusing her of having an affair. She told him that she was not having an affair and that she was losing the weight for herself. He became angry often and told her to stop losing weight, that she looked fine. Tausha was proud of herself and told the ladies, "I'm not losing weight for any man. I'm doing it for Tausha!"

On Thursday, December 29, Briley came to house to hang out with She told them, "Thank you for letting me come over. I need a break from my house. My dad is terrible."

The ladies indicated that when they would go to the house, the suspect would appear and suddenly act caring and helpful. When he would leave the room, they would all laugh a little. They described the behavior as "disgusting."

Tausha confided that she was filing for divorce a few weeks earlier. She was careful to keep it a secret so that the suspect couldn't try and talk her out of it. On the day that the suspect was served the divorce papers, Tausha arranged for all of the kids to be at a neighbors house because she feared for their safety if the suspect were to come home. After the suspect was served with the papers, he called Tausha. He asked how her day was going. He acted as if nothing had happened. Tausha asked him if he got divorce papers. He acknowledged that he did. He told her that she needed to be out of the house when he got home. He also told her that she was to leave the kids there. Tausha packed up the kids and left the house to stay with her mom in LaVerkin for the weekend. Tausha stated that the suspect showed up at her mother's door unannounced in LaVerkin. He kept trying to get Tausha to leave with him and "go for a drive." Tausha told them that she had a terrible feeling and felt like she shouldn't go anywhere alone with him. She ended up shutting the door in his face and telling him to leave.

Tausha and the kids came home Saturday night. They attended church on Sunday. The suspect also came to church. Tausha would not let him sit with her of the kids, he sat several rows back. According to the ladies, the suspect was angry because his public image was going to be questioned because he was not sitting with his family.



During the summer of 2022, Tausha indicated that the kitchen table was getting worn out. She was told that it was her fault because she didn't control the children. She was told that they weren't going to spend money on a new kitchen table. Tausha decided that she was going to re-finish the table on her own. She bought the materials and re-finished the table in one day. The suspect was angry because he had not given her permission to do so. Tausha called and and invited them to come over and look at the table. They indicated that she had done a great job and was very proud of herself. They talked about this just being another example of Tausha gaining her independence. They also indicated that starting in this period, the suspect seemed to be more desperate

to keep control of the narrative that the family was sharing.

12/30/2022, 1041 hrs. - 1121 hrs. - The suspect Google searches various topics. Topics include, "How loud is a 9mm gunshot." "What does a gunshot sound like?" "I heard gunshots near my house, what do I do?" "If you heard a single gunshot in your neighborhood at night would you immediately recognize it as such? Would you either way be alerted enough to call the police, or would you chalk it up to being just another sound in the night?" "How loud is a gunshot in a house?" "Would a neighbor hear a gunshot in a garage?" "How loud is a 40 mm pistol?"

12/31/2022 - Macie tells dance chaperone that her dad is being a jerk again. She is excited about the pending divorce.

1/2/23 - Tausha reports that firearms are removed from the home to her attorney.

1/3/23 - Briley reports to that her parents are divorcing. She is really excited to have the suspect out of the house.

1/3/23 - Tausha meets with her attorney and discusses financial issues in the divorce.

1/4/23, 0330 hrs. - After the fact, a neighbor reports hearing what she thought were fireworks. She describes the cadence of the sounds.

1/4/23, 1102 hrs. - A welfare check was requested at the Haight residence when family members were determined to be missing from various obligations. Officer Humphreys attempts to make contact at the address.

1/4/23, 1350 hrs. - A welfare check is requested on the suspect by It is reported that the suspect has been acting strange for a couple of weeks.

1/4/23, 1400~hrs. - Officer Humphreys returns to the residence in an attempt to check the welfare. The house was secure and nothing visible through the windows.

1/4/23, 1400-1550 hrs. - Various attempts to make contact with the Haight family by ECPD and Cedar City PD.

1/4/23, 1550 hrs. - Neighbors enter the Haight home to check welfare. They see a body on the bed with blood. They back out of the house and call police.

1/4/23, 1601 hrs. Enoch Officers arrive and determine that there are deceased bodies in the residence and the radio channel is prioritized.

RESPONSE TO HOME:

On January 4, 2023, I was flagged down by Chief Ames as I was heading to the office. I turned around, Chief continued east on Midvalley. He then initiated his emergency lights and so did I. Chief then got on the radio and stated he received a call regarding a deceased body in the home.

Upon arrival, I checked the front door. It was locked. We then made our way into the home from the garage. We were met by was going to let us take over. Officer Humphreys was already in the home at the end of the hallway next to the garage. We met up with him and then began to clear the home. As we were clearing the upstairs, Officer Humphreys and I moved to the bedrooms on the south side of the home while Chief Ames covered the stairs to the basement. Officer Humphreys and I cleared those bedrooms and discovered two deceased children. We then made our way back to Chief Ames and continued to the basement. The first four doors were checked and cleared, also discovering two more deceased children. The fifth door was locked when checked by Chief Ames. I immediately kicked the door in and moved in to clear the room. We then moved to the north side of the basement where we discovered a deceased adult male and another locked door. I kicked the door in and the room was cleared. Once finished, we exited the home. Chief Ames obtained crime scene tape from his truck and started to set up the crime scene. I started a log for individuals coming in and out of the home. We advised Dispatch to contact the County Attorney's Office and the on call OME's.

Once Detective Topham arrived on scene he stated we needed to get started on a search warrant. Sgt Roy arrived on scene shortly after that and I asked him if he wanted me to type the warrant, he stated yes. The warrant was approved, Crime Scene Specialists, OME's Mike Bleak and Matt Topham, and Sgt Roy then made entry into the home.

I further assisted with scene security and helping the Mortuary's get the bodies of the deceased out of the home. Once finished, I cleared the scene.

HOMICIDE INVESTIGATION:

Initial Response:

I received a call from Officer Humphries informing me that I was needed to assist with a missing person investigation that turned into a homicide case. I called Mickelle Crofts, CSI with the Iron County Sheriffs Office and asked her if she would be available to help with processing the scene. Mickelle stated she would help but asked that I call her supervisor as well. I called Detective Nate Houchen with the Iron County Sheriffs Office to ask if Mickelle Crofts could assist us with our scene processing. Detective Houchen said it was fine to have Mickelle help and that he would head to the scene to help with anything else we might need. I reported to the Enoch City Police Department to gather some equipment and our crime scene trailer and rode with Officer Carter to the scene.

On Scene:

The scene was located at 4923 N. Albert Drive, Enoch, Utah. The scene was a single residence two story dwelling with a main level and a basement. I arrived on scene and met with the officers on scene. It was determined that I would be on the team that would assist CSI Mickelle Crofts processing the scene.

Entry to the scene:

Once entry was made, it was determined that there were various scenes located in different rooms on both levels of the house. The scenes were split into 6 rooms labeled with letters A thru F.

- Room "A" Master Bedroom and adjoining bathroom located on the main level
- Room "B" Bedroom in the South East corner of the main level of the residence
- Room "C" Bedroom in the South West corner of the main level of the residence
- Room "D" Bedroom in the South West corner of the basement
- Room "E" Bedroom in the South East corner of the basement
- Room "F" Exercise room located on the north side of the basement, adjacent to the family room

On the initial walk through, initial scene photographs were taken by CSI Crofts. Evidence that was found during the walk through was left in place, marked with numbered evidence markers, and photographed. The following was discovered on the initial walkthrough:

- Room "A": two deceased adult females, one deceased male juvenile
- Room "B": one deceased female juvenile
- Room "C": one deceased male juvenile
- Room "D": one deceased female juvenile
- Room "E": one deceased female juvenile
- Room "F": one deceased adult male

A second walk through was made with Detective Chappell from the Cedar City Police Department. Detective Chappell took 360 scene photos with the departments "OSCAR" camera. Evidence that was found during this walk through was left in place, marked with numbered evidence markers, and photographed.

After the 360 scene photos were complete Officer Mike Bleak (ECPD) and Detective Matt Topham (CCPD) were tasked with the OME duties. They went through the scene documenting the deceased and started the process of identifying them. During this process evidence discovered was marked with numbered evidence

markers, photographed, and collected.

After the OME tasks were complete, Affordable Mortuary and Southern Utah Mortuary took the bodies from the scene. Once the bodies had been removed from the scene, a final walkthrough of all the scenes was done to collect any remaining evidence that had been uncovered.

CELL PHONES RETRIEVED:

On January 13, 2023 all but one cell phone was picked up from the Utah Tech Digital Forensics Lab. The one cell phone still at the lab is currently connected to grey key to have its passcode bypassed and its content extracted. CONTENTS OF MICHAEL HAIGHT'S PHONE:

After an overall review of the contents in Michael's phone, I determined that Michael and Tausha had been struggling with their relationship for at least over 2 years, possibly longer. Divorce came up several times by Tausha in videos that had been recorded by Michael. It seems that whenever the couple started to struggle Michael would do things such as record videos of his interactions with Tausha and the kids, Tausha's interaction's with the kids, and take pictures of rooms and items throughout the home.

The last video recorded was Michael and Tausha having a conversation where Michael was trying to get Tausha to work things out and Tausha essentially told him no. That video took place around 9pm on January 3, 2023. The last known correspondence took place at 9:43pm on January 3, 2023 where Michael asks Tausha if they can talk about it and she does not respond.

All the videos from the days before this incident are Michael recording interactions with the family or his conversations with Tausha. All of his conversations with Tausha the day of the incident, Michael is essentially trying to get Tausha to work things out between them. Michael keeps saying "I feel like your backing me into a corner" several times throughout some of the conversations.

In Michael's search history days prior to the incident he had searched things related to gunshots, like whether you could hear gun shots in a garage, home, or if neighbors would hear gunshots from these places. He also searched things such has how loud is a 40mm and 9mm. This is all that was in the phone. Below are the searches of interest with how they were labelled/time-stamped via Cellebrite. No further action will be taken with Michael's phone unless needed.

This is nonsense and I can't handle it for one more day. We will not be a burden on society. I kept asking for help and you wouldn't listen."
