Facts & Circumstance that support probable cause to arrest the above named person are

On 05/25/2026 at around 2200 hours I was driving east bound on highway 51 near 250 road, I was advised by other officers and dispatch that there was a reckless driver also driving east bound on highway 51. The reporting person for this incident was an EMS driver who called 911 and advised that he believed the driver to be intoxicated and ran off the roadway multiple times.

I was then able to locate the 2025 Ford F-150 that is blue in color, the driver of the vehicle was failing to maintain its lane while I was behind his vehicle.

I then initiated a traffic stop at Highway 51 & 250 road, the driver of the vehicle came to a stop in the quick trip parking lot. I was then able to make contact with the driver of the vehicle later identified as Joel Wiedel.

Upon initial contact with Joel Wiedel I quickly noticed a strong odor consistent with an odor commonly associated with an alcoholic beverage coming from inside of the vehicle. I then asked Joel Wiedel if he had consumed any alcoholic beverages today to which he stated that he had consumed several alcoholic beverages. Joel Wiedel also had bloodshot watery eyes, and slurred speech.

I then asked Joel Wiedel to step out of his vehicle to conduct some field sobriety test, Once Joel Wiedel stepped out of the vehicle I noticed that he was very unsteady on his feet.

While conducting field sobriety test with Joel Wiedel the following clues were identified, HGN 6/6, WAT 6/8, and OLS 4/4.

Joel Wiedel was taken into custody for driving under the influence, I then read Joel Wiedel implied consent. Joel Wiedel agreed to take the stated breath test. I then checked Joel Wiedel's mouth and ensured that he did not have anything inside of his mouth for the deprivation period.

Joel Wiedel was then transported to the Wagoner Police Department where the states breath test was conducted. The result of Joel Wiedel's breath test was 0.21 BrAC g/210L making this an aggravated DUI.

Joel Wiedel was then booked into the Wagoner Police Department without incident.


I was able to obtain a triple I report on Joel Wiedel and it was identified that Joel Wiedel was arrested on 08/26/2025 in Okmulgee Oklahoma. The charges filed at that time were transporting open container, and Aggravated DUI. Case [REDACTED]

It should be noted that this arrest is the second DUI that Joel Wiedel was arrested for DUI within a 10 year time frame.
