<u>DEFENDANT'S UNOPPOSED SECOND LOCAL RULE 7.4.1 EX PARTE MOTION FOR EXTENSION OF TIME TO ANSWER OR OTHERWISE PLEAD</u>

Defendant, Don's Specialty Meats, Inc. ("Don's"), respectfully moves, ex parte pursuant to Local Civil Rule 7.4.1, for an extension of time of fourteen (14) days, until January 11, 2022, to answer, respond or otherwise plead in response to Plaintiff, Equal Employment Opportunity Commission ("Plaintiff") Complaint (R. Doc. 1). In support of this motion, Don's states as follows:

- 1. On October 8, 2021, Plaintiff delivered via certified mail a copy of the Complaint and a Waiver of the Service of Summons ("waiver of service").
- 2. On November 17, 2021, Don's executed, and delivered to Plaintiff, the waiver of service.
- 3. Pursuant to Rule 4(d)(3), by executing the waiver of service, Don's deadline to answer or otherwise plead in response to the Plaintiff's Complaint is December 7, 2021; which is less than twenty-one (21) days after Don's executed the waiver of service.

- 4. As a result, on December 3, 2021, Don's filed a Local Civil Rule 7.4.1 *Ex Parte*Motion for Extension for Extension of Time to Answer or Otherwise Plead (R. Doc. 4).
- 5. On December 6, 2021, this Court granted such foregoing motion to extend to December 28, 2021, Don's deadline to file responsive pleadings (R. Doc. 6).
- 6. The parties have been engaged in efforts to amicably resolve this matter, and the parties anticipate being able to finalize such resolution in two weeks' time.
- 7. This is Don's second request for an extension of time.
- 8. By correspondence sent on December 22, 2021, counsel for Plaintiff stated that he does not object to Don's request for an extension of 14 days.

WHEREFORE, Defendant Don's respectfully requests this Honorable Court enter an Order granting Defendant's Unopposed Second Local Civil Rule 7.4.1 *Ex Parte* Motion for Extension of Time to Answer or Otherwise Plead, thereby extending Don's responsive pleading deadline to January 11, 2022.
