AFFIDAVIT OF PROBABLE CAUSE

I, Detective Foster of the Nampa Police Department

declare and state that the following is true and accurate.

The following acts occurred at: 331 Lone Star Road, Nampa, Canyon County, State of Idaho

1. Synopsis of Case:

On 12/16/2025 at approximately 03:44 hours, I was contacted by Sergeant Williams and advised that there was an infant death located at 331 Lone Star Road, Nampa, Idaho. The infant was identified as B.L. [REDACTED]/25. Upon arrival on scene, I was briefed by Officer Renner about the incident. Officer Renner advised me the father of B.L. [REDACTED]/25 is Brian Lemke [REDACTED]/94 and the mother is Allysen Armenta (11/13/97). There were two additional individuals on scene as well, Angela Redman (04/10/83), who lives in the white trailer with a green stripe on it in the backyard, and David Hinkel [REDACTED]/73, who lives in the residence. David was interviewed and he is the owner of the residence. David said Brian and Allysen live in the larger silver colored Jayco trailer in the backyard. David said B.L. [REDACTED]/25 was taken to Brian and Allysen's trailer when he went to bed around 21:00 hours on 12/15/2025. David had woken up to the police at his residence.

Officer Renner was given consent to search the residence by Brian Lemke and David Hinkel. Brian stated he was sleeping in the living room with B.L. [REDACTED]/25 when he woke up to him not conscious. Brian called 911 and told dispatchers B.L. [REDACTED]/25 had died and they needed a coroner. Brian said B.L. [REDACTED]/25 is breastfed and they were keeping frozen breast milk in the freezer in the kitchen. Brian had advised patrol officers that Allysen was not on scene and that she had left days prior. Brian told me that he had been living in the trailer in the backyard, however, because it was too cold, him and B.L. [REDACTED]/25 moved inside. After telling Brian I needed to make sure there was no one else in the Jayco trailer, Brian gave me consent to go into the trailer and told me that there should not be anyone inside.

Brian told me that the trailer was unlocked. We knocked on the trailer, attempted to open the trailer door, and it was locked. An officer continued trying to make contact at the trailer and we did a security sweep of Angela's white and green trailer. Officers moved back to the Jayco trailer and continued knocking and making announcements to Allysen. Ultimately, Sgt. Williams observed Allysen hiding in the back of the trailer and gave her commands that she was under arrest and needed to come outside. After a few minutes Allysen Armenta eventually came out of the trailer, and she was arrested for her outstanding warrant for an Ada County Probation Violation. Allysen had a black Apple iPhone in her possession when she was arrested. I notified her that B.L. [REDACTED]/25 had passed away. Allysen advised me that she was inside the trailer the entire night, that she had gotten into an argument with Brian in reference to the propane heater in the trailer, and she needed a break from taking care of the baby. Allysen said she was unaware that B.L. [REDACTED]/25 was injured or had passed away. Allysen told me that there was a marijuana vape in the trailer.

When I arrived at 331 Lone Star Road and walked through the residence, it had the overwhelming odor of animal feces and urine. There were 8 puppies in the living room with feces on the ground next to B.L. [REDACTED]/25's bassinet. There were an additional 7 dogs in the backyard of the residence. I observed that B.L. [REDACTED]/25 was not conscious, not breathing, laying in the bassinet with blankets over him. B.L. [REDACTED]/25 was lying face up and his head and face were exposed. B.L. [REDACTED]/25's skin was dark purple color on his nose and

mouth. I observed that the house was in disarray. I observed that the bassinet was very close to the front walkway of the residence. I found the placement of the bassinet to be odd because with my experience most people do not place a bassinet and have a baby sleeping in front of the front door where it is the common path of entrance and exit of the residence. The space to walk by the bassinet was minimal and especially with a larger male like Brian Lemke who is 6'02 and weighs 290 pounds. I did not observe a milk bottle in plain view. I observed that there was a car seat near the bassinet and that there were diapers in a tote on the couch. I also observed that there were 2 two plastic breast milk containers that would have breast milk in them. I did not observe any breast milk, and if there was any, there was an extremely small amount inside the plastic milk pouch that was frozen. Detective Arment observed blood on B.L. [REDACTED]/25's nose and there was blood located on wipes in Brian and Allysen's trailer.

Brian Lemke consented to a search of his person and agreed to be transported to the Nampa Police Department to be interviewed. Angela Redman and David Hinkle drove themselves to the Nampa Police Department to be interviewed. Allysen was transported to the Nampa Police Department to be interviewed as well.

Detective Scott began speaking with Brian at the Nampa Police Department interview room and she advised him he was not under arrest and was free to leave at any time. Brian acknowledged his understanding of this. Brian began by explaining the events of the previous night. He stated that he fed (the baby) B.L. [REDACTED]/25 around midnight, though he was not certain of the exact time due to what he described as "baby brain, work, everything else." After feeding the baby, Brian stated he laid B.L. [REDACTED]/25 down in his bassinet and then laid down himself on the couch in the living room. Brian stated that B.L. [REDACTED]/25 appeared to be fine at that time, breathing normally. Brian said he wrapped B.L. [REDACTED]/25 up in a Paw Patrol blanket and laid him on his back, emphasizing, "I didn't have it covering his neck or face or anything like that." Brian stated he could not recall what time he called for help, but stated that just before calling, he had "rolled over and looked at him and he wasn't breathing. He was blue."

When asked about the sleeping arrangements, Brian confirmed that he was on the couch with B.L. [REDACTED]/25's bassinet nearby in the living room. He estimated that he put B.L. [REDACTED]/25 in the bassinet around midnight, noting it was, "a couple of hours after Dave went to bed." Brian identified B.L. [REDACTED]/25's mother as Allysen Armenta. He stated that Allysen had not been at the residence for "a couple of days" following an argument about previous children that were adopted. When asked if Allysen knew about B.L. [REDACTED]/25's death, Brian initially said "yeah" but then clarified, "I don't know if she does or not" and stated he had not had any contact with her since she left, and he did not know her current whereabouts.

Brian stated he and Allysen share three biological children together: A.L. [REDACTED]/20, L.L. [REDACTED]/23, and B.L. [REDACTED]/25. Allysen also has a child from a previous relationship, A.L. [REDACTED]/16. Brian stated that A.L. [REDACTED]/20 and L.L. [REDACTED]/23 were adopted a couple years ago due to "home conditions" at a previous residence in Boise. Regarding B.L. [REDACTED]/25's health, Brian described him as "perfectly healthy" and said he was gaining weight and eating well. B.L. [REDACTED]/25's birth weight was 8 pounds 5 ounces, and he was born at Saint Alphonsus in Nampa. Brian mentioned that B.L. [REDACTED]/25 had the cord wrapped around his throat and body at birth, requiring a C-section delivery.

Brian said he was "finishing up using the last bit of breast milk" and was planning to switch to formula in the next day or two. He estimated they had accumulated about 30-40 ounces of breast milk but was down to the last couple of ounces with a couple more ounces still in the freezer. Brian confirmed that he was the only person who had contact with B.L. [REDACTED]/25 throughout the night. Brian stated they had been living at their current residence off Lone Star for six months. Brian disclosed that Health and Welfare was going to be involved with B.L. [REDACTED]/25 due to his "previous dealings with health and welfare." Brian stated that a CPS employee named Mariana had called him the previous day making sure that B.L. [REDACTED]/25 is okay, and that the house is in good living condition. Brian stated they spoke for 15-20 minutes, and he was supposed to call Mariana back but forgot because he got busy at work. Brian stated Mariana had asked to see B.L. [REDACTED]/25 and was going to set up a time for a visit. Brian stated he was planning to call her back that morning.

After, Detective Scott interviewed Allysen Armenta, who had in fact been located in the Jayco trailer by myself and other patrol officers. Before proceeding with questions about Benjamin, Officer Scott advised Allysen of her Miranda rights, which she advised she understood and agreed to speak. Allysen stated that she had been sleeping in a trailer on the property because the couch in the house was uncomfortable after extended use. She stated she also wanted a break because she had been with B.L. [REDACTED]/25 all day, and when Brian comes home, he only talks about his work at a tow truck company. Allysen stated she wanted to take her anxiety medication (Hydroxyzine) and get proper sleep. She said she was awakened by lights flashing and banging on the door, which she initially thought might be one of Dave's dogs jumping on the door.

Detective Scott asked Allysen about her medications. She stated she takes Hydroxyzine (prescription says 25mg but she's been getting 50mg for the past month), ibuprofen, and an unnamed pain medication for her C-section. Allysen confirmed taking one 50mg tablet of Hydroxyzine and some ibuprofen around 9:00 PM the night before. She denied using alcohol, marijuana, or other substances. Allysen stated she and B.L. [REDACTED]/25 had been staying in the house with Dave, as they were out of propane for the trailer. Allysen again explained that she was feeling anxious and wanted to get her sleep, so she told Brian he was on "dad duty" and there was milk in the freezer. Allysen said she went to the trailer where she took her anxiety meds and went to sleep. A short time later she was woken up by officers. Detective Scott asked Allysen how her anxiety medication's make her feel, and she stated they make her feel relaxed and less jittery, and that they had made her sleepy tonight since she hadn't taken them for a little while.

When asked what she thought happened to B.L. [REDACTED]/25, Allysen stated, "I don't know. All I got told was he wasn't here. I don't know

where he was." Allysen stated she didn't know if B.L. [REDACTED] (25) was in the bassinet or if one of the huskies had gotten into the bassinet with him. Allysen stated she has had to previously get after two of the 2 huskies for trying to climb in the bassinet with him and lay with B.L. [REDACTED] (25). Detective Scott asked Allysen where B.L. [REDACTED] (25) was when she left him to go out into the trailer and she stated he had been in the bassinet sleeping. Allysen described their typical bedtime routine for B.L. [REDACTED] (25), explaining they would put him in either a pre-made swaddle (zip-up or Velcro) or wrap him in a Paw Patrol blanket, keeping his arms outside the swaddle when using the blanket. Allysen confirmed that Brian uses the same swaddling method. She stated as she left to the trailer, Brian was setting up his area to go to bed. Allysen stated Dave was going to bed as well and Angie had gone out to her trailer.

Regarding the living arrangements, Allysen stated they had been living at the current location since June. They initially lived in the trailer but moved into the house after B.L. [REDACTED] (25) was born because Dave (homeowner) offered them the couch, preferring they stay in the house with the B.L. [REDACTED] (25). Allysen stated she and Brian would sleep on the couch while B.L. [REDACTED] (25) slept in a bassinet. She described Brian as being good with B.L. [REDACTED] (25), with no issues or concerns. She mentioned having breast milk stored in the trailer (3-4 bags) and in the freezer in the house (approximately 8 bags). When asked if she told Brian she was going to the trailer, Allysen stated that around 8:15-8:30 PM, she told him she was going to a friend's house and was going to pack a bag, but then decided to "pass out on my bed and go to sleep for a little bit" in the trailer instead.

Detective Scott confirmed with Allysen that B.L. [REDACTED] (25) was overall a healthy baby and had no major medical issues. Allysen stated B.L. [REDACTED] (25) was overall healthy and the only minor concerns were a little bit of high blood sugar at birth and mild congestion due to B.L. [REDACTED] (25) swallowing amniotic fluid during delivery. Allysen denied fighting or arguing with Brian recently, but then stated they did have a disagreement over Brian making a Facebook post asking for propane for the trailer.

Detective Scott re-entered the interview room with Detective Corporal Stark and informed Brian that she had talked to everyone in the house, and knew he was not being honest. Brian began to nod as Detective Scott spoke to him. Brian said he thought Allysen rolled over on B.L. [REDACTED] (25). He said they went to bed around midnight together and he confirmed he knew about Allysen's warrant for her arrest. Brian explained Allysen, B.L. [REDACTED] (25), and himself went to bed on the main bed in the Jayco trailer. He advised Allysen and B.L. [REDACTED] (25) went to bed first, and he went after. He explained when he went into the camper they were both sleeping on the bed and it appeared Allysen fell asleep feeding him, as he had her breast in his mouth. Brian said the baby was not deceased at this time, and Allysen was sleeping on her side, the baby was on his back. He reported moving the baby so the baby was in the middle of the bed. Detective Scott asked about their typical sleeping arrangements and Brian explained they would sleep in the house or in the trailer. Detective Scott asked why they slept in the trailer last night and he said he didn't know. He explained he was trying to get it cleaned up.

Detective Scott asked what happened after he moved the baby and he said he fell asleep. Brian stated Allysen woke up screaming (he did not recall what time it was), and that is when he called police. Brian ultimately admitted to knowing B.L. [REDACTED] (25) was deceased, moving B.L. [REDACTED] (25)'s deceased body inside the residence and placing him in the bassinet near the front door. Brian said he called the police after he had moved B.L. [REDACTED] (25) inside the house. Detective Scott asked about the conversation between he and Allysen when they woke up and found B.L. [REDACTED] (25). Brian stated Allysen said she couldn't be there, because of her warrant. Brian said he was out of it from sleep. Brian said when he woke up, he saw B.L. [REDACTED] (25) in Allysen's arms and she was yelling and screaming and B.L. [REDACTED] (25) was already blue. He advised he did not remember after that. He denied trying CPR due to feeling B.L. [REDACTED] (25) and he was already cold so there was no point.

Brian didn't think Allysen did anything to B.L. [REDACTED] (25) and described her as a great mom. Detective Scott asked whose idea it was for him to go inside and Allysen to stay in the trailer. Brian said, "that's what Allysen told me to do". Detective Scott asked if Allysen told him what she was going to do, and Brian said no. Brian stated he was on the couch inside the house when he called 911. He thought it was approximately 5 minutes between waking up and calling 911. He denied calling anyone prior to 911. He stated Allysen called his phone when the first officer showed up. He pressed answer without knowing it but did not talk. Brian knew she was in the trailer at that point, and thought she did not come out because she was scared of her warrant. Detective Corporal Stark asked if they had conversations prior about her being scared of her warrant, and Brian indicated they had. Detective Scott confirmed he initially didn't want law enforcement to go in the trailer because Allysen was in there, and he advised that was correct.

Brian said he was trying to clean out the trailer but was also talking with Dave about moving in the house. Brian talked about the propane running out in the night when it is cold. He denied it being cold in the trailer last night and stated it was 75 degrees. Brian also thought B.L. [REDACTED] (25) was eating enough and getting 2-3oz every couple of hours. Brian said the carbon monoxide monitors in the trailer were working.

Detective Scott informed Allysen that she spoke to Brian who told the truth of what happened. Allysen stated that she, Brian and B.L. [REDACTED] (25) went out to the trailer around 9:30 PM. She fed B.L. [REDACTED] (25) and they all laid down. B.L. [REDACTED] (25) woke up at 11:00 PM and she fed him again. Allysen stated that they all woke up at around 2:00 AM and B.L. [REDACTED] (25) ate again. She stated that Brian woke up at 4:00 AM and saw "that he was gone." When Detective Scott asked how Brian woke up, Allysen said he "rolled over and he was gone." Detective Scott clarified that Brian was the first to find B.L. [REDACTED] (25) unresponsive and Allysen stated that was correct, as she was still asleep. Detective Scott confronted Allysen with the fact that Brian had told her that he woke up to her screaming, to which she responded, "I don't know." Allysen stated she couldn't remember if Brian had been the first one to notice B.L. [REDACTED] (25) was unresponsive as she was still half asleep. She stated she did remember Brian yelling and running out the trailer door.

When asked what happened after they discovered B.L. [REDACTED] (25) was deceased, she said Brian "maybe" tried to do CPR, and she told him to call 911, which he did. She stated that Brian ran inside the house screaming for help with the baby. When asked what she decided to do, she said she tried to get close and try to come into the residence, but she was told not to come in by Angie. Allysen claimed Angie told her to stay in the trailer because "she didn't want me to see him." After Detective Scott confronted Allysen, she admitted she was told not to come into the residence because of seeing B.L. [REDACTED] (25) and because they were trying to figure out if her warrant was active still. Detective Scott confirmed she didn't come into the residence and hid in the trailer because of her warrant. Allysen insisted she didn't want to be in the trailer and wanted to be in the residence with B.L. [REDACTED] (25).

Allysen acknowledged that when she woke up, she saw B.L. [REDACTED] (25)'s face was blue. When Detective Scott asked why Brian took the baby into the house rather than calling 911 from the trailer, Allysen claimed, "I think he went in to get Dave to help because Dave has first aid certifications. He used to be a first aid responder." Detective Scott informed her that Brian had said she told him to go to the house with the baby and that they had decided she would hide because of her warrant. Allysen denied this, stating she was going to come into the residence but was told not to because they didn't want her seeing B.L. [REDACTED] (25) and they didn't want her to go to jail the night her son died. Allysen claimed that "Angie" told her "Don't come out, stay hidden" via text message on her phone. Allysen did not give consent to search her black Apple iPhone that was collected when she was arrested on her warrant.

When asked if the trailer was safe for B.L. [REDACTED] (25) to sleep in, Allysen admitted, "It wasn't last night." Allysen explained the trailer was cluttered and she hadn't finished cleaning up everything from when B.L. [REDACTED] (25) was born. She mentioned being very tired and wanting to sleep in a bed last night. Detective Scott asked Allysen if she thought the medication she was taking (hydroxyzine) had anything to do with what happened. She stated, they had given her the medication in the hospital and had been on it during her entire pregnancy.

Detective Scott asked Allysen about some blood found on wipes in the trailer and she explained it was her blood from her period/blood clots. She stated she had tried to sleep without an adult diaper and woke up with blood. When asked what she was doing during the approximately hour-long period while police were in the house before coming to the trailer, she said she was cleaning blood off herself, including a large clot that had dried on her body. Detective Scott clarified with Allysen that she heard officers in the house and was aware of our presence, mentioning the dogs barking. Allysen argued she has hearing impairment (30% hearing in one ear and 25% in the other) and relies partly on reading lips. Allysen denied cleaning or altering anything in the trailer other than cleaning blood from her own body, acknowledging the trailer was a crime scene.

When asked about a Paw Patrol blanket, Allysen stated it was "above our heads" and she used it as a prop for her. Allysen confirmed B.L. [REDACTED] (25) was not wrapped in anything when he was sleeping in the bed with Brian and Allysen in the trailer. It should be noted that when I arrived on scene at the residence the weather was approximately 30 degrees outside and below freezing temperature.

Detective Corporal Stark was tasked with interviewing David Hinkle and Angela Redman. Cpl. Stark first interviewed Angela Redman. Redman advised she has been living at the Lone Star address with her brother-in-law and sister for approximately 2.5 to 3 years. When asked about the current household residents, she stated that prior to her sister's recent incarceration, the household consisted of herself, her brother David Hinkle, her sister Laura (currently incarcerated), Brian, and Allysen. When asked about the living situation at the residence, Redman advised that after B.L. [REDACTED] (25) was born, Brian and Allysen had been crashing on the couch, B.L. [REDACTED] (25)'s bassinet located in the living room directly next to the couch. She confirmed that both Brian and Allysen both slept on the couch together.

Redman stated that Brian called her around 3:30am after he had already called 911. According to Redman, Brian told her that he woke up and the baby was blue and that he had already called 911. Cpl. Stark asked Redman to describe what she observed upon entering the house. Redman said, "I saw him on the couch. I said, What's going on? And he said, the baby's gone. And I went, What? And he said the baby's gone and I walked over and I, I reached for the baby and he said they told me not to touch him, to just leave him alone. I said, Well, did they say do CPR or anything? No, they said just leave him alone and they'd deal with it when they got here." When asked about Allysen's whereabouts at that time, Redman said she did not know where she was.

Next, Cpl. Stark interviewed David Hinkle. Regarding the living arrangements, Hinkle described the property as "kind of a communal house" with separate sleeping areas. He explained that Angela slept in the green trailer on the property, and Brian and Allysen slept in the big trailer. Hinkle confirmed that he was the only person who slept in the main house, along with his dogs. Hinkle said he last saw Allysen last night when they were visiting and were in the main house. Hinkle said they were all hanging out till about 9:30pm and then he kicked them out because he needed to go to bed. Hinkle reported being awakened at approximately 3:30am by his dogs "losing their shit" because Angela and Brian came barging into the house. Hinkle stated, "Angela pulled me off to the side and said That they lost B.L. [REDACTED] (25) and it's just been a whirlwind since then." The police and fire arrived shortly after.

I wrote a search warrant for 331 Lone Star Road, Nampa, Idaho and for the silver Jayco trailer in the backyard that was occupied by Brian and Allysen. I was granted a Canyon County Magistrate Court search warrant 2025-669A to collect evidence in the residence and evidence in the trailer.

Nampa Police Evidence Unit took overall photographs of the residence and the trailer and searched both. I reviewed the photographs and

observed in the house freezer there were two plastic breast milk bags. Both frozen breast milk bags had a small amount of breast milk inside, I am unable to determine specific amount because the milk was frozen. Next, I reviewed the photographs from the Jayco trailer. Inside the trailer it was full of trash, food, clothing, animal feces, and other miscellaneous items all over the trailer. It would be extremely difficult to walk through the trailer due to the poor conditions and excessive trash build up. The bassinet inside the trailer was propped up laying on top of a suitcase, a laundry basket, and cardboard boxes. The bathroom toilet was discolored, there was trash on the bathroom floor, dirt, cigarettes, cigarette packs, cigarette ash build up, a plastic container, and other miscellaneous trash/debris in the bathtub. Next to the refrigerator there is a cat litter box with animal feces inside and on the ground around it. The bathroom was indicative that B.L. [REDACTED] (25) was not being bathed or cleaned due to the conditions inside the trailer. B.L. [REDACTED] (25) had to sleep between his two parents that are both obese which would not give him enough reasonable space to sleep without being suffocated or having his breathing restricted on a small trailer mattress. Allysen Armenta's Idaho DMV return showed her being 5'03 and 230 pounds, and Brian's Idaho DMV return showed him being 6'02 and 290 pounds. There were cats that lived in the trailer as well. Brian had made a Facebook post requesting people to help him get more propane so he could heat his trailer for their new baby. The trailer was not a safe environment for B.L. [REDACTED] (25) to be living in due to the filthy living conditions that Brian and Allysen placed him in.

On 12/17/2025 Detective Corporal Ferrari attended the autopsy of B.L. [REDACTED] (25). Dr. Kronz concluded that there were no external injuries, normal skull, and brain with no injuries. Dr. Kronz stated that the likely cause of death was suffocation. The official autopsy report with the toxicology report is still pending.

Next, I reviewed the cell phones that were collected and extracted on consent.

First, I began reviewing Brian Lemke's Samsung cell phone is Cellebrite Guardian. I first reviewed the message history in Brian's cell phone. I located a message conversation between Brian and Allysen Armenta [REDACTED] (6701). It should be noted this is not the complete message history, merely a highlight of the important messages related to this case.

On 12/14/2025 at 17:17:36 PM Brian says, "Deleted Facebook."

Allysen says, "I'm gonna delete mine. We can run. Pack a bag for me and the baby and you and just run. My warrant is in limbo. Did you call bill. I'll come out and help in a minute let me change laundry."

Brian says, "Wait till it gets warm out here staying there for right now."

Allysen says, "I can't keep walking back and fourth I'm shaking and scared. I'll kill myself before losing another baby."

Later in the conversation at 18:38:01 Allysen says, "We're gonna lose everything."

Brian says, "Stop it we're fine."

Allysen says, "They're gonna keep harassing us until we leave." Allysen is talking about Child Protective Services who was trying to contact them to check on B.L. [REDACTED] (25) and the living conditions due to prior orders of removal for their other children for unsafe living conditions.

Brian says, "They can't keep harassing us if we don't give him a reason to show them a clean house show them food show them water everything we will be fine."

Allysen says, "What about hot water. What about dumping the tanks and all that."

Brian says, "They don't need to see hot water cold water as long as they see water and right now as it sits I just fixed the water tank hopefully I'm going to go dump the tanks here in a minute."

Allysen says, "How much is left in the house? We gotta bring this bed out. Unless we do what Dave says."

Brian says, "Which is what."

Allysen says, "Say we're staying in the house on the couch. Because he's never here."

Brian says, "Okay."

Allysen says, "Foods done. You come and explain what they said I don't know what to say I'm fucking scared and panicking. Foods done. But I can't be here. So we're gonna have to hide me. And then bring in breast milk."

Later in the conversation on 12/14/2025 into the morning of 12/15/2025 Allysen says, "I knew we should've left Idaho. I can't lose him so what do you want help with. We don't have a lot of time before you leave. That's if she calls or shows up. If she shows up I'm Acting like no one home. And hiding."

Brian says, " I know baby."

Allysen says, "I'll die before I lose another to Idaho. I mentally can't do it again. I'm tempted to call around to attorneys and find one to sue cps."

Brian says, "Yeah but I don't think an attorney would say we have a case because we've already lost to CPS twice."

On 12/15/2025 at 08:19:37 AM Allysen says, "Tell me and promise me we won't lose him. Promise me on grandpas Allen and Jim."

Brian says, "I promise."

Allysen says, "Swear. I will die. Dogs just went off to a car parked outside and they're just sitting. Thanks."

Brian says, "Wtf."

Allysen says, "SUV beige. And everything I took making me see double I landed on the corner of the table on the one side. And it's worse."

Brian says, "Like how."

Allysen says, "Huh. Cops are driving like around like crazy. Whatever I'll figure it out by myself."

Brian says, "I'm at work just a second babe."

Allysen says, "Yea and it's about your fucking kid being safe. I see where he lies. I'm gonna go back to camper and get it fucking done myself. Forgot everyone at asap is priority over our family."

Brian says, "Ill just quit and we will lose everything in a week."

Allysen says, "No that's how you fucking make me feel. Is everyone there is more important. Ok. Thanks for calling me fucking back. Now I'm pissing out my ass and pissing bloody. And everything hurts. I can't. Ok then."

On 12/15/2025 at 12:04:11 PM Brian says, "On with her just a sec." Brian means he is on the phone with the CPS worker.

Allysen says, "What is she saying. And who called and what's going on. How long do we have to get shit done and everything else. I don't want to lose him and I don't trust them. And I can't be here baby. Don't give her the address. Is she being nice? Or being a cunt. I hope she's a good one and keeps her word. I'm still scared."

Brian says, "Me too."

Allysen says, "You better fight to keep him here. "

Brian says, "I will."

Allysen says, "Not like last time."

Later in the conversation on 12/15/2025 at 05:55:09 PM Allysen says, "He's clingy and everything. The way that social worker made me feel because of him coming up not breathing pretty much was my fault."

The next morning on 12/16/2025 at 03:31:55 AM Allysen says, "I can't be in there my warrant baby. I'm a piece of shit. I'm a piece of shit. What did I do. What the fuck did I do. I'm sorry. I don't know what I did. I don't know what the fuck. My baby. I don't know what happened but it must be my fault. Are they saying Sid's. Is Dave gonna tell them I'm here. I'm sorry. What's going on. I just want my baby. I want B.L. [REDACTED] (25) "Allysen said infant's name". I need to feed him I need him. I need to feed him. Bring him here. Please bring me my baby. Bring me my baby!!!! He needs to eat."

Allysen was texting Brian from 03:31 AM until 04:35 AM and was aware that 1st responders were on scene but would not go inside because she had a warrant.

Next, I found a message conversation between Brian and Marianela Turner [REDACTED] (818).

On 12/15/2025 at 12:09:02PM Marianela Turner says, "It's was good speaking with you. This is Marianela Turner with CPS. We'll connect later today. Thank you again for taking my call."

Next, I reviewed Brian's call history.

Outgoing call to 911 on 12/16/2025 at 03:31:42 AM for a duration of 2 minutes and 42 seconds.

Incoming call from Allysen Armenta (██████████-6701) for a duration of 1 hour, 35 minutes, and 23 seconds. This means Brian was on the phone with Allysen when police were on scene at the residence.

Next, I reviewed over Angela Redman's cell phone extraction in Cellebrite Guardian.

I located Facebook messenger conversation between Allyzen Armenta-lemke and Angela.

On 12/14/2025 at 21:05:21 PM Allysen says, "I mean if they knock we just don't answer the door and act like no one home tomorrow. Since I'm in limbo rn."

Angela says, "O.. K.. I get u."

Allysen says, "And they try stupid shit but technically we don't have to open the door until they call Brian and schedule a time."

Next, I reviewed Angela's call history.

On 12/16/2025 at 03:34:01 AM incoming call from Allysen Armenta for a duration of 55 seconds.

On 12/16/2025 at 03:37:35 AM incoming call from Allysen Armenta for a duration of 2 minutes and 4 seconds.

Next, I reviewed Dave Hinkle's cell phone extraction in Cellebrite Guardian. I did not locate any evidence related to this case in Dave's phone.

Detective Maddox reviewed Laura Hinkle's Idaho Department of Corrections call on 12/15/2025 at 09:21:14 hours. The call was between Laura Hinkle and David Hinkle. Laura and David discussed how Brian posted on Facebook that he was running low on propane, just had a baby and was asking for someone to help him get more. A female agreed to help Brian and they agreed to meet on 12/14/2025 at 16:00. Brian was contacted by police and drove away when he was being questioned by police about a welfare check on the baby. David said Brian and Allysen both deleted Facebook after. David and Laura discuss Allysen and Brian losing their other kids. Next, they discussed Allysen sleeping till 13:00 and wondering where the cats and dogs are going to the bathroom, and how often they are cleaning the trailer with a baby living inside. They also talk about the weather being cold outside. Both Laura and David talked about the concerns they have for B.L. (██████████/25)'s living conditions. The contact with law enforcement that David is describing is the contact that Cpl. Benson had with him on 12/14 (N25-76008).

Detective Maddox located the Facebook post by an anonymous person asking for propane on the Facebook group, "Idaho Mutual Aid." The post reads: "I hate to come here and ask but I am living in my camp trailer in Nampa I just had a baby and I have run out of propane and it is how I heat and cook and shower I have a big propane tank and it cost right at 100 bucks to fill im in between paychecks right now can anyone help."

Next, I reviewed prior law enforcement contacts with Allysen and Brian. I reviewed an Ada County Sheriff's Office report #2019-1091 and the summary was:

An Ada County deputy responded to 7309 W Snohomish St, Boise, ID to assist DHW on a welfare check of children at the residence. After entering the residence the observed three children under the age of three with dangerous living conditions, including trash all over the floor, moldy food throughout the residence, knives found all over the residence and nearby children. The children appeared to not have taken a shower for some time. One of the children had a sore on his mouth and another child had a bruise on her head. Based on the circumstances, the children were declared in imminent danger and taken into custody by DHW.

The suspects were listed as Brian Lemke (██████████/94) and Allysen Armenta (11/13/97).

The victims were listed as E.L. (██████████/17); R.L. (██████████/16); and A.L. (██████████/16).

On 12/22/2025 I reviewed my emails from Child Protective Services in reference to the documented history with Allysen and Brian and their children. The following is a synopsis of the history with CPS:

2019 - Mom SUBSTANTIATED - A.L. (██████████/16) came into foster care due to unsafe living conditions.

2019 - Dad SUBSTANTIATED to "knowingly and willingly allowed his children to live in a hazardous home environment which led to them entering foster care." Rights were terminated and the children, E.L. (██████████/17); R.L. (██████████/16), were adopted out.

██████ 2022- Priory 1- : A.L. ██████/16), A.L. ██████/20), and L.L. ██████/23) Children being declared for concerns regarding the living conditions. Allysen Armenta and Brian Lemke were SUBSTANTIATED for level 3 neglect. A.L. ██████/16), A.L. ██████/20), and L.L. ██████/23) were adopted out of foster care.

Next, I reviewed Allysen and Brian's criminal histories and they showed the following:


