The information you requested contains information that relates to: The records of a child who is alleged to have engaged in delinquent conduct or conduct indicating a need for supervision.

This information is confidential under section 552.101 of the Texas Government Code in conjunction with Section 58.008(b) of the Family Code. Our office is prohibited by law from releasing this information to you, and therefore we are withholding the confidential records.

The Attorney General has granted the City of Corpus Christi a previous determination (OR2023-36700) allowing the Department to withhold certain information under section 552.101 of the Government Code in conjunction with section 58.008(b) of the Family Code without the necessity of first requesting an Attorney General decision. Section 58.008(b) applies to entire law enforcement records; therefore, a law enforcement entity is generally prohibited from releasing even basic information from an investigation file when section 58.008(b) applies. When applicable, we will process the rest of your request for information in accordance with the terms of the Public Information Act.
