Myself and Lieutenant Vance activated our emergency lights and affected a stop in the parking lot of the Library. This Deputy removed Joshua Lashbrook from the vehicle and Lieutenant Vance placed in handcuffs and searched. He was cuffed from the rear and transported to the County Line and turned over to Prince George County PD.

This Deputy then spoke with driver and registered Owner of the Grey Honda Dale Lashbrook the suspects father. This Deputy then asked Mr. Lashbrook where he was going he said Matthews County he then corrected himself and said Prince George County so his son could turn himself in. I then asked how long he had been at the house and he stated for a few hours, I asked so you were there when we were at the house knocking and yelling Sheriff's Office? And he stated he heard us but didn't know who we were.

I then asked him so you didn't hear me knocking and yelling Sheriff's Office at the top of my lungs and he said yes I did. I then asked him why he cut through the parking lot and he stated that his son told him to do because he thought we wouldn't recognize he fathers vehicle. I asked him again stated we were going to turn him into Matthews County and then corrected himself and said I meant Prince George County. He advised that he still had a large amount of his son's insulin in the car and stated he was going back to the house to put it back in the fridge and I advised him not to touch anything else in the house.
