Probable Cause Summary

Statement of Facts:

On June 10<sup>th</sup>, 2020 Portsmouth NAACP leaders James BOYD and Louie GIBBS were arrested for trespassing on the Confederate Monument [the monument] located at 400 Court St in the City of Portsmouth, VA. Following their arrest and subsequent release BOYD and GIBBS returned to the monument where they met with Portsmouth School Board member Lakeesha ATKINSON, Lakesha HICKS (Aka Onyx Kearney), Dana WORTHINGTON, Kimberly WIMBISH, Amira BETHEA, and others yet to be identified.

Senator L. Louise LUCAS arrived a short time later and met briefly with the group at the corner of Court St and High St.

Senator LUCAS then approached a group of police officers and told them she just talked to the Mayor and City Manager and said "they are going to put some paint on this thing, and y'all can't arrest them" while gesturing towards the monument. LUCAS continued by saying "they gonna do it, and you can't stop them... they got a right, go ahead!". PPD Sergeant Johnson informed Senator LUCAS that she could not tell people they can do that. LUCAS replied, "I'm not telling them to do anything, I'm telling you, you can't arrest them".

ATKINSON, who was carrying a backpack full of spray paint cans, BOYD, GIBBS, HICKS (holding, and shaking a can of spray paint), WORTHINGTON (holding and shaking a can of spray paint), WIMBISH (holding and shaking a can if spray paint), BETHEA (holding and shaking a can of spray paint), and others gathered in a small group. GIBBS told the group to "just take the cans out and shake them, that's intimidating them". BETHEA asked WIMBISH "is it a go?" because she (WIMBISH) was the one "that's been communicating with her" [meaning LUCAS] and WIMBISH said, "she said yes". BETHEA said "she's waiting for someone to come down here, that's why I'm asking".

WIMBISH was told by Senator LUCAS to "wait five minutes" for Lisa (Vice Mayor LUCAS-BURKE) and Shannon (Councilman GLOVER) and WIMBISH held up her hand with 5 fingers up to the group. LUCAS walked over and said of the delay "because Lisa and Shannon are on City Council and they both know that this is city property just like I do". Members of this group were also "livestreaming" on social media telling others "get down here, it's about to go down".

Once other elected officials arrived Vice Mayor LUCAS-BURKE addressed the group and tried to explain the process the City Council was taking to have the monument legally and safely removed after July 1<sup>st</sup> when the state law was slated to change to make it legal to do so. Vice Mayor LUCAS-BURKE also explained that the monument was city property.

Senator LUCAS then proceeded to announce loudly "The city has had 3 years to cover it" and gesturing to the group gathered yelled "let them cover it!". The group gathered with her were shaking up cans of spray paint and shouting "cover it!". Someone in the group yelled "y'all

8/17/20 Mandy Wens 10:15am Maaistrate heard her! go, cover it!" at which time people began climbing the protective fence (which was posted with a no trespassing sign), and began spray painting the monument.

While the monument was being painted by a number of people Senator LUCAS asked BOYD if they had enough "cover" and he said they were going to buy some more and "we are going to put Black Lives Matter probably around the front of it". Senator LUCAS told him "I just wanted to come down here and make sure nobody else got arrested". BOYD told her "you know jail ain't nothing but a thing" and Senator LUCAS replied "ain't nothing but another thing to put on a piece of paper."

No state or local elected official, or any other person or entity had any legal authority to direct or allow any citizen to go upon, damage, or deface the monument and neither the City Manager or Mayor told Senator LUCAS anyone had permission to paint, damage, or otherwise alter the monument which is subject to Virginia Codes 18.2-137 and 15.2-1812.

HICKS, WIMBISH, WORTHINGTON, and BETHEA, along with others who have not yet been identified all climbed over the fence around the monument and spray painted it in several places causing extensive damage.

They were joined by Portsmouth Public Defenders Office Attorney Brenda SPRY, Attorney Alexandra STEPHENS, and Attorney Meredith CRAMER who also painted the monument in multiple places also causing extensive damage.

Over the next several hours dozens more people arrived and spray painted the monument. They also dumped buckets of paint on it and defaced the bronze statues with hammers and other objects. They eventually broke pieces of the statues off and ultimately pulled one of them down which struck a man and caused a life-threatening injury.

The following individuals have so far been identified as some of those who caused extensive damage:

Hanah RIVERA, who used tools to hammer on the monument and was involved in toppling one of the statues which landed on the victim.

Raymond BROTHERS, who was involved in painting the monument and assisted others climbing on the monument and handed them tools to cause damage and also removed a stone and metal marker which was smashed on the street.

Brendan WOODARD, who painted the monument and statues.

The monument was built in 1876 and is constructed of granite and four bronze statues. The amount of damage caused to the monument is estimated to be well over \$100,000. The statues themselves were damaged extensively, possibly beyond repair and there were gallons of paint covering the bronze statues and granite structure.

In 2005 the monument was vandalized with spray paint limited to the faces of the four bronze statues. Clean up cost for that incident, which is insignificant in comparison to the damage done
