3 AN ORDINANCE ADDING TO LVMC CHAPTER 13.04 A NEW SECTION TO AUTHORIZE THE
4 DEPARTMENT OF OPERATIONS TO DETERMINE AND DESIGNATE HOURS OF CLEANING FOR
PUBLIC SIDEWALKS, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Adds to LVMC Chapter 13.04 a new
6 section to authorize the Department of Operations
and Maintenance to determine and designate hours
7 of cleaning for public sidewalks.

8 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS

9 FOLLOWS:

10 SECTION 1: Title 13, Chapter 4, of the Municipal Code of the City of Las Vegas, Nevada,
11 1983 Edition, is hereby amended by adding thereto a new section, designated as Section 90, reading as
12 follows:

13 **13.04.090:** The Director of the Department of Operations and Maintenance is authorized to determine
14 and to designate hours of cleaning for public sidewalks. The Director, or a designee, must place appropriate
15 signs or markings to give notice of designated hours of cleaning. During such designated and noticed hours
16 of cleaning, no person shall sit, lie, sleep, camp, or otherwise obstruct the cleaning of the designated public
17 sidewalks by the Department of Operations and Maintenance.

18 SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase
19 in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by
20 any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the
21 remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby
22 declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase
23 thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,
24 sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

25 SECTION 3: Whenever in this ordinance any act is prohibited or is made or declared to
26 be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is required

1 or the failure to do any act is made or declared to be unlawful or an offense or a misdemeanor, the doing of
2 such prohibited act or the failure to do any such required act shall constitute a misdemeanor and upon
3 conviction thereof, shall be punished by a fine of not more than \$1,000.00 or by imprisonment for a term of
4 not more than six months, or by any combination of such fine and imprisonment. Any day of any violation
5 of this ordinance shall constitute a separate offense.

6 SECTION 4: All ordinances or parts of ordinances or sections, subsections,
7 phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
8 1983 Edition, in conflict herewith are hereby repealed.
