INFORMATION

12 In the District Court of the Twentieth Judicial District of the State of Montana, the Defendant is  
13 charged by Plaintiff with committing the offenses of:

14 COUNT 1: Deliberate Homicide, a Felony, under MCA 45-5-102(1)(a), with a maximum  
15 punishment provided by law of death, or life imprisonment, or by imprisonment in the state prison for  
16 a term of not less than 10 years or more than 100 years.

17 COUNT 2: Criminal Endangerment, a Felony, under MCA 45-5-207(1), with a maximum  
18 penalty provided by law of imprisonment in the state prison for 10 years and a \$50,000 fine.

19 The facts constituting the offenses are:

20 COUNT 1: On or about May 10, 2022, in Lake County, Montana, the Defendant, TYLER  
UHRICH, purposely or knowingly caused the death of R.B. by shooting her in the head.

COUNT 2: On or about May 10, 2022, in Lake County, Montana, the Defendant, TYLER  
UHRICH, knowingly engaged in conduct that creates a substantial risk of death or serious bodily

1 injury to another when he abandoned a 2 year old child in a car with the windows open on a cold night  
2 in a wooded area of the Mission Mountains.
