That I learned the following facts and circumstances which lead me to believe that the above named subject committed or was committing the offenses above at the location of [REDACTED] LAS VEGAS NEVADA 89143 and that the offense(s) occurred at approximately 08:04 hours on the 22th day of April, 2019.

On 04/22/2019, at approximately 0804 hours, LVMPD call takers were advised there had been a shooting at [REDACTED] Las Vegas NV 89143. Upon arrival, officers observed an adult male who had suffered several gunshot wounds. Medical personnel arrived and pronounced the male, later identified as [REDACTED] as deceased. At the time of incident, an occupant of the residence, later identified as Pamela Bordeaux, exited the residence and indicated to officers she had shot the deceased. Bordeaux was subsequently taken into custody.

Officers made contact with [REDACTED] DOB [REDACTED], the daughter of Bordeaux, who stated she drove to her mother's residence located at [REDACTED] on 04/22/2019. In accordance to a child custody agreement, [REDACTED] takes her 3 year old child to the house for a supervised, child visitation with the father of the child, [REDACTED] one day a week.

Wherefore, Declarant prays that a finding be made by a magistrate that probable cause exists to hold said person for preliminary hearing (if charges are a felony or gross misdemeanor) or for trial (if charges are misdemeanor).

Bordeaux supervised the visits with [REDACTED] and [REDACTED] both present. The visitation was for one hour, from 0700 hours to 0800 hours, and after the allotted time, [REDACTED] took the 3 year old child upstairs, leaving her mother, Bordeaux, downstairs with [REDACTED]. Within seconds, [REDACTED] heard shots from downstairs.

Due to the aforementioned details, Bordeaux was transported to LVMPD Headquarters. I, Detective G King, along with Detective K Long, conducted an interview with Bordeaux who was read her rights per Miranda which she stated she understood. Bordeaux stated she was unable to talk about the incident.

A search warrant was authored by Sergeant J Scott and authorized by the Honorable Judge Leavitt for [REDACTED]. [REDACTED] Crime Scene Analysts along with Homicide Detectives documented the scene. Next to the deceased, was a Glock 19 9mm Serial# [REDACTED] which was confirmed through a records check as a firearm which had been in the possession of Bordeaux. Due to the above circumstances, Bordeaux was placed under arrest for Open Murder with a Deadly Weapon and transported to CCDC where she was booked accordingly.
