**AFFIDAVIT OF PROBABLE CAUSE**

state that the following is true and accurate. The following acts occurred at: 1917 E Linden St Caldwell, Idaho

Canyon County, State of Idaho.

1. Please state what you did or observed that gives you reason to believe the individual(s) committed the crime(s) alleged:

Around August 03, 2025, Meridian Police Detective and ICAC Affiliate Jim Bohr using his undercover law enforcement computers downloaded approximately 2,500 files (digital media) of suspected Child Sexual Abuse Material (CSAM) through the BitTorrent peer-to-peer (P2P) file sharing network, from a device at IP address 24.116.99.68. Subpoena results showed the location of the IP address during the date and times of the downloads was 1917 E. Linden Street, Caldwell. Detective Bohr later transferred the case for investigation to OAG Senior Investigator C. Walker.

Based on further investigation and physical surveillance I identified the possible occupants of 1917 E. Linden Street Caldwell, Idaho to be Jeremey Wakeley and Wayland Wakeley. On January 15, 2026, a search warrant was signed by the Honorable Third Judicial District Judge Matthew Bever for the person of Jeremey Wakeley, the residence at 1917 E Linden St in Caldwell, Idaho, and a 2010 red Ford Focus with Idaho license plate: 2CNS814.

On January 21, 2026, the search warrant was executed. At approximately 0658 hours, the Caldwell Police Department initiated a traffic stop on E Linden St near S Ohio Ave. The driver verbally identified himself as "Brian" and subsequently confirmed his name is Jeremey. I recognized him as Jeremey Brian Wakeley (DOB: 01/12/1984) from his Idaho Driver's license photograph.

I read J. Wakeley his Miranda Warning and asked him to initial and sign the document, he agreed to do so. The following is a synopsis of my interview and contact with J. Wakeley. During my contact with J. Wakeley I observed a cell phone in his front t-shirt pocket. He identified this as his cell phone and indicated it did not have a password on it. He stated he has lived at his current address for years and lives alone. J. Wakeley indicated he has three or four laptops and an old tablet, keeps his property in his bedroom upstairs, and provided me the password for his computer. When asked about what device illegal child pornography images would be located on, J. Wakeley responded they would probably be located on his cellular phone and his laptop although he later said he didn't look at the images on his laptop. J. Wakeley said people send him the images through an app on his cell phone, he thinks it's called Telegram but he'd have to look at his phone to verify. J. Wakeley stated his preference is 17-18 years of age and that he doesn't like the younger ones but he's seen them and currently they'll find younger images than that on his cell phone. He stated he usually just trades those and doesn't look at all of them but sometimes he has to look at them when he downloads them. After receiving the images he connects his cell

phone to his computer and saves them to the attached external hard drive. J. Wakeley then later sends those images he saved on the external hard drive to other users to trade. J. Wakeley stated he trades the images because it's exciting although he knew before today it is illegal. J. Wakeley said he saves some images, only to trade, in the gallery on his cell phone and the last time he viewed one of the images was a few days ago when he was trading them. J. Wakeley estimates he's been trading these images for approximately one year. J. Wakeley indicates he has seen images of minors under 16 years of age engaged in sexual acts and nude. J. Wakeley doesn't think he's seen infants and toddlers but indicates he might have seen images of juveniles as young as 5 years of age. J. Wakeley estimates he trades images of juveniles from 6 to 16 years of age.

J. Wakeley said none of his family members would have come to his house and viewed CSAM. J. Wakeley's Internet service provider is CableOne and he recognizes "Belkin" as the Wi-Fi network for his residence. He doesn't know the password but he has it at the house to join his Wi-Fi.

J. Wakeley states he doesn't sell the CSAM images and only trades them via the Telegram application on his cell phone using the Internet. He remembers trading images from the folder labeled "Cynthia 9yo\_anal" via Telegram with other users.

J. Wakeley indicates he has never physically touched a minor for sexual purposes. J. Wakeley states he doesn't masturbate to the images he views and trades. J. Wakeley states he doesn't remember using BitTorrent to collect the CSAM images as he knew it wasn't a secure place and only used it for movies.

I viewed some of the images located by OAG Forensic Investigator Hardin and confirmed the presence of CSAM. I observed images of juveniles from approximately one years of age through 18 years of age engaged in sexual acts with adults and engaged in lascivious display of their genitals.

Senior Investigator Greg Lindsay viewed 3 of the CSAM images located on the USB drive by Forensic Investigator Hardin and they are described below:

FILE #1 Found in File Folder labeled: 1A2C73DD8954BF3F1460B27CE061A929

FILE DESCRIPTION: This file is a still photograph. It is in color and depicts a 9-11 year female child completely naked, lying on her back, exposing her vagina and buttocks area. The female child is using her right hand, which has two rings on her ring and pinky fingers, to lift her vagina up. The main focal point of the photograph is the female child's vagina. She is laying on what appears to be a bed with blue, purple and green pillows, and a multicolored blanket. On the bottom right side of the image, you can see a date/time stamp that states, "10.13.2004 05:52".

This concludes the description of this file.

FILE DESCRIPTION: This file is a still photograph. It is in color and depicts a 2-5 year old female child. The female child is laying on her back completely naked. The main focal point of the image is the female child's exposed vagina. She appears to be on a bed with white sheets that have multicolored butterflies on them. There is a thick, whitish, milky liquid, which appears to be ejaculation fluid or "Semen" on the female child's stomach and vaginal area. On the bottom right side of the image, you can see a date/time stamp that states, "08/11/2009".

FILE #3 Found in File Folder labeled: D8472E211A8160C3A39763B712BFE1E8

FILE NAME: Z3

FILE DESCRIPTION: This file is a video; it is in color and contains audio. It is approximately 23 seconds long. The video begins by showing what appears to be a dog's erect penis. There is a human hand holding the dog's penis. The dog appears to be golden colored and similar size to that of a Goldendoodle dog breed; however, I can't confirm what breed the dog is. At approximately the 6 second mark, you see the adult switch hands and hold the dog's erect penis with the

adults left hand. The right hand is then used to lift what appears to be a 4–8-month-old baby. I cannot tell what gender the baby is as it only shows the facial and top area of the baby. The adult hand then forces the baby mouth onto the erect penis of the dog. The baby starts crying and shortly after, the hand lays the baby back down on its back. There is a quick camera turn and there is what appears to be a female adult forcing the sexual contact between the 4–8-month-old baby and dog. The video then stops at the 23 second mark.

This concludes the description of this file.

Nampa Police Department Detective and ICAC Affiliate Curtis Carper described two additional images located on the USB drive by Forensic Investigator Hardin. The first image below is from the folder "Cynthia 9yo\_anal" J. Wakeley identified as images he traded with other users via Telegram.

FILE #4:

Video titled Cynthia9yo\_anal.avi is a color video 3 minutes and 24 seconds in length.

The video is found at Drive-F:\Cynthia 9yo\_anal\Cynthia 9yo\_anal.avi and has an

MD5 hash E2269E1AA5AEA8CF067B5F5E215A3393.

There is no audio. The video starts with a close shot of a female's anus and vagina. There is no pubic hair. The words "9yo Cynthia ass slut double fuck and cream her ass" are displayed on the screen. As the video plays additional words of "She gets fucked by two friends in the ass and her uncle is watching" replace the original wording. The video pans backwards giving a wider view. There is an adult hand on the child's left butt cheek. There is a large size difference between the hand and buttock. There is a small child sized hand sticking out between the child's legs. The video continues with the adult male forcing his erect penis inside the anus of "Cynthia" The male continues to anally penetrate the child until ejaculation. The screen then shows another male, with different clothing, with his erect penis in the anus of "Cynthia". At this time, the following words are observed on the screen: "The second friend fucks immediately afterwards and record it" The second male is observed holding a video camera that appears to be recording. The male continues to forcibly penetrate the child until he ejaculates. Based on the size difference of the individuals observed and title of the video, as well as the size of the hand, I believe the video is of a child approximately 8 to 11 years of age.

FILE #5:

Video titled MU8-144.mpg is a 4 minute and 43 second color video with sound (music).

The video is found at Drive-F:\mu08\mu8\MU8-144.mpg and has an MD5 hash 2484ECF71E33D49ABB10551CD4567100.

The video starts by depicting an adult male with an erect penis straddling a very small framed body. A naked body (later identified as a child) is observed from the waist down and is observed wearing a yellow article of clothing pulled up above the waist. The bodies torso is not visible beyond the waist area at this time. The male forcibly penetrates the body with his penis. The video pans out and then shows the torso and head of the small framed body, at this point it is clear this is a child. Her hair is pulled back into a pony tail and tied with a pink ribbon. The child appears to be between 4 and 6 years of age based on the size of the body, hands, and facial features. The video pans back and the male continues to penetrate the child. At 43 seconds, the video the video changes to the male laying on his back. The child is observed laying between the spread legs of the adult male. The child is observed masturbating the male while looking directly at the camera. The child then places the males penis in her mouth. Next, the video changes to the child sitting to the left of the male while the child continues to orally copulate the adult male. The video changed again and the original child is seen in the background with an additional child approximately 6 to 8 years of age now being observed orally copulating the males penis. During the video, there are red lights followed by a flash of bright light as if the acts were also being photographed.

2. What further information do you have regarding what others did or observed giving you reasonable grounds to believe that the individual(s) committed the crime(s) alleged?


During the execution of the search warrant on January 21, 2026, OAG Forensic Investigator Chris Hardin told me he located CSAM images on a USB drive that was attached to a laptop that was located in the upstairs bedroom of the residence. This is the same bedroom J. Wakeley identified as his and laptop he identified as his. When later asked about the naming of some of the folders on the USB drive, J. Wakeley said he only named the dated folders but the other titles are how he received them from Telegram. Some of the titles of the folders located on the USB drive are as follows: "babys", "boys and girls", "Cynthia 9yo\_anal", "Davilla-12", "mu10", "mu08", "master links", "girls and toothbrushes". Some of these folders contained CSAM and adult pornography.

During the service of the search warrant on January 21, 2026, OAG Forensic Investigator Dana Miller told me he located CSAM on J. Wakeley's cell phone and Telegram was located currently open and it appeared J. Wakeley had sent CSAM to other users.
