


1. Affiant is a licensed Peace Officer certified by the State Of Texas.

4. Affiant met with, the Victim, who stated she was stripped by, the Defendant, on a school bus ride back from a volleyball game at Little River Acadaemy, ten to eight minutes up the road from the Dairy Queen in Cameron, TX on HWY 190.
5. Affiant was told by, the Victim, that she was singled out by the actors and the Defendant.
6. Affiant was told by, the Victim, the Defendant took off her shoes and socks then attempted to pull off the Victim's shorts.
7. Affiant was told, the Defendant continued to reach in and attempt to take her clothing off while being told to stop by the Victim.
8. Affiant was told, the Defendant, then removed the Victim's pants and panties to her mid shin and exposed her genitals.
9. Fellow actor Sophie Goodman, stated during her interview with Burleson County S.O. " they (the actors) were looking for a target to rape".
10. A fellow actor, Marina Brinkman, stated in a interview statement from Burleson County SO, Kadie and Alyna (Katherine) took off the Victim's shorts and then her spandex came off.
11. A Witness stated to Burleson County S.O. that the actors (Katherine and Kadie) were pulling her spandex so hard trying to get them off the Victim was being pull off the seat while trying to keep her spandex on.
12. The Defendant stated in an interview with Burlseon County S.O. that it was a "tradition" because it happens every year.
13. Affiant was told by, the Victim, the Defendant, intentionally continued to try and remove the Victim's clothes even after repatedly telling the Defendant to stop.
14. Affiant, due to the facts, has good reason to believe and does believe, the Defendant, committed the criminal act of Indecency with a Child Exposes 21.11 (d) and is charging, the Defendant, with that offense.

6. Affiant was told by, the Victim, the Defendant took off her shoes and socks then attempted to pull off the Victim's shorts.
7. Affiant was told, the Defendant continued to reach in and attempt to take her clothing off while being told to stop by the Victim.

6. Affiant was told by, the Victim, the Defendant held her in the seat while the Victim's shoes and socks were taken off then, the other actors took off the Victim's pants.
7. Affiant was told, the Defendant continued to hold her in the seat, while the other actors tried to reach in and attempt to take her clothing off while being told to stop by the Victim.
8. Affiant was told, the Defendant, was holding her down when the Victim's pants and panties were removed to her mid shin and exposed her genitals.
A fellow actor Sophie Goodman stated during her interview with Burleson County S.O. " they (the actors) were looking for a target to rape".
9. A fellow actor, Marina Brinkman, stated in a interview statement from Burleson County SO, Kadie and Alyna (Katherine) took off the Victim's shorts and then her spandex came off.



6. Affiant was told by, the Victim, the Defendants job was to keep everyone else on the bus unaware of the incident.
7. Affiant was told, the Defendant played music as loud as possible and sang as loud as she could to cover any sound the Victim made.
8. Affiant was told, the Defendant's role in the crime was to be the "lookout" and aleart the other actors if anyone raised suspicion.
