AGREED ORDER OF SUMMARY SUSPENSION

This matter was presented to the Commissioner of the Department of Commerce and Insurance through his designee, Assistant Commissioner, Regulatory Boards Division, Alex Martin, (hereafter referred to as the "Commissioner"), pursuant to the provisions of Tenn. Code Ann. §§ 4-5-320(c) and 4-5-320(d)(1)(A) which state, in pertinent part, as follows:

Tenn. Code Ann. § 4-5-320(c):

(c) . . . If the agency finds that public health, safety, or welfare imperatively requires emergency action, and incorporates a finding to that effect in its order, summary suspension of a license may be ordered pending proceedings for revocation or other action. These proceedings shall be promptly instituted and determined.

Tenn. Code Ann. § 4-5-320(d):

- (d)(1) Notwithstanding subsection (c), in issuing an order of summary suspension of a license the agency shall use one (1) of the following procedures:
- (A) The agency shall issue a notice to the licensee providing an opportunity for a prompt informal hearing, review or conference before the agency prior to the issuance of an order of summary suspension;

WHEREAS, based upon the agreement of the parties as evidenced by the signatures below, the Commissioner makes the following Findings of Fact and Conclusions of Law:

Dylan Larocca (hereinafter "Respondent"), is licensed by the State of Tennessee
 Department of Commerce and Insurance, Detection Services Licensing Program, as an Unarmed
 Security Guard, License Number 455392.

- 2. According to the Respondent's arrest records and documentation received by the Detection Services Licensing Program ("Program"), on or about December 16, 2021, the Respondent was indicted for and charged with one count of aggravated assault and one count of reckless homicide.
 - 3. These charges are currently pending.
- 4. The Commissioner may discipline a licensee for violating any statute or rule under Tenn. Code Ann. § 62-35-101 et. seq. and/or for emergency action pursuant to Tenn. Code Ann. § 4-5-320.
- 5. Due to Respondent's pending criminal charges, he agrees to the voluntary suspension of his Unarmed Guard License, No. 455392, pending the outcome of his criminal proceedings or for license revocation proceedings or other action by the Program.
- 6. The Respondent agrees to this voluntary suspension of his license without making any admission as to any facts or circumstances surrounding the alleged incident that led to his criminal charges.
- 7. Respondent, without making any admission of fact relating to the nature of his criminal charges, agrees to this voluntary summary suspension of his license, to the jurisdiction and authority of the Program and Commissioner, and to provide appropriate updates to the Program regarding the status of his criminal charges upon the request of the Program and upon the final disposition of his criminal charges.
- 8. The Respondent waives the right to an informal hearing, review, and/or conference before the Program and Commissioner and consents to the entry of this Order.

Therefore, due to the agreement of the parties and waiver of the right to an informal hearing, conference, and/or review before the Program and Commissioner, the Commissioner finds that the

health, safety, and welfare of the public immediately requires this emergency action and the immediate summary suspension of Respondent's license.

IT IS THEREFORE ORDERED that the License Number 455392 for Dylan Larocca shall be summarily **SUSPENDED** by the agreement of the parties and pursuant to the entry of this Order, pending the outcome of the Respondent's criminal case and/or proceedings for revocation or other action by the Program.
