	<p>On June 3rd 2021 at 1952 hrs, Deputies responded to the listed location for a juvenile with sharpened sticks, hitting the walls and threatening staff. Deputy Humphries and Deputy Connolly arrived and was directed to Building 9 where the disturbance was located. Both deputies arrived at building 9 and located several staff members holding the door to the day room locking the victim inside. Both deputies observed [REDACTED]/JUVENILE holding a large piece of wood and using that wood to destroy the dayroom.</p> <p>Both Deputy Humphries and Deputy Connolly attempted to calm [REDACTED] down by attempting to talk with him. Soon Sgt Johnston and Deputy Majette arrived on scene and began attempting to calm [REDACTED] by talking with him. After approximately 45 minutes, All deputies decided to enter the dayroom and Deputy Majette and Deputy Connolly were able to talk with [REDACTED] and calm him down. After [REDACTED] was disarmed, Units were able to set him down and try and figure out the issue.</p> <p>Deputy Humphries discovered from [REDACTED] that he was suppose to have a phone call with his mother at 2000hrs. Unfortunately, [REDACTED] tripped over the phone which caused the phone to fall and break. [REDACTED] stated, he picked up the cord to the phone and one of the nurse stated that she would hit him over the head with a walkie talkie if he</p>

<p>approached her with the phone cord. [REDACTED] stated after receiving the threat, he was unable to control his anger and rage.</p> <p>[REDACTED] informed Deputy Humphries that the hospital staff has not been consistent with giving him his needed medication and the inconsistency has caused severe mood swings, anger and aggression. [REDACTED] stated, the threat made to him plus the inconsistency related to his medication was too much for him to take so he exploded.</p> <p>Deputy Humphries attempted to speak with someone about getting [REDACTED]'s mother on the phone so deputies could explain the situation with her. The on duty supervisor asked Deputy Humphries would we TDO [REDACTED] and Deputy Humphries explained, once a patient is inside a mental health facility receiving treatment for a psychiatric issue, we typically wont remove that patient via ECO and transport him or her to another mental health facility. The supervisor clearly wasn't satisfied with Deputy Humphries answer so he referred her to Sgt Johnston.</p> <p>After some time passed, Deputy Humphries initiated an ECO based on conversations between Sgt Johnston, Lt. Carnell and Cumberland Hospital Staff. Cumberland Hospital staff made contact with Henrico Mental Health and Henrico Mental Health performed a virtual assessment on [REDACTED] agreed to the assessment and agreed to voluntary treatment at a different facility. Henrico Mental Health determined that [REDACTED] was a voluntary committal and terminated the ECO. Deputy Humphries and Sgt Johnston released [REDACTED] back into the custody of Cumberland Hospital staff without further incident.</p>
