MATT JENNINGS, Deputy County Attorney, deposes and says that on or about September 8th, 2021, in Missoula County, the Defendant committed the offenses of:

COUNT I: ATTEMPTED DELIBERATE HOMICIDE, a Felony, in violation of Mont. Code Ann. § 45-5-102(1)(a), and 45-4-103, punishable by life imprisonment, or not less than 10 or more than 100 years MSP;

COUNT II: CRIMINAL ENDANGERMENT, a Felony, in violation of Mont. Code Ann. § 45-5-207, punishable by 10 years MSP and/or \$50,000 fine;

COUNT III: CRIMINAL ENDANGERMENT, a Felony, in violation of Mont. Code Ann. § 45-5-207, punishable by 10 years MSP and/or \$50,000 fine;

COUNT IV: CRIMINAL ENDANGERMENT, a Felony, in violation of Mont. Code Ann. § 45-5-207, punishable by 10 years MSP and/or \$50,000 fine.

**For each of the counts, Defendant is subject to the firearm sentence enhancement specified in Mont. Code Ann. § 46-18-221, punishable by not less than 2 or more than 10 years MSP in addition to the punishment provided for in the underlying offenses.**

The facts constituting the offense are:

COUNT I: On or about September 8, 2021, Defendant purposely or knowingly attempted to cause the death of J.H. by shooting him.

COUNT II: On or about September 8th, 2021, Defendant knowingly engaged in conduct that created a substantial risk of death or serious bodily injury to J.O. to wit: Defendant shot a firearm in the direction of J.O.

COUNT III: On or about September 8th, 2021, Defendant knowingly engaged in conduct that created a substantial risk of death or serious bodily injury to S.D. to wit: Defendant shot a firearm in the direction of S.D.

COUNT IV: On or about September 8th, 2021, Defendant knowingly engaged in conduct that created a substantial risk of death or serious bodily injury to B.M. to wit: Defendant shot a firearm in the direction of S.D.
