PROBABLE CAUSE STATEMENT

On 10/30/2020 at approximately 19:28HRS, Sr. Ofc. M. Dominguez 6431 and I, Ofc. V. Fabie 1223, were dispatched to a STAB / CHARLIE at 5220 WEBER RD CC NUES, APT 103C @ WEBER SQUARE APARTMENTS reference a male subject who stated he stabbed his girlfriend earlier in the day.

Officers made contact with OF Rodrigo Garza Jr at apartment # 103C. Upon opening the door to the apartment, Garza stated "I killed my girlfriend". Garza was detained and handcuffed.

From the front door of the apartment, a female subject could be seen lying on a mattress in a back bedroom. The female had a large laceration on her neck and was unresponsive. Medics arrived on scene and confirmed the female to be deceased. Garza identified the female as VI [REDACTED]

The only subjects located inside the apartment at the time of contact were Garza and [REDACTED]. A kitchen knife was on the bed next to [REDACTED]. Garza had dark, red stains, believed to be blood, on the bottom of his pant legs.

Lt. Tackett arrived on scene. CID was notified and responded. ID Technicians D. Garza 16410 and A. Tuttle 16433 processed the scene. Medical Examiner Deborah Perez was notified and responded.

Garza was transported to the main police station for questioning. Garza was then transported to CDC for booking.

"On 10/30/2020 at 1928, Officer V. Fabie #15223 and I S/O M. Dominguez #6431 were dispatched to 5220 Weber Road #103C, in reference to a possible stabbing. The call noted that a male called in stating that he had stabbed his girlfriend.

Upon arrival we contacted a male subject at the door, later identified as Rodrigo Garza (of#1). Rodrigo immediately advised us that he had killed his girlfriend. We quickly detained Rodrigo and I conducted a safety sweep of the residence. While checking the bedroom on the South end of the apartment, I saw a female laying on a bed that had blood around her head and neck area. The female was not breathing and seemed to have expired for some time. Rodrigo was then placed in Officer Fabie's unit. S/O Ruebelmann arrived and started the crime scene log.

I canvassed the area to look for witnesses. I went to apartment [REDACTED] and contacted [REDACTED]. [REDACTED] advised me that he had arrived at his apartment around 1940 and had not herd or seen anything. I then went to [REDACTED] and contacted [REDACTED] who advised me that she was at her residence most of the day. [REDACTED] advised me that she had not seen or heard anything all day long.

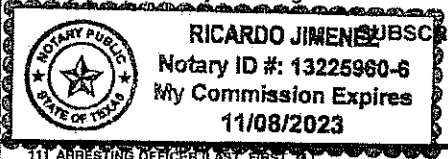
