I am a police officer for the City and County of Denver, Colorado, and have knowledge regarding the arrest/incident of the above named party for the below listed offense, which offense occurred on or about the date of 06/04/2022 at 9:01 pm at or near the location of 490 W COLFAX AVE in the City and County of Denver, State of Colorado.

The probable cause of the arrest of the above-named individual is as follows:

[On 06-04-2022 at approximately 2100 hours, I, RO Kaufmann while working 651H, was advised by Denver Sheriffs at the Denver Detention Center (DDC), 490 W Colfax Ave, of a narcotics call. This occurred in the City and County of Denver, State of Colorado.

Investigation disclosed, on 06-04-2022 at approximately 1800 hours, Sergeant Boothe (S16109) and Deputy Roberson (S21026) responded to Pod 3F, for an overdose medical call. Due to the nature, a search was conducted of an 8 man cell, 3F-202, where the incident occurred.

During the search, Sgt Boothe and Deputy Roberson, contacted inmate/arrestee, later identified by CO ID PIN [REDACTED] and his most recent mug shot photo CD [REDACTED], Kevin Bui, DOB 022604. During the search a blue baggies was found in Bui's sock. Bui at this time was escorted to a private area to conduct an additional search. When Bui's pants were removed, an additional baggie was discovered falling out of the pants.

When conducting an inventory of the suspected narcotics the following was found;

A blue baggie with 46 blue pills with an "M" marking on one side and a "30" marking on the opposite side, of suspected fentanyl

A blue baggie inside of a tan baggie with 46 blue pills with an "M" marking on one side and a "30" marking on the opposite side, of suspected fentanyl

The baggies were located inside of a set of blue gloves, inside of a secured bag to secure the suspected narcotics.

Bui is a current inmate at the DDC.
