

Sarah Ganoe told him not to be sad, but the house would be bloody when he got home. John Howard left work and called 9-1-1 while driving to his residence. John Howard arrived on scene before paramedics and made entry with his house key. Upon entry, John Howard observed a large amount of blood in numerous bed rooms. He then located Sarah Ganoe, Zell Howard, and lying on the bed in the master bedroom. Sarah Ganoe had superficial stab wounds to her body. Sarah Ganoe was taken into custody and she was transported to Riverside Regional Medical Center for treatment. After being medically cleared, she was transported to Newport News Police Headquarters and interviewed. Post Miranda, Sarah Ganoe admitted to stabbing her two children, Zell Howard and I multiple times with a knife. She had bruising to her right hand and arm that she stated was caused by "hammering" the knife during the stabbing. Sarah Ganoe also had one bite

mark to her right forearm that she stated was from biting her in an attempt to get free.
