11 The Grand Jurors of the County of Cochise, in the name of the State of Arizona, and
12 by its authority accuse:

13 **ALYSHA RAE HOP AND DANIEL JAWARA FOSTER**

14 and charges that in Cochise County:

17 **COUNT 1: First Degree Murder**

18 DANIEL JAWARA FOSTER and **ALYSHA RAE HOP**, on or about June 3, 2020,
19 acting either alone or with one or more other persons, committed or attempted to commit
20 Child Abuse, the victim being under the age of fifteen, A.R.S. §13-3623, and in the course
21 of and in furtherance of such offense, or immediate flight from such offense, DANIEL
22 JAWARA FOSTER and **ALYSHA RAE HOP**, or another person did cause the death of
23 KG, in violation of A.R.S. §§ 13-1101, 13-1105(A)(2), 13-303, 13-701, 13-702, 13-751,
24 13-752 and 13-801, a class 1 Felony.

3 **COUNT 2: Child Abuse**

4 DANIEL JAWARA FOSTER and ALYSHA RAE HOP, on or about June 3, 2020,
5 under circumstances likely to produce death or serious physical injury, intentionally or
6 knowingly did cause KG, a child under fifteen years, to suffer physical injury or, having
7 the care or custody of KG, caused or permitted the person or health of KG to be injured or
8 caused or permitted KG to be placed in a situation where the person or health of KG
9 was endangered, in violation of A.R.S. §§ 13-3623(A)(1), 13-303, 13-705, 13-701, 13-702,
10 and 13-801, a class 2 Felony.

11 The State further alleges that the offense charged in this count is a Dangerous Crime
12 Against Children in violation of A.R.S. §13-705.

15 **COUNT 3: Child Abuse**

16 DANIEL JAWARA FOSTER and ALYSHA RAE HOP, on or about February 28
17 2020 to June 3, 2020, having the care or custody of IG, a child, under circumstances other
18 than those likely to produce death or serious physical injury intentionally or knowingly did
19 cause IG to suffer physical injury or abuse or, having the care or custody of IG caused
20 or permitted IG's person or health to be injured or to be placed in a situation where her
21 health was endangered, in violation of A.R.S. §§ 13-3623(B)(1), 13-303, 13-701, 13-702,
22 and 13-801, a class 4 Felony.


COUNT 4: Child Abuse

DANIEL JAWARA FOSTER and ALYSHA RAE HOP, on or about February 28, 2020 to June 3, 2020, having the care or custody of KH, a child, under circumstances other than those likely to produce death or serious physical injury intentionally or knowingly did cause KH to suffer physical injury or abuse or, having the care or custody of KH caused or permitted KH's person or health to be injured or to be placed in a situation where her health was endangered, in violation of A.R.S. §§ 13-3623(B)(1), 13-303, 13-701, 13-702, and 13-801, a class 4 Felony.
