Subject: RE: COB Notifications

Deputy Chief Hagar,

Thank you for facilitating this conversation and for your introduction to Acting Director Milliken.

Director Milliken, as you are aware, our Legal Advisor, Todd Pinckley, has been working with Ms. Cyndi Gross of Metro Legal to develop a Memorandum of Understanding between Metro Community Oversight and DEC. It is my understanding that you have received the MOU and have reviewed it briefly. The essence of the MOU was that MNCO would receive call-out notification from DEC for critical incidents involving MNPd. The "critical incidents" to which MNCO requested notification were:

- (1) All MNPd police personnel involved shootings;
- (2) All in-custody deaths; and
- (3) Any other incidents where an MNPd Commander is notified of an occurrence

Therefore, in an effort to speed up this process, I would request that DEC provide our office with notification by e-mail, phone call, and/or text message if any of the above critical events occur. If possible, I would request that you make notification to all of the following MNCO staff members when a critical call-out incident occurs:

- (1) William C. Weeden, (615) 330-7377 (call/text), william.weeden@nashville.gov
- (2) Jill Fitchard, (615) 218-1110 (call/text), jill.fitchard@nashville.gov
- (3) Todd Pinckley, (615) 306-6652 (call/text) Robert.pinckley@nashville.gov

It is my understanding that no other Metro entities have MOUs for call-outs on critical incidents. Hopefully, MNCO can bypass the need for an MOU as well.

Director Milliken,

I understand that there may have been some communication issues over the weekend about notifying COB on certain incidents. Let me try to help resolve that and speed up the process by facilitating a dialogue and your staff access to COB staff.

We were given Mr. William Weeden's (Director of Nashville Community Oversight) contact information Saturday afternoon. I wanted you to have that number in case you or your staff needed to contact them. While I am unaware of exactly what incidents they want to be notified of, I wanted to ensure your office had the same information we received. His number is 615-330-7377.

Although we had suggested that they should contact your office directly to receive DEC notifications (as DEC is a separate department and not a MNPD operation), I am not sure to what extent that has occurred. If they have reached out and made those requests already, great. If not, hopefully this email helps start that dialogue with you; as Mr. Weeden is copied on this email and can clarify any unresolved issues directly with you and your office.
