On Sunday, 11/04/18 at approximately 1550 hours, Officer R. Hackleman #1354 and I (Officer L. Rodriguez #1165) were dispatched to the residence at [REDACTED] in regards to an annoying a child report.

Upon arrival, I made contact with the [REDACTED] and [REDACTED] stated she has an application on [REDACTED] cell phone that tracks her location. [REDACTED] stated last night, [REDACTED] dropped her off and she later noticed [REDACTED] went to a residence she believed belonged to one of [REDACTED] friends, from approximately 0030 hours until 0145 hours. [REDACTED] said when she noticed last night, she asked [REDACTED] where she was at and [REDACTED] told her she was dropping something off at a friend's. [REDACTED] said when she texted [REDACTED] to pick her up, it took another 20- 30 minutes for her to leave the residence.

[REDACTED] stated today, he and [REDACTED] became suspicious of where [REDACTED] had been the night prior so they looked up who the residence belonged to and discovered the owner was JEFFREY HICKS. [REDACTED] said she instantly recognized the name because [REDACTED] has spoken about him many times in the past, describing him as the cool teacher everyone likes. [REDACTED] has also told her HICKS said he thought she [REDACTED] was hot. [REDACTED] also said [REDACTED] is a teacher's aide for HICKS. [REDACTED] said she took [REDACTED] cell phone and did not notice any provocative pictures or text in the phone. She also said when she opened [REDACTED] Instagram account, there was a text thread between [REDACTED] and HICKS; however, there was not text. Moments later the thread disappeared. [REDACTED] said HICKS can delete the text thread on both sides from his account and believes he did so.

I then contacted [REDACTED] the interview was recorded utilizing my department issued recorder and the recording was later downloaded into DIMS. The following is a synopsis of my interview and not verbatim. [REDACTED] stated she is a [REDACTED] and she is a teacher's aide [REDACTED] for her math teacher, HICKS. [REDACTED] stated she and HICKS began to message each other approximately two months after the school year began. [REDACTED] stated she first began messaging with HICKS on Instagram and approximately two weeks later, she added HICKS on her Snapchat, where they continued to message each other. [REDACTED] stated her user name on Snapchat is [REDACTED] and HICKS' username

is "JEFF HICKS". [REDACTED] stated she and HICKS became close after she began speaking with him regarding her parent's divorce. [REDACTED] stated she would text HICKS every night as well as after school talking about her problems and he would listen to her vent. [REDACTED] stated during their conversations, HICKS would randomly message her his address and the gate code to his gated community; she believed in an attempt to persuade her to go over. [REDACTED] said she would usually ignore the messages or make an excuse as to why she could not go. [REDACTED] said HICKS behavior became sporadic and she never knew if he was mad, sad, or happy. [REDACTED] said if she did not respond to a text from HICKS, he would sometimes delete her from all social media then re-add her minutes or hours later. [REDACTED] said she initially would talk to HICKS about boys she would talk to, hang out with, or dance with at events. Recently HICKS would become angry and jealous hearing this so [REDACTED] stopped telling him. [REDACTED] said this change in behavior from HICKS has caused her to become upset all the time, not wanting to eat, and avoiding the early part of school to avoid HICKS. [REDACTED] also confirmed [REDACTED] has been missing early parts of school and did not know the reason until today.

[REDACTED] stated two nights ago, HICKS asked her to go over and she told him she could not because her mother was there. He told her to wait until she went to sleep then go over and she told him no. Last night, when she dropped her mother off, HICKS told her to go over and [REDACTED] said she felt obligated because she had told him no or ignored it so many times before. [REDACTED] said she arrived at HICKS residence at approximately 0030 hours, and HICKS was standing to the front of his residence. [REDACTED] said HICKS pulled her in tight by the arms to give her a hug. [REDACTED] stated she felt uncomfortable but did not say anything. [REDACTED] stated HICKS then asked her if she wanted to go to his room as he started walking towards it, and she followed. [REDACTED] stated while inside HICKS' room, he lied on the bed with his head near the pillows, while she sat at the foot of the bed looking at Instagram on her phone. [REDACTED] stated as she was looking at her phone, she could see HICKS holding his arm out towards her believing he wanted her to move next to him; however, she would ignore him. [REDACTED] said they did not talk much while there and mostly stayed on her phone. [REDACTED] said she felt really uncomfortable there but again did not say anything. [REDACTED] stated her mother began texting her while at HICKS' residence and HICKS became upset when he read a text from [REDACTED] to [REDACTED] stating she was ready to be picked up. [REDACTED] stated at approximately 0130 hours, as she was holding her phone and still sitting on HICKS' bed, he placed his head between her phone and her face and got very close to her lips. [REDACTED] stated HICKS' lips were touching her face;

however, he never kissed her. [redacted] and she moved back away from him because she felt weird about it. [redacted] stated she then left the residence at approximately 0140 hours, and went home.

I asked [redacted] if she and HICKS ever exchanged photographs on Snapchat and she stated they have. [redacted] stated she has received approximately 20 Snapchats from HICKS. [redacted] said the photographs consist of HICKS' face or body fully clothed. [redacted] said there were a few times HICKS sent a picture of himself with a towel around his waist as if he just got out the shower. I asked [redacted] if HICKS has ever sent her nude photographs of himself and she stated he has not. I asked [redacted] if she has ever sent HICKS nude photographs of herself to HICKS and she stated she has not. [redacted] said she is usually fully clothed in the pictures she has sent. [redacted] did she has sent him photographs of herself in pajamas consisting of a sports bra and spandex shorts (spunks). [redacted] HICKS replied to one of the photographs saying "Oh, I can take those pants off". Other times he has commented to her saying, "Sexy, or gorgeous". I asked her if she has had any other physical contact with HICKS and she said occasionally she would give him a "high five" and he would keep hold of her hand momentarily until she pulled it away. [redacted] and she thought that was weird but never told him anything. [redacted] said he has given her a hug on prior occasions; however, the only time she thought it was weird was last night as his residence.

I asked [redacted] if she and HICKS have ever discussed what to say if they were questioned about their relationship or if it was found out they were texting and sending pictures. [redacted] said they had and they would say they are just close and nothing is going on. [redacted] said when her parents found out she was at his house, she texted him on Snapchat telling him her parents know and her father was going to go to his house. HICKS asked her if she was serious and she said yes. [redacted] did HICKS deleted her from his account prior to her yes response as it now shows pending, meaning it has not gone through. I asked her if there was anything I was missing or did not ask that she thought I should know and she said there is not and she has said everything. [redacted] said HICKS was investigated by the school last year when it was discover he was texting another student; however, doesn't know what that investigation entailed. [redacted] said she did not believe it was anything more than an innocent text and he was advised to be careful when communicating with students. [redacted] also said HICKS frequently speaks to a former student who is now in college in San Luis Obispo and they frequently facetime each other. [redacted] said she initially did not expect anything like this to happen because HICKS communicates with many students

via social media and that is all it would be.

[REDACTED] brought up a picture of HICKS via facebook which she confirmed to be the subject she told me about. Officer Hackleman took a photograph of this and later uploaded into DIMS.

We responded to HICKS residence at [REDACTED] which was provided to us by [REDACTED]. HICKS answered the door and I recognized him from the photograph [REDACTED] showed us and he identified himself as being HICKS. I asked him if he knew why we were there and he said he did. I asked him if we could speak and he said we could and invited us into his home. I asked him to tell me what he believed we were there for and he said because of a [REDACTED] HICKS said [REDACTED] is his [REDACTED] and has been for this [REDACTED] recently she began having problems at home dealing with her parent's divorce and she found it easy to speak to him. HICKS said he is younger than many [REDACTED] and believes this is why many students gravitate toward him. HICKS said he is really caring, to a fault, and he was only trying to help [REDACTED]. I asked him how they communicated and he said they mostly talk and there have been some text messages. I asked him how they text each other and he said on their phones. I asked him if it was through regular texting and he said it was. I asked him if he still had the texts and he said he does not and he deletes all his texts. I asked him what the texts consisted of and he said they would speak to [REDACTED] about her problems or would tell her to go to school because she was absent. I asked him if they ever sent pictures to each other and he said they did not. I asked him if [REDACTED] as ever been to his house and he said she has not. HICKS said last night [REDACTED] called him asking to go over and he told her no because it was not appropriate. [REDACTED] said he does not know if [REDACTED] showed up or drove by but she did not go over. I told HICKS I already knew the answer to everything I was asking him and he was lying to me. I told him just because things have been deleted off the phone, nothing is ever really gone and could be easily retrieved. I told HICKS this was his opportunity to tell his side of the story because [REDACTED] is already told me hers. I told HICKS I was going to let him start over and tell me what really happened. HICKS said he and [REDACTED] began texting each other and it escalated into more. I asked him how they texted and he said on instagram. I asked him if he had those texts and he said he did not. I asked what they would talk about and he said it escalated to talking about hanging out outside of school. I asked him if [REDACTED] came to his residence last night and he said she showed up unannounced while he was asleep. HICKS said he opened the front door and spoke to [REDACTED] outside in the front yard for about 20 minutes. HICKS said [REDACTED] as crying and upset telling him she had taken her

mother to a bar. HICKS said after about 20 minutes, [REDACTED]. I asked him if [REDACTED] ever went inside for any reason and he said she did not. I asked him if there is any reason why [REDACTED] could describe his bedroom and he said maybe from pictures he has sent her in the past of himself in the bedroom. I asked him if they had any contact and he said he gave [REDACTED] hug when she left his residence and that was it. I asked him if they ever sent any revealing pictures of themselves to each other and he said they did not. HICKS said he has sent a picture of himself without a shirt and he knows that is wrong. I again told HICKS he was not being truthful and I know the answers to the questions I am asking. HICKS became defensive and asked if it was okay for me to be questioning him like this. I again informed HICKS he did not have to speak to me and he invited us into his home to speak. I told HICKS he could not tell me anything else if chose to, and I was only there to offer him an opportunity to tell his side of the story. I told him if he did not want to clarify the things he has already told me and I know to be false, the truth would come out and I do not believe it would be in line with what he has told me. I asked him if that is what he wanted his statement to be and he said he did not and wanted to cooperate with the investigation. HICKS said he knows what he has done is wrong and it just escalated to a place he did not intend.

HICKS said he was lying and wanted to tell the truth. HICKS said he and [REDACTED] have been primarily texting on Snapchat and sending pictures to each other. HICKS said he has not sent any pictures of himself exposing his private parts; however, [REDACTED] has sent nude pictures of herself to him. [REDACTED] said it was only a couple times and it was only of her breasts. I asked him if her breasts were fully exposed without a bra and he said she did not have anything covering her chest. I asked him if he asked her to send the nude pictures and he said he did not. I asked if him if [REDACTED] sent any pictures of her vagina and he said she did not. I asked him what he replied when the nude pictures were sent and he said gorgeous. I asked him what would text about and he said they would occasionally talk about hanging out after school but it never happened. I asked him if he asked her to go over last night and he said he did. HICKS said he also wanted to say that [REDACTED] was in his room last night and that is why she would know what it looks like. I asked him to tell me what occurred last night and he said when [REDACTED] arrived they went into the bedroom and they both sat near the headboard. [REDACTED] was mostly on her phone looking at instagram while they talked. HICKS said [REDACTED] getting texts from her mother occasionally and [REDACTED] was going to leave to pick her up. Just before [REDACTED] left, he moved towards [REDACTED] and began kissing her on her lips. HICKS said they "made out" for about five minutes then she left. I asked him

what the making out consisted of and he said it was only kissing on the lips. I asked him if he was touching her anywhere or if she was touching him and he said they were not and it was only kissing. I asked HICKS if there was anything else that has occurred that I have not asked or he thought I should know and he said there is not. HICKS said he has now told me everything.

I asked HICKS for his cellphone which he provided to me and I seized as evidence. [REDACTED] also provided me with [REDACTED] cell phone and I later booked them into the BPD Property Room as evidence.

I responded back to [REDACTED] residence to speak with her about what HICKS said. [REDACTED] denied sending any nude photographs of her breasts to HICKS. [REDACTED] said HICKS was trying to kiss her last night for about five minutes but they were not actually kissing.

[REDACTED]'s parents were present during the interview and are aware of what occurred. I provided [REDACTED] with a victim assistance guide with this case number. [REDACTED] advised [REDACTED] would not be going to school tomorrow and they would respond to the school to speak with them regarding the investigation and what could be done to address [REDACTED] being assigned to HICKS class. They were all advised not to communicate with HICKS which they said they would not.

Sgt. K Williams was notified of this investigation.

On 11/05/18 as a Detective in the Bakersfield Police Department's Special Victim's Unit I was assigned to conduct follow up on this investigation. I found that Officer's L. RODRIGUEZ #1165 and R. HACKLEMAN #1354 had conducted the initial investigation the day before on 11/04/18 and had interviewed both the victim, [REDACTED] and the suspect, JEFF HICKS. For further details on their investigation see their initial offense report. I found that when [REDACTED] was interviewed yesterday both of her parents, [REDACTED] and [REDACTED] were present. On 11/05/18 Detective A. TIPTON #1163 and I went to the [REDACTED] interview [REDACTED] again, this time I requested to interview [REDACTED] without her parents present and both [REDACTED] and [REDACTED] agreed and stepped outside.

I recorded this interview without the knowledge or permission of [REDACTED] later downloaded this recording to BPD DIMS. The following is only a synopsis of the interview and is not verbatim or in chronological order. For the exact context of the interview listen to the recording.

[REDACTED] confirmed that JEFF HICKS had asked her to come to his house on Saturday which was 11/03/18. Although from the initial offense report it looks like she arrived at his house just after midnight which would have been the first hour of Sunday 11/04/18. She said this request by JEFF HICKS was on Snapchat. [REDACTED] said the Officers had taken her phone but she had tried to sign in on her Snapchat account from another device but was told her log in was wrong and she couldn't get in. Detective TIPTON asked [REDACTED] what JEFF HICKS'S Snapchat is and she said she didn't know it by heart but her Mom had looked it up and it was just "JEFFHICKS". [REDACTED] said other people have been have tried to look him up today and it seems like all of JEFF HICKS social media has been deleted. [REDACTED] said HICKS'S Instagram account had been "JEFFFHICKS" with three "F's". She said most of their communication had been on Snapchat. [REDACTED] had considered making a new Snapchat account at one time to contact her without anyone else knowing but he never did create that new account. [REDACTED] SNAPCHAT account is [REDACTED] that is the only one she ever used.

I tried to confirm with [REDACTED] what had occurred when HICKS tried to kiss her and she said she did not kiss him back but he was basically trying to kiss her. She said he was kissing her but she wasn't kissing him back. She said she was dodging being kissed and demonstrated by moving her face back and forth. And that went on for about five minutes.

[REDACTED] said more things about that night are coming back to her now that she has calmed down, she said she was worked up yesterday. [REDACTED] said when arrived at his house she felt everything was super aggressive and JEFF HICKS grabbed her arm and pulled her inside and she had no choice weather to go inside and he shut the door and locked it. I asked her if she had told the Officers yesterday that she had followed JEFF HICKS in to his house and she said no she told them that he pulled her in. I listened to the recording in BPD DIMS of the Officers interview with [REDACTED] heard [REDACTED] when she arrived

HICKS did grab her and hugged her tight and it scared her and he asked her to come into his room and she was like I don't know. She said he just walked into his room and he laid down and then pulled her but she backed up and sat on the bed.

[REDACTED] told us today that JEFF HICKS had asked if she wanted to come to his room and she said she stated "I don't know" she said it was weird and she felt uncomfortable. She said JEFF HICKS grabbed her arm and took her to his room [REDACTED] said JEFF HICKS pulled her on top of him and she had no choice. She said JEFF HICKS asked her why she was acting shy and said she felt uncomfortable [REDACTED] said she told JEFF HICKS that she was uncomfortable and that this was weird and he told her she could leave, but then he would let her leave and pulled her closer. She said basically she said she wanted to leave but he pulled her closer. She said JEFF HICKS would put her on top of him and she would get off. She said when she did get off and she sat on the side of the bed and he asked her why she was on her phone so much. She said he kept saying she could leave but he wouldn't let her leave. I asked her if she ever actually tried to leave and she said no but when she got up to leave to get her Mom that when he got in front of her tried to kiss her.

I asked [REDACTED] if JEFF HICKS touched her anywhere else besides his lips touching her lips. [REDACTED] said JEFF HICKS tried to take off her pants she said he laid her down on her back and tried pulling down her shorts. She said she told him she didn't want her shorts off and he told her "you tied them tight on purpose". She said when he continued to pull her shorts, she sat up so he could get them off. She said he looked all "butt hurt" and turned away. She said she told JEFF HICKS that she was going to leave but she always felt like he was doing something to make her stay. She said after she did leave he texted her and said "I wanted more", she then confirmed it was a Snapchat message and not a text. She said he also mentioned that he wanted her there every day. She said he also told her to come back but she told him she couldn't and said she was so uncomfortable and didn't know what to do. She said after he wrote he wanted more he wrote "...kiss" and she didn't know what that meant. She said after she didn't respond he wrote "so you didn't want more", she said she didn't know but it seemed really forceful. She said it was almost like he was making her say she wanted it. She said he said a bunch of little things and she responded back but didn't know what she responded with.

[REDACTED] did he and JEFF HICKS have been sending each other electronic messages for about a month and half. I asked [REDACTED] describe the pictures that JEFF HICKS has sent to her. She said he sent her pictures of himself with no clothes on in the mirror but he was holding his private spot. She went onto say he would send some pictures with a towel on or underwear on [REDACTED] said his penis was never exposed in any of the pictures. I asked if he had ever exposed his penis to her in person and she said that night and she said he was "thrusting me and pulled down his pants". She then said she didn't know if his penis was out of not it may have been in his underwear. She said it hurt and didn't feel good. She described herself laying on the bed and he was standing between her legs thrusting. She described his penis rubbing on her vagina but she had her shorts on still and he may have still had on his underwear. She said he did pull down the front of his shorts but she didn't know about his underwear.

[REDACTED] said JEFF HICKS was wearing a [REDACTED] dry fit shirt and some navy blue or black gym shorts. [REDACTED] said she has sent him pictures of her but not naked pictures, but like in a towel or a sports bra. She then said when she was sending those pictures she didn't want to but she felt like she had to and

she felt forced to. I asked how she was forced to like she had to give him the attention and she said JEFF HICKS is super demanding. She said there were times when he would be nice to her and before this they were very close. She thought the photos he sent were a joke at first but then it started getting weird. She said she would be nice then he would be nice, then he would be rude and stop talking to her, to make her chase after him, like it was all a game he was playing in order to get what he wanted. She said when he ignored her she felt like she had to. I then said so he wasn't really forcing you he was just playing games with her and she said yeah like really demanding. He would say things like why don't I get pictures, like asking her. I then said he was asking not demanding but she said she felt like she didn't have a choice. I asked her where she was at when she send the pictures to him and she said here at her house in the bath room. I confirmed with [REDACTED] that JEFF HICKS wasn't here when that happened. I said so he's basically asking for pictures and asked her if she just felt obligated to send them and she said "yeah". I asked her if he ever threatened her or say he was going to kill her or beat her up or cause her some harm and she said "no". Detective TIPTON asked [REDACTED] what she thought would happen if she didn't send the pictures [REDACTED] said she didn't know but she saw him in class every day and felt it would be awkward. She said she was sometimes afraid to go to class and sometimes he would get mad and she felt weird to go to class so she just wouldn't go to school. She said she felt like she was scaring herself and she never knew what would happen. [REDACTED] said she ever think JEFF HICKS would try and hurt her.

Detective TIPTON asked [REDACTED] describe their relationship, if it was like boyfriend/girlfriend or flirty and she said flirty at first but she thought it was a joke or compliment. She said they were close but JEFF HICKS is close with a lot of students.

[REDACTED] said JEFF HICKS would flirt with her over Snapchat by saying things like you're so beautiful, you're so sexy or be mine and these comments may have been over things like just picture of her face. [REDACTED] said if she would not give him attention back he would, then she paused and said she forgot what she was going to say. She said she felt the flirting was one sided and she felt like she kind of had to, but they were close so she didn't think anything of it. She said she asked JEFF HICKS if he was serious and she never knew if he was serious. She said she wasn't sure if JEFF HICKS was serious about her being his but he would why would I say it if I wasn't serious. [REDACTED] said JEFF HICKS would also send her his address and said his doors unlocked and she could come over anytime. She said when he would flirt with her she would beat around the bush and asked how the relationship would even work. She said JEFF HICKS said they could "keep it low" until she turned 18 then make it public. [REDACTED] she never told JEFF HICKS that she did or didn't want to be in a relationship with him.

Detective TIPTON told [REDACTED] were would possibly be going to go through their phones and we were looking for the truth as to what had happened. She said what she was telling us was the and truth, she then said she honestly didn't want to get JEFF HICKS in trouble but she has no choice and she felt really in this situation. She said she felt obligated to give JEFF HICKS the attention and send him what he wants. She said he would say to send him pictures and she would but she would feel weird about it. She said she felt weird because he is 28 years old and she is 16 years old and she shouldn't be sending her teaching pictures of herself. She said at first their relationship wasn't weird and she started off by confiding in him about her parent's divorce.

[REDACTED] the night she went to his house she had dropped off her mother, [REDACTED] at an event and after dropping her off, JEFF HICKS asked her to just come by his house and she was like "okay". [REDACTED] for a couple of nights before that JEFF HICKS had been asking her to come by and even prior to that. She said he had asked her Friday night and she didn't go and used the excuse that her mom was awake. But since she was already out driving Saturday night she decided to go by. She said JEFF HICKS told her to park down the street from his house so people wouldn't see.

Detective TIPTON asked [REDACTED] if they ever talked about what would happen or what they would do if she ever went to his house like if they would hang out or make out. [REDACTED] said JEFF HICKS told her he wants everything from her but she didn't know what that meant, then she said he would ever say it, he just said I want you to be mine. [REDACTED] was asked if she thought that meant a relationship or sex or both and she said she thought both but she didn't expect it "to be so like, I don't know, why did you have to grab my hand". She then went on to say she felt like she had to.

I then asked [REDACTED] if there was going to be a picture of her bare breasts on either phone because JEFF HICKS had told the Officers that she sent him a picture like that. [REDACTED] said no, but there is a picture of her in the mirror and the mirror was all foggy, she was topless but you couldn't see anything. [REDACTED] that was the only picture like that. She said you can tell she is topless but you can't see anything.

[REDACTED] said she would be willing to testify in court if this case goes to court, she said she didn't want to testify but she would do it. [REDACTED] said she did tell more about the incident today than she did yesterday because she was embarrassed to say some things in front of her parents.

[REDACTED] said she believes that JEFF HICKS lives in his house alone and no one else lives there.

[REDACTED] said she didn't know how many pictures she had sent to JEFF HICKS but it was pretty much every day for like a month, but maybe only 15 days. She said she and JEFF HICKS were number one best friends on Snapchat, meaning they Snapchat'ed each other more than anyone else. She estimated it was about a week ago that she sent the foggy mirror picture of her topless to JEFF HICKS.

At this time [REDACTED] said about being in his room again going over some things she had already said. But mentioned that [REDACTED] rubbed her back and leg and tried to hold her hand while they were on his bed. She said while he tried to kiss her mouth he also tried to kiss her neck. She said at one point during this she told him she had to go pick up her Mom and he said, no you can stay a little longer and that's when he started thrusting on her. She again said he was pushing his penis against her vagina but through clothing while he told her she is sexy. [REDACTED] said she did not say no or doing anything to make him think it was okay but she was moving her head. She confirmed she didn't say no but she didn't kiss him back. She said she didn't try to push him off of her. [REDACTED] said JEFF HICKS knew she felt uncomfortable because he even said it. [REDACTED] said JEFF HICKS never touched her breasts under or over clothing and he never touched her vagina with his hand under or over clothing. She said the only part of JEFF HICKS that rubbed her vagina was his penis through clothing. [REDACTED] said she knew it was his penis rubbing her and not his hand because she's had sex before with a long term boyfriend she had for two years.
