Summary

On February 3, 2026, I Detective A. O'Keeffe P# 17767, was assigned to the Juvenile Sex Crimes unit with the Las Vegas Metropolitan Police Department (LVMPD) and was assigned a case for follow-up reference sex abuse against a child by a math teacher at Clifford J. Lawrence Middle School.

On February 3, 2026, I Detective O'Keeffe received a call from Las Vegas Metropolitan Police Department (LVMPD) Sexual Assault Section advising they had Rocky Newton on the phone. Rocky stated he was the father of 13-year-old [REDACTED] and wanted to report his daughter had been involved in a sexual relationship with her mathematics teacher, Brian Daniel Conway, DOB [REDACTED] at Clifford J. Lawrence Junior High School located at 4410 S. Julian Road, Las Vegas, NV 89147. Rocky reported last night he discovered sexually explicit text conversations between [REDACTED] and Brian on [REDACTED] cellphone. [REDACTED] and Brian communicated through Instagram, Signal and text messages. Rocky found pictures and videos of [REDACTED] naked and masturbating that had been sent to Brian. Additionally, Brian sent pictures and videos of himself naked masturbating to [REDACTED] while showing his face in the images/videos.

Rocky provided Brian's cellphone number that [REDACTED] had been using to communicate with as [REDACTED]. Through investigative measures, Brian's cellphone number was traced back to him. Additionally, Rocky provided an address for Brian, based on the information [REDACTED] Life360 application, which listed his address of [REDACTED], Las Vegas, NV 89147.

Rocky was sent a community request link to upload all pictures, videos and text messages on every platform. I reviewed the content Rocky uploaded, which included pictures and videos sent between Brian and [REDACTED]. The pictures and videos Brian had sent to [REDACTED] of his penis appeared to be taken in his apartment bathroom, Brian masturbating and selfies on his couch which appeared to be in his apartment. [REDACTED] had sent Brian pictures and videos of herself naked and masturbating.

Attempting to locate Brian Conway

On February 3rd, 2026, Detective D. Huffine PN#13545 and Detective G. Fitzgerald PN#16623 went to Clifford J. Lawrence Junior High School located at 4410 S. Julian Road, Las Vegas, NV 89147 to try to locate Brian, who was listed as a math teacher on their website. Upon their arrival, they contacted school Principal Allen Yee. Allen confirmed Brian Daniel Conway was a mathematics teacher at their school since August 2025; however, Brian was not at work today nor was he at school yesterday. Allen advised Brian's classroom was room "808" and directed detectives to his classroom. Additionally, Allen provided a home address of [REDACTED] Las Vegas, NV 89147 for Brian.

Live updates

As Detective Huffine and Detective Fitzgerald were at the school, Rocky was providing me live updates of active text messages between him and Brian, which were being monitored by Detective M. Alexander PN#17083. Rocky explained that Brian believed he was still talking to his daughter, [REDACTED]. In the text messages, Brian expressed his love for [REDACTED] and told her that he was "messed up" because she hadn't been responding to him.

Rocky communicated with me that Brian had put [REDACTED] on the tracking app, "Life360". Rocky said according to Life360, Brian was home at his address located at [REDACTED] Las Vegas, NV 89147.

Identifying Brian Daniel Conway

Brian Conway was verbally identified by Rocky Newton. Through investigative measures, Brian Conway was positively identified through his Idaho driver's license. Brian's driver's license picture matched Clifford J. Lawrence's website picture of Brian. Additionally, Brian's driver's license picture matched a selfie he had taken and sent to [REDACTED].

Wherefore, Declarant prays that a finding be made by a magistrate that probable cause exists to hold said person for preliminary hearing (if charges are a felony or gross misdemeanor) or for trial (if charges are misdemeanor).

Interview with Rocky Newton (Dad)

On Tuesday, February 3, 2026, Detective Huffine P#13545 conducted a recorded interview with Rocky Ray Newton, DOB: [REDACTED] Phone number [REDACTED] Address: [REDACTED] Westfield, IL 62474. The interview was conducted over the telephone, and the following is an overview of the interview, please refer to the transcription or audio recording for the full interview:

Rocky said he was the father of [REDACTED] and married to Faith Newton. They lived in Las Vegas, NV for approximately 9 months at [REDACTED] Las Vegas, NV 89147. The family moved to IL at the end of January 2026 due to economics. While they lived in Las Vegas, [REDACTED] attended Clifford Lawrence Middle School located at 4410 S Julian Street, Las Vegas, NV 89147. As a student at Lawrence MS, [REDACTED] had a math teacher by the name of Brian Daniel Conway. Rocky described Brian as a 47–50-year-old male, with a phone number of [REDACTED] and an address of [REDACTED] Las Vegas, NV 89147.

Rocky said that Faith is very proactive with [REDACTED] phone conversations. On February 2, 2026, Faith noticed that [REDACTED] was texting late at night. Faith snatched [REDACTED] phone, described as an Android S23, and went through it. Faith found conversations between [REDACTED] and an older male, in which they exchanged nude pictures of themselves. Rocky and Faith spoke to [REDACTED] and she disclosed that she had been in a relationship with Brian for a few months. [REDACTED] told Rocky that the relationship began slowly and progressed throughout the months. [REDACTED] said that Brian began by kissing her, then touched her breast and butt, then put his hands inside her pants and rubbed her vagina, and he made her touch his private part as well. Brian moved [REDACTED] desk next to his desk and other students questioned if Brian was her dad because of so much attention Brian was giving [REDACTED]. Rocky said he thought Brian was tutoring because he would make [REDACTED] stay after school. Rocky also wrote many late passes, excusing [REDACTED] tardiness to other classes. [REDACTED] told Rocky that Brian had given her a gold necklace, matching hoodie and they were “sexting” for months. [REDACTED] said that Brian and her track each other via the application “360.”

Rocky went through [REDACTED] cell phone and found text conversations between [REDACTED] and Brian, communication between them via Instagram and nude photos and videos of them via Signal. Rocky said [REDACTED] sent Brian explicit videos of her playing and fingering herself, and nude pictures. Brian sent [REDACTED] nude pictures of himself and videos of him ejaculating. Rocky found conversations where Brian told [REDACTED] he was going to get her from her new residence, take her to his place for a week so they could have all the sex they wanted. Brian also told [REDACTED] that he still had her bodily fluids on her desk, next to his, and he stared at it every day. Brian told [REDACTED] that he would kill her friend Geo and other boys that got near her.

Custody plan

On February 3, 2026, Detective A. Fox PN#16559 and SOAP detectives were tasked with locating and apprehending Brian Conway. Detective D. Nededog PN#14301 observed Brian exit his apartment [REDACTED]. Detective Nededog lost visual of Brian once he exited. Detective Fox then observed Brian sitting in the courtyard area wearing a black sweatshirt with “wolves” written on the front. Brian was taken into custody and transported to Southern Nevada Children’s Advocacy Center (SNCAC) located at 701 N. Pecos Road K2, Las Vegas, NV 89101.

Search Warrant

On February 3, 2026, I completed a search warrant for Brian Conway’s residence for all his digital devices, clothing, photographs of Brian’s residence to include interior and exterior, photographs of Brian to include nude photographs of his penis and hands, the Clifford J. Lawrence Junior High School.

The warrant was approved by Honorable Judge Ronald Israel on February 3, 2026, at 1619 hours. Search warrant # SW-26-00997

Wherefore, Declarant prays that a finding be made by a magistrate that probable cause exists to hold said person for preliminary hearing (if charges are a felony or gross misdemeanor) or for trial (if charges are misdemeanor).

I observed an error on Brian's DOB on page 2 of the application and affidavit for search warrant under premise from Brian Conway and the top of the search warrant on page 9; however, Brian's DOB was correct throughout the search warrant and probable cause statement. I spoke with DA Eckley Keach in regard to the error. I resubmitted a new warrant with Brian's correct DOB.

The warrant was approved by Honorable Judge Ronald Israel on February 3, 2026, at 1838 hours. Search warrant # SW-26-01016.

The following items were recovered during the serving of the search warrant.

Contact with Brian Daniel Conway

On February 3, 2026, Detective Huffine and I completed an audio and video recorded interview with Brian Conway. The following is a synopsis of the interview, not verbatim

I started the interview with building a rapport with Brian.

I then read Brian his advisement for custodial interrogation from my blue LVMPD 148 card at 1704 hours. Brian replied, "yes ma'am" to understanding his rights.

Brian told me he currently works at Clifford J. Lawrence middle school teaching 8th grade math. Brian said it's "different" teaching in Las Vegas because the idea of education doesn't value education. Brian described the children at Lawrence Middle School as "spoiled" because he was used to dealing with "rough" kids at his other schools. Brian said there are six periods that he works a day.

Brian said he taught in Pheonix, Arizona and in Idaho prior coming to Las Vegas.

I asked Brian if he knew a student by the name of [REDACTED]. Brian said he had a student named [REDACTED] and his assistant principal, Larry Medford, recently spoke to him (approximately 2 weeks ago) about [REDACTED]. Brian said the assistant principal just told him, "Be careful". Brian asked him why, but Larry said it was confidential but told him to "Just be careful". Brian said he does one on one tutoring and class. [REDACTED] would also come by the class to say hello to him and other children in the classroom.

I asked Brian if [REDACTED] ever confided in her. Brian said [REDACTED] told her about issues with her parents. I told Brian that I wanted to know more about his relationship with [REDACTED] because I knew there was more. Brian said, "Ok well I can see where this is going." Brian told me that I should know where he was coming from because he had already been warned by the assistant principal but now, he was in a police station. Brian stopped and told me that he thought he should have an attorney present before answering any more questions.

I then concluded the interview and informed Brian he was under arrest and would not be released.

Brian asked me what he was being arrested for. I informed Brian what he was being arrested for.

Marcum Notice

Brian was served with a notice of intent to seek indictment; however, Brian refused to sign.

Wherefore, Declarant prays that a finding be made by a magistrate that probable cause exists to hold said person for preliminary hearing (if charges are a felony or gross misdemeanor) or for trial (if charges are misdemeanor).

Conclusion

Brian was placed under arrest for the following.

Use/Permit Minor Less Than 14 to Produce Porn NRS 200.710.1 (1 count)- Brian did knowingly used, encouraged, enticed and permitted 13-year-old [REDACTED] to simulate or engage in sexual conduct to produce a performance by fingering herself while recording the act.

Lure Child with Computer for Sexual Acts NRS 201.560.4A (1 count)- Brian did knowingly contact and communicated with 13-year-old [REDACTED] intending to persuade, transport, or solicit the child away from her home to do sexual acts.

Possess visual pornographic of Person Less than 16 NRS 200.730 (1 count)- Brian did knowingly and willfully had in his possession for any purpose any film, photograph or other visual presentation depicting 13-year-old [REDACTED] as the subject of a sexual portrayal by [REDACTED] sending nude photographs and videos of her masturbating to him.

Brian was transported to CCDC where he was booked accordingly for the above charges.
