CRIMINAL COMPLAINT - ATTACHMENT

I base my belief on the following facts:

This affiant, Detective S. R. McKinley, of the Newport News Police Department, submits this affidavit in the support of the issuance of arrest warrants for As-Siddiq Abdul-Aziz, as there is probable cause to believe that on August 26, 2022, he committed offenses which violated Virginia State Code: 18.2-32, to wit, Second Degree Murder; and 18.2-53.1, to wit, Use of a Firearm During the Commission of a Felony.

On August 26, 2022, at approximately 1326 hours, Newport News Communications received a call in reference to a shooting in the parking lot of Food Lion located at 316 Oyster Point Road. The caller advised an altercation occurred in the parking lot between a black male and the victim. The caller also advised the black male shot once, exited his vehicle, and placed the gun on the ground. Officers located the victim suffering from at least one gunshot wound. Medics arrived on scene and at approximately 1335 hours, they pronounced the victim deceased. The victim was identified as Crystal Mittelstadter

The suspect, who was eventually identified as As-Siddiq Abdul-Aziz stayed on scene, placed his gun down on the ground and was detained by police at approximately 1332 hours. Mr. Abdul-Aziz was transported to Newport News Police Headquarters to be interviewed by detectives. Mr. Abdul-Aziz's girlfriend, was a witness to the shooting and willingly went to Newport News Police Headquarters to be interviewed. After speaking to numerous witnesses on scene, and watching a cellphone recording from stemmed from a road rage incident that began around City Center Boulevard and Warwick Boulevard.

During the cell phone recording, both Mr. Abdul-Aziz and the victim exchanged words back and forth before driving off. The victim is heard in the video saying, "You got a gun on me." Mr. Abdul-Aziz said he retrieved his firearm from his black bag that was in his glove compartment and held it against his chest. I asked Mr. Abdul-Aziz if the victim could see his firearm and Mr. Abdul-Aziz believed the victim could see his firearm based on the victim leaning toward the passenger seat. After Mr. Abdul-Aziz and the victim turned westbound on Oyster Point Road, Mr. Abdul-Aziz is heard on the cell phone recording saying, "it's cool, it's cool, he gone die. He gone die today, come on, as the victim is observed driving to the left of Mr. Abdul-Aziz's vehicle.

Both the victim and Mr. Abdul-Aziz drove into the Food Lion parking lot where the road rage incident continued. Camera footage showed Mr. Abdul-Aziz exiting his vehicle and running toward the victim's vehicle. Numerous witnesses, who stayed on scene to give statements, observed both Mr. Abdul-Aziz and the victim exit their vehicles and argue with each other. According to Mr. Abdul-Aziz, he exited his vehicle with his firearm in his right hand and kept it down to his right side. Witnesses did not observe the victim with a firearm. Mr. Abdul-Aziz believed he saw the victim with a firearm on his hip but the victim did not remove a firearm from his hip or waist and never pointed a firearm at him. A search of the victim's body and clothing was conducted and no firearm was located warrant of the victim's vehicle was obtained and executed and no firearm was located

within the vehicle during this search. Mr. Abdul-Aziz's firearm was recovered on scene as well as a cartridge casing from the inside of his vehicle.

Video footage showed Mr. Abdul-Aziz get back in his vehicle and park it in a parking spot. The victim drove to the passenger side of Mr. Abdul-Aziz's vehicle and a witness observed Mr. Abdul-Aziz lean toward the passenger window with his firearm and shoot the victim who died as a result of that gunshot wound.

The Commonwealths Attorney's Office was consulted and a determination was made to seek warrants charging As-Siddiq Abdul-Aziz with 2nd Degree Murder and Use of a Firearm in the Commission of a Felony.
