OBJECTION TO CANDIDACY REQUEST FOR EXPEDITED HEARING

NOW INTO COURT comes KEITH A. STUTES, in his capacity as the District Attorney of the 15th Judicial District, Parishes of Acadia, Lafayette, and Vermilion, hereinafter referred to as "the District Attorney", plaintiff herein, who with due respect avers as follows, to -wit:

1.

Qualifications for candidates for the office of Marshal of the City Court of the City of Lafayette, Louisiana, for the primary election of November 3, 2020, were duly opened on Wednesday July 22, 2020 and closed on Friday, July 24, 2020.

2.

On July 24, 2020, Brian L. Pope executed a Notice of Candidacy certifying that he will be a candidate in the Primary Election to be held on November 3, 2020, for the election to the office of City Marshal, City Court, City of Lafayette, and filed said Notice in the office of Clerk of Court, Parish of Lafayette, purporting to "qualify" as such as a candidate. Brian L. Pope is made a defendant herein.

3.

A registered and duly qualified voter of the City and Parish of Lafayette has presented evidence to the District Attorney, that defendant, Brian L. Pope, is NOT qualified to be a candidate for the office of Marshal of the City Court of the City of Lafayette, Louisiana, for the primary election of November 3, 2020, that said defendant does not meet the statutory and legal qualifications for said office, and that said evidence establishes grounds for objecting to such candidacy.

The District Attorney, in accordance with R.S. 18:491, elects to timely file this action objecting to the candidacy of the defendant pursuant to R.S. 18:495.

The office of the Marshal of the City Court of the City of Lafayette, Louisiana, is an elective office, serving a term of six years, elected at the congressional election, R.S. 13:1879. The qualifications of the Marshal of the City Court of the City of Lafayette, Louisiana, are that "the marshal shall be a resident **elector** of the territorial jurisdiction of the court", among others, R.S. 13:1880. "Elector" is defined as "a duly qualified voter", a person duly qualified to vote, regardless of whether he has exercised his right to vote or not, *Suarez v. Barney*, 903 So2d 555 (La. App. 4th Cir. 5/9/05), writ not considered 902 So2d 999 (La. 5/10/05).

Further, a person who meets the qualifications for the office of Marshal may become a candidate and be voted on in a primary election or general election if he qualifies as a candidate. However, the candidate "shall possess the qualifications for the office he seeks at the time he qualifies for that office", R.S. 18:451.

7.

The defendant does not meet the qualifications for the office of Marshal of the City Court of the City of Lafayette, R.S. 18:492, in that the defendant is NOT registered to vote, qualified to vote, and was NOT registered or qualified to vote at the time he "qualified" on July 24, 2020. When the defendant "qualified" on July 24, 2020, he certified that he was not a duly qualified elector in the territorial jurisdiction of the City Court of the City of Lafayette, Louisiana. (See Attached Exhibit "A")

WHEREFORE, PREMISES CONSIDERED, plaintiff, the District Attorney, prays that the defendant, Brian L. Pope, be served with this Objection to Candidacy, and ordered to appear on a day and time, in an expedited fashion as this is a time sensitive election matter to show cause why this objection should not be sustained, and a judgment rendered removing him as a candidate for the office of Marshal of the City Court of the City of Lafayette, and ordering that he

withdraw and/or be removed from the primary election of November 3, 2020 and that the defendant be cast with attorney fees and the costs of these proceedings pursuant to LSA-R.S. 18:495.
