NARRATIVE TEXT ENTRIES:

CASE SYNOPSIS: ARRESTEE #1- MENDOZA DEANDA, EDUARDO

Added by [REDACTED] on June 16 2026 at 09:13

On Tuesday, 6/16/2026, I, Trooper [REDACTED] with the Texas Department of Public Safety (DPS), Highway Patrol Division, was working on a joint operation with Immigration and Customs (ICE) in Waco, Texas. Agents with ICE observed the suspect, Eduardo Mendoza-Deanda, DOB: [REDACTED] exit his residents at [REDACTED] and enter a silver Ram 1500 bearing [REDACTED]. Mendoza-Deanda entered onto [REDACTED] and passed my fully marked Texas Highway Patrol unit. At that time I observed that the pickup had illegal front window tint, later confirmed to be 17%. Once behind the pickup on [REDACTED] Mendoza-Deanda began to rapidly increase his speed, pulling away from me. Once my emergency lights activated, Mendoza-Deanda continued to briefly evade persons he knew to be law enforcement with his vehicle as he traveled westbound on [REDACTED]. Mendoza-Deanda then abruptly drove into a residential front lawn and continued to evade from me on foot. Mendoza-Deanda then entered the backdoor of [REDACTED] and began to run inside of the residents before entering a guest bathroom and shutting the door. After a few minutes of giving verbal commands to exit, Mendoza-Deanda surrendered himself to Law Enforcement and was taken into custody without further incident. After Mendoza-Deanda was advised of his rights, to which he acknowledged he understood, Mendoza-Deanda admitted to me that he knew I was attempting to pull him over for a traffic stop and that he continued to flee. Mendoza-Deanda also admitted he entered the house to evade me. Mendoza-Deanda was transported to the McLennan County Jail for Felony Evading Arrest/ Detention with a Vehicle [REDACTED].
