REPORT NO. I21167312

OFFENSE REPORT

ON 12/2/2021 AT APPROXIMATELY 1337 HOURS, I RESPONDED TO THE AREA OF 75TH AVENUE AND GLENDALE FOR A HIT AND RUN COLLISION THAT HAD JUST OCCURRED.

WHILE ENROUTE, COMMENTS ON THE CALL WERE UPDATED AND STATED THE PERSON REPORTING (A BLACK MALE SUBJECT LATER IDENTIFIED AS [Victim] [Victim]) FOLLOWED THE SUSPECT VEHICLE (A MAROON IN COLOR MERCURY GRAND MARQUIS BEARING AZ LICENSE PLATE [Address]) TO [Address]

UPON MY ARRIVAL I MADE CONTACT WITH [Victim] WHO ADVISED ME OF THE FOLLOWING:

HE WAS HEADED WESTBOUND ON W GLENDALE AVENUE IN LANE #1 WHEN HE WAS REAR ENDED BY THE VEHICLE DESCRIBED ABOVE. HE OBSERVED THE DRIVER OF THE VEHICLE PUT HIS FINGER UP TO LIPS AS TO MOTION TO HIM TO "BE QUIET". THE DRIVER THEN LEFT THE AREA. [Victim] FOLLOWED THE VEHICLE AND WAITED OUTSIDE FOR POLICE TO ARRIVE. WHEN ASKED [Victim] STATED HE DESIRES PROSECUTION FOR HIT AND RUN.

I RAN THE LICENSE PLATE OF THE VEHICLE WHICH CAME BACK TO THE [Address] ADDRESS. THE REGISTERED OWNER OF THE VEHICLE WAS A MALE SUBJECT IDENTIFIED AS JESSE MAYA. I WENT TO UNIT# [REDACTED] AND MADE CONTACT WITH JESSE.

WHEN ASKED WHAT HAPPENED TODAY, JESSE STATED "MY BAD, I BUMPED HIM". I ASKED JESSE IF HE COULD GET HIS INSURANCE INFORMATION AND DRIVER'S LICENSE. HE STATED HE WOULD AND THEN WALKED TO THE REAR FAMILY ROOM OF THE RESIDENCE. WHILE DOING SO HE SEEMED TO LOSE HIS BALANCE. WHEN I ASKED HIM IF HE NEEDED THE FIRE DEPARTMENT HE STATED "YES, I'M DRUNK". WHEN ASKED TO CLARIFY, JESSE STATED HE HAD BEEN DRINKING TODAY AND DENIED NEEDING THE FIRE DEPARTMENT.

I READ JESSE HIS MIRANDA WARNINGS VERBATIM FROM MY STANDARD ISSUED MIRANDA WARNING CARD AT APPROXIMATELY 1425. WHEN ASKED IF HE UNDERSTOOD HIS RIGHTS, JESSE STATED "YES". WHEN ASKED IF HE WAS DRIVING TODAY JESSE STATED "YES". WHEN I ASKED IF HE WAS DRIVING THE MAROON GRAND MARQUIS REGISTERED TO HIM, HE STATED "YES". HE STATED HE WAS DRINKING ALCOHOL AT A LOCAL RESTAURANT BEFORE DRIVING HOME. HE STATED HE WAS ON 75TH AVENUE AND GLENDALE WHEN HE RAN INTO THE BACK OF [Victim] IS VEHICLE. HE STATED "I'M GUILTY", AND ADVISED HE DOES NOT CURRENTLY HAVE A VALID DRIVER'S LICENSE.

A CHECK OF JESSE'S DRIVING RECORD, SHOWS HIS DRIVING PRIVILEGE TO BE CURRENTLY [REDACTED] [Criminal History Database]. JESSE WAS CITED IN LIEU OF DETENTION FOR HIT AND RUN AND DRIVING ON A

SUSPENDED LICENSE (CITATION # C21015310). HE WAS EXPLAINED HIS COURT DATE, THE LOCATION OF THE COURT. HE SIGNED THE CITATION ACKNOWLEDGING RECEIPT OF THE CITATION AND AFFIXED HIS RIGHT INDEX FINGERPRINT TO THE CITATION WHERE REQUIRED.

JESSE WAS PROVIDED WITH A COPY OF THE CITATION. AN INSPECTION OF THE VEHICLE'S INVOLVED IN THE INCIDENT DID NOT SHOW ANY OBVIOUS SIGNS OF DAMAGE. SINCE DAMAGES WERE UNDER THE \$1,000 DOLLAR LIMIT, A COLLISION REPORT WAS NOT COMPLETED. JAMES WAS PROVIDED WITH A VICTIM'S RIGHTS PACKET AND PROVIDED WITH JESSE'S INSURANCE INFORMATION.

DUE TO THE TIMEFRAME SINCE THE CALL FOR SERVICE ORIGINATED, AND JESSE LEAVING THE VEHICLE, HE WAS NOT INVESTIGATED FOR DRIVING UNDER THE INFLUENCE.

MY GLENDALE POLICE DEPARTMENT ISSUED BODY WORN CAMERA WAS UTILIZED DURING THIS EVENT. THIS CONCLUDES MY INVOLVEMENT IN THIS MATTER.
