I have been a New York State Trooper for more than 31 years and am currently assigned to Troop T, SP Buffalo. During my career I have been involved in the arrest of hundreds of criminals ranging from cruelty to animals to murderers.

I met Dr. Gosy through a mutual friend, Dr. David Pochatko, about 20 years ago. Over the past two decades we have watched many ball games. We have shared birthday parties, graduations, and many special events. We have become very good friends.

In 2012 I was carrying a heavy bag strapped across my shoulders and injured my neck. The pain in my neck was awful. I was unable to work. I saw my personal physician, physical therapists, and a neurosurgeon. No one could provide any relief of the pain. Then I saw Dr. Gosy. He scheduled me for a procedure whereby he injected medicine into my neck. A moment before the procedure Dr. Gosy whispered in my ear, "Don't worry. I will treat you like you were my mother." The kindness of his words was like a breath of fresh air. I immediately felt at ease. Shortly after the procedure and additional therapy I made a full recovery.

I have dealt with criminals my entire adult life. Dr. Gosy is not one of them. Dr. Gosy is without a doubt the kindest most sincere man I have ever met. Mistakes may have been made. I am not privy to any of that. However. I can say with certainty that Dr. Gosy does not possess any criminal intent. Your Honor:

This letter is being written on behalf of Dr. Eugene Gosy.

I recognize the fact that Dr. Gosy has pleaded guilty to the serious charges of Conspiracy to Distribute Prescriptions for Controlled Substance Medications Not for Legitimate Medical Purpose, as well as Health Care Fraud.

I was a long-term patient of Dr. Gosy, and have a great respect for the law as my daughter recently passed the NY Bar Exam and is awaiting her admission ceremony in June.

In no way do I seek to exculpate Dr. Gosy's admitted criminal conduct, but as a friend, citizen and taxpayer wonder what the results of a trial would have been, had Dr. Gosy the means to mount an adversarial trial defense against the limitless resources of Federal prosecutors.

At the same time, I recognize that a guilty plea is regarded in the same light as a conviction by bench or jury.

I first became a patient of Dr. Gosy roughly 20 years ago, upon the ardent recommendation of a physician I was dating at the time, who informed me that Dr. Gosy was the "go-to" medical doctor in the area for chronic pain and an excellent neurological expert.

Due to an auto accident on August 31, 1989 in which I was rear-ended while stopped at a light, three vertebrae were fractured and every day since then have experienced chronic pain and all that comes with it.

The compassionate care of Dr. Gosy, which involved regular physical examinations, trigger-point injections and prescriptions, significantly helped me to continue my life and career.

I never knew him or his office to simply throw out drugs willy-nilly, and on an occasion where I was going to be out of the country during a refill, his office made me show my itinerary and receipt for the trip

before partially filling a prescription for narcotics before I traveled.

Furthermore, past his pain-management expertise, approximately in 2010 I developed symptoms of a brain tumor which caused extreme headaches, auditory and perceptual issues and caused great alarm.

Dr. Gosy immediately diagnosed me as having a very rare condition known as pseudo-tumor cerebri, which is caused by an excess of cerebrospinal fluid which causes the brain to experience increased cranial pressure.

His rapid diagnosis was amazing because this disease is most typically found in obese females of child-bearing age, and his recognizing a situation in a male of my age, which deviated from the norm, so quickly, was quite a feat, and Dr. Gosy quickly performed a lumbar puncture and drained the excess fluid, thus likely saving me from severe complications, including optic nerve damage which may have left me blind.

I enjoy excellent and personal relations with many doctors in Western New York, as well as the CEO's of the major health care agencies here, and prior to his current difficulties Dr. Gosy was highly regarded.

Furthermore, many physicians off the record have told me that they have been afraid to speak up on his behalf, due to fear of repercussions by zealous prosecutors, the DEA and licensing boards.

In addition, many of these doctors no longer prescribe needed medicines for chronic pain patients, for fear of sending up red flags with the authorities.

This concern started long ago, actually, which is precisely why Dr. Gosy wrote so many prescriptions: FEW PHYSICIANS WANTED TO DO SO and sent their patients to Dr. Gosy for comprehensive pain management.

My urologist writes thousands of scripts for Viagra.

My cardiologist does the same for blood pressure and cholesterol meds.

Logically, a doctor who handles chronic pain patients would be expected to write a lot of scripts for pain medications because that was his specialty and Dr. Gosy was referred these patients by numerous physicians.

Therefore, some of the early hyperbolic claims about Dr. Gosy being some kind of Pablo Escobar drug dealer were unfair and not based on the reality of his practice.

Would we say that Hospice is a "drug dealer" for its generous use of end-of-life care morphine?

Some common sense is called for in this case.

I am afraid there has been a specious conflation made between the "opiate epidemic" and the "heroin epidemic."

They are two separate issues, and according to the Erie County officials with whom I communicate, the people who track overdoses, our tragic drug deaths typically involve heroin (and now cocaine) laced with Chinese fentanyl, and not FDA-approved prescriptions such as those prescribed by Dr. Gosy.

This heroin epidemic has touched me personally, as a friend's son died tragically of a heroin overdose and his dealers have been charged by J.P. Kennedy and the US Attorney for Western New York's office, as well they should.

Tragically, the charges against Dr. Gosy and the shadow of fear of investigation over duly licensed physicians who formerly prescribed needed narcotic medications approved by the FDA as "safe and effective" has resulted in cases of respectable "soccer moms" and professionals turning to heroin and other dangerous and unregulated substances for relief from legitimate chronic pain.

This, in part, was an unintended consequence of the arrest and undue demonization of Dr. Gosy.

Your honor, in the interests of justice I respectfully ask you to bifurcate between the reality of the charges to which Dr. Gosy has pleaded guilty, and the false narrative painted after his arrest which wrongly made him the "face" of the opiate epidemic.

In the interests of justice, please do not unfairly scapegoat or make Dr. Gosy the "poster child" for the "opiate" epidemic as an "example."

As a taxpayer and citizen, I respectfully implore you to show Dr. Gosy all of the mercy and leniency you would show any first-time offender with such a record of service to his fellow man.

Dr. Gosy is a man I would welcome to stay in my home, not some violent predator.

The price Dr. Gosy has already paid for the crimes to which he has pleaded guilty is significant, and I respectfully ask Your Honor to not further compound this man's suffering by unduly depriving him of the last thing he has: his freedom.

I am aware that Dr. Gosy plead guilty to conspiracy to distribute prescriptions for controlled substance Medications not for legitimate medical purpose, as well as health care fraud.

My name is Russel Bower and I have been a patient of Dr. Gosy for over 20 years. I was born in Batavia on January 20th 1964. I have lived my entire life in Akron New York. I went to Akron Central School and graduated in 1982. I was on the wrestling team for 3 years, winning all league at 119 pounds my junior year. I played varsity baseball 3 years, I ran cross country 1 year and played golf 2 years. I was on the honor society and was treasurer my senior year.

My senior year of high school, on Halloween of 1981, I was involved in a one car accident. The driver lost control and we rolled towards the right side of the vehicle. I was nearest to the passenger door, with the window down and no seat belt on. As the car rolled, I was half in the car and half out of the car. The pressure of the car rolling in my direction, snapped my body into 2 pieces. I suffered severe trauma to my back. I had dislocation of my spine at thoracic vertebra 10 and 11 and had compression fracture at thoracic 6 which is my level of sensation, which is at the bottom of my chest muscles. My left lung had collapsed. I was rushed to Milliard Fillmore Suburban where they did a pneumothorax. This is where they insert a tube between your ribs and thrust it into the collapsed lung to reinflate it and help it to heal. The following Thursday they did the surgery to put my spine back together. They inserted steel rods, wires and bone from my pelvis for fusion. The remainder of my life would be spent in a wheelchair. Since than I have had 9 surgeries. I have suffered 2 stage 4 bed sores on my right buttocks. The 1st my freshman year at UB. The 2nd 30 years later. The 2nd one I spent over 2 years of bed rest, lying on my side or stomach the entire time. I was only allowed to get out of bed for 3 hours a month. After all that time, the wound refused to heal. I ended up having flap surgery and spent 9 weeks at Niagara Falls Medical Center. So you can see my life has been a challenge to say the least.

I graduated from the University of Buffalo in 1987. I received a B.S. degree in Communication with an emphasis on Marketing and Advertising. I took my first job at Goldome in 1988. I have worked in retail and mortgage banking for over 25 years. When I suffered my 2nd bed sore in 2013, it left me in a position where the Dr. only wants me to sit no longer than 6 hours at a time. I am now living on Social Security Disability and a small Long Term Disability from HSBC.

In 2007 I built my dream home with my entire life savings. I found out my fiancé was having an affair with my next door neighbor who was my best friend. I had sold him the house he was living in. After she moved out is when I developed my 2nd bed sore. I had no choice but to sell the house as I could not afford it now being on disability. The house sold while I was recovering in the hospital. As I could not afford the debt load I had built up trying to save the house from going into foreclosure I had no choice but to file bankruptcy in 2017. The Akron ambulance brought me home from the hospital and I now live with my mother and father, Shirley and Rodney Bower.

So as you can see your honor my life has been a roller coaster of highs and lows. Around 1997 or 1998 I started to develop severe pain sensations in my chest and in my legs. It felt like my feet were sitting in boiling water or being on fire. None of this made sense as I have no feeling from my chest down. In the summer of 1998 I went to the emergency room 5 times. Every time I was in the emergency room they were not able to come up with a diagnosis as to where these pain sensations were coming from. Each time I was discharged from the hospital I wasn't given any help with my pain. My pain became so severe that I was thinking about taking my own life. I told my primary physician Dr. Rajendran that if I didn't get help soon I would not be alive much longer. She referred me to a pain specialist whose name was Dr. Gosy.

The 1st time I met Dr. Gosy he walked into the exam room and I had tears rolling down both my cheeks. He than asked me what was wrong and I explained to him the pain I was going thru. Dr. Gosy immediately responded that he knew where my pain was coming from and that he wanted me to go have a thoracic MRI completed on my entire spine. He wanted to see what was going on. When I was in my car accident, I had broken my back so severely that the trauma to my spinal cord basically had killed the spinal cord. It no longer had blood flowing to the damaged area. The body over time had removed the spinal cord as it deteriorated. So now the area where the spinal cord use to be had filled with fluid. The pressure of this fluid was effecting my nerves and those nerves where sending messages to my brain in the form of pain. This pain is referred to as neurogenic pain. So there it was, Dr. Gosy had found where my pain was coming from in a matter of seconds, where all the other Dr.s had no clue on how to help me, except Dr. Rajendran providing me with the referral to go see Dr. Gosy. Unfortunately there is no medical procedures that can remedy this pain. The way to help me with my pain was to put me on a prescription of Neurontin which is referred to as Gabapentin. This medication gave me immediate relief. It did not get rid of my pain completely, but it did enough to put my pain in my subconscious so I could lead a some what normal life. Over the last 20 years of seeing Dr. Gosy my pain has steadily gotten worse. We have gone thru many stages of making changes to my dosages and what medication would be best to help me live from day to day. We have had many conversations, we have debated, we have had heightened discussions, but in the end I have always felt that Dr. Gosy has had my best interest at hand.

Dr. Gosy is not only my pain Dr., but he is my friend. I have always trusted his diagnosis and I have always followed his instructions to the letter.

I have watched Dr. Gosy's office grow from a small practice with one maybe two patients in his waiting room. To a waiting room with as many as 25 to 30 patients waiting to be seen. There was as many as 20 to 30 employees working on the various office tasks behind the glass, along with 8 to 12 Dr.'s and practitioners helping patients. I was fortunate to be 1 of Dr. Gosy's early patients and have always had the pleasure to see him for each appointment.

Dr. Gosy came to our country with a suitcase and \$200. In his pocket. He became a licensed Dr. thru hard work and determination. He started with a small practice and built it into one of the largest pain management facilities on our planet. He was married and has 2 daughters who have his work ethic. I truly believe that his dedication to his practice cost him his marriage.

When I heard on the news that the FBI and I believe the DEA had raided his practice it made me sick to my stomach. When I heard the charges I did not believe that they were going to find any wrong doing and I have always felt this was nothing more than a witch hunt.

What I don't understand is if someone is under suspicion of a crime that they are to stop whatever it is they are doing until the investigation has been completed, yet they let Dr. Gosy continue to see patients right along, that makes no sense to me?

The media right along has portrayed Dr. Gosy as this horrible monster who kills people thru the use of opiates and other pain medications. I feel the media has been so unfair that it reminds me of the scarlet letter. Something he has to carry with him the rest of his life. This man is no monster. This is a man that grew a practice very quickly because all the other Dr.'s in western New York were referring their patients to him as he was doing what a Dr. is suppose to do. You visit with the patient, you diagnose what is wrong and you help the patient with whatever means you have available to you as a licensed Dr.

Whats very important to remember when considering what punishment you are going to give to Dr. Gosy, is how he handled every patient that ever came to see him. How that patient was treated and was that treatment detrimental to that patient in any way. I know that when I came to see him, he listened to what was going on with me, he formulated a course of action, than he implemented it. I felt he went thru the proper stages for every patient he ever saw. He expected his employees to follow that exact plan of attack so that each patient received the very best care possible. Many times I sat in the waiting room and I watched the pain the other people were going thru who were waiting to be seen. The grimaces, the way they moves their hands. Those who were having difficulty walking, because of their back, or their hips or various parts of their legs. Either thru injury, genetics or degeneration thru time. I use to think, my god, what Dr. would ever want to deal with this day after day. I would take a very special person, with fortitude and a demeanor so strong that they could sleep at night. Someone who knows that now and than they are going to lose a patient for various reasons and be able to handle it.

Speaking of losing patients. I know that Dr. Gosy had no other choice of taking a plea bargain because of losing patients. This is the one thing that pisses me off more than any other. We are talking about nothing more than conduct. Conduct means, "the manner in which a person behaves, especially on a particular occasion or in a particular context". They had Dr. Gosy bent over a barrel due to the conduct of a super small sample of the way that sample of patients conducted themselves. I believe that 6 patients of Dr. Gosy's tens of thousands of patients found a way to kill themselves by overdose. Now if Dr. Gosy rolled the dice and took the chance of taking his case to trial and if they find him libel of 1 of those 6 he could be sentenced to life in prison. So all it would take is one juror who had a grudge for any hidden reason, or one juror who knew they were going to find him guilty before it even started, Dr. Gosy would be subject to stiff confinement. So how on God's green earth can he take that chance. He couldn't, nobody could because of the way our judicial system works. Going back to conduct. I know that each and every one of those patients that died under Dr. Gosy's watch did not conduct themselves in the manner they told Dr. Gosy they would when he was putting together a plan of action to help those individuals with their pain. Every one of them lied and did not stick to taking the medications prescribed to them in the manner it was prescribed. Each one of them when looking at the toxicology report that was provided after a thorough autopsy showed that they were taking recreational drugs on top of the prescribed medications. So they did not conduct themselves in the manner they told Dr. Gosy that they would. This is not Dr. Gosy's fault. But that doesn't stop the families of the individuals from pointing fingers and wanting someone to be libel for their family members behavior and conduct. They say that Dr. Gosy should have known they have a history of drug abuse. Well that is why Dr. Gosy did random drug testing of all his patients that were prescribed to controlled substances such as myself.

When Dr. Gosy was basically forced out of the practice that he had built over years of hard work he was allowed to take a job at Invision, of which I and many of his patients followed him to this new location.

This is when the Western New York task force was put into place. A task force which was created to come up with ideas how to cope with the national opiate crisis. A task force that did not have one pain management Dr.'s as part of the group. Where I feel the entire task force should have been made up of pain Dr.'s as they were the ones dealing with the patients that were on the opiates. So when the task force was put into place they instructed the Dr.'s who were prescribing opiates to their patients to reduce the amount they were prescribing. So how was I awarded for taking every prescribed pill as instructed over the last twenty years, I was awarded by having my methadone reduced by 25%. I had done nothing wrong, did they ever consider how this was going to affect someone with such acute pain that they were lucky if they slept 2 hours a night. So after this happened, every appointment seeing Dr. Gosy every 3 months was an absolute struggle. I cried every appointment because of what I was dealing with. Dr. Gosy knew that I should not have my script reduced, but his hands were tied by a group of people that never considered how their instructions were going to affect those that had done nothing wrong. So I turned to marijuana of which I had not smoked since 1988. I had no choice but to try and find something to make up for the 25% reduction in my pain management. I told Dr. Gosy when he told me that I needed to take a urine test that I Had smoked marijuana because of the pain I was in. He told me that I had a choice, either one or the other not both or he was going to cut my methadone by another 25%.

So at this point I saw the writing on the wall and I knew if things were going to continue in this fashion I needed to make a change as my quality of life was in the toilet. I expressed to my mother what I was going thru on a daily basis and all she could say is I wish I could help you.

I than wrote a letter to Dr. Laszlo Mechtler who is in charge of the cannabis clinic at Dent Neurology. I explained to him everything I was going thru, how they had turned Dr. Gosy into a pawn and where he no longer could help his patients like he use to. Dr. Mechtler was kind enough to take me under his wing. I now see Dr. Henry at Dent who has increased my methadone back up to the level that helps me with my pain and I also have the option of using medical marijuana if I choose to based on where my pain level is on every given day.

Your honor, I beg of you to show leniency when considering punishing Dr. Gosy. Thru hard work and determination he built a clinic that would help people living in pain by the tens of thousands. Patients who other Dr.'s referred to Dr. Gosy because they didn't have the balls to help their patients like they said they would when they took their oath to become a Dr. Whoever was in charge of this investigation really thought they were accomplishing something by hanging Dr. Gosy out to dry by their utilization of the media. If they really thought he was guilty of a crime or crimes, why did they allow him to keep practicing after they initially raided his office. How could they take his 2 best cars, before finding him guilty, put them in storage and than auction them off and giving the majority of the sale proceeds back to Dr. Gosy. Than they make Dr. Gosy pay an exorbitant storage bill over \$12,000. I never heard of anything so half ass backwards in my life. What purpose did that prove. If it wasn't for those who overdosed at their own hand there would be no case.

I feel Dr. Gosy has suffered enough. He has been punished over and over again by showing his face in the paper on TV and on the internet. They have made him out to be a monster when he is anything but. While those individuals in the FBI and DEA were high fiving each other that they had Dr. Gosy backed into a corner and at the suggestion of his council felt the plea bargain was the best way to go. To get him to admit any level of guilt is absurd. They had everyone believing that he did what he did out of greed when he was already wealthy thru hard work. Did the FBI or whatever levels of power think for a second what was going to happen to the thousands of people who live very hard lives because of the hand god

dealt them when they needed to find another Dr.'s office for pain management. When all those Dr.'s offices are scared to death to prescribe an opiate or any form of a prescription to help someone in pain. That they would be the next office put under a microscope. I often wonder, what if it was one of the prosecutors who was in pain, or if it was one of their family members that was in a situation that they needed help. What if I was their son and they knew what I have had to live with since that day back on Halloween in 81 when I was senior in high school and 17. That I would be in a wheelchair for the rest of my life where I am now 56 and scared to death on what the rest of my life will be like because of those who have a problem with people that work hard and succeed in life.

I really feel your honor that if you give Dr. Gosy anything more than an ankle bracelet for a year is a tragedy. He is a good man and he hasn't deserved to go thru what he has been thru aiready. I ask you, because I am on 20 milligrams of methadone 3 times a day and 800 milligrams of gabapentin 3 times a day and my pain level is still between 3 and 9 out of ten everyday of my life 24/7. If you were ,e and you don't have someone like Dr. Gosy or Dr. Mechtler or Dr. Henry what would I do. I would have no choice but to end my life. Probably just like the 6 people that overdosed. There is no doubt in my mind that each of them had reached that point of no return. In no way is that Dr. Gosy's fault. He did all he could to help the. Some people just cant be help.

I ask you for LENIENCY. He derserves it for the thousands of people that he improved their quality of life. He saved my life and I love him for helping me. For being a top notch physician and a better friend.

Dear Sir:

I am writing on behalf of Dr. Eugene Gosy. I am aware that he has plead guilty to Conspiracy to Distribute Prescriptions for Controlled Substance Medications Not for Legitimate Medical Purpose, as well as Health Care Fraud.

I am a 67 year old wife, mother, grandmother, and retired educator with a Master's Degree in Nursery, Elementary Education and Special Education. (*Terminology per 1979*) During my twenty plus years as an educator in private education, my responsibilities varied. I was a director of a preschool and then taught Kindergarten, first grade and Resource K-12 at Christian Central Academy in Williamsville. I was also the cheerleading coach for the high school girls for 2 years and director of the K-8 Elementary Musical one year. For a few years I taught Vacation Bible School (VBS) at the Chapel and directed the VBS Kindergarten Department. My husband and I participated in the Choir at The Chapel and all the special musical events for ten plus years as well. The last half of my teaching career was spent in Administration as the Admissions Director for Christian Central Academy (CCA) and then as the Assistant to the Head of School. Add the various demanding jobs of a mother of two children, now adults with children of their own, and I can say I had a very active, full life that was tempered with living with chronic pain issues and necessitated an early retirement at age 49.

Given all the attention the opioid crisis has been getting in the media, I sometimes feel that the public thinks the people using opioids just cannot handle a little pain in their lives and we all just want a quick fix. *Take opioids and you will feel great!* On the contrary, my personal experience and that of most of Dr. Gosy's patients that I talked with while sitting in his waiting room, have been dealing with pain for a long time, have seen other medical professionals, and tried many things before even seeing Dr. Gosy. Most people do not realize, or they choose to forget, that Dr. Gosy is a brilliant neurologist, first. He is very diligent in seeking to confirm a patient's diagnosis is correct or he strives to find the correct medical issue responsible for one's pain. Being knowledgeable to treat the pain is Dr. Gosy's second medical degree, a degree not all neurologists choose to hold. A fact which became very obvious to us as we looked for a new pain specialist while trying to develop a Plan B the last few years.

My medical overview follows, as concise as I can make it, and portrays why my husband and I sought Dr. Gosy's help. I trust it also reveals what an excellent physician Dr. Gosy is.

In May 1984, I gave birth to a 9 lb.-11 oz. baby boy and ruptured two lumbar discs in the process. Treatment was a chymopapain injection to dissolve the ruptured discs. In July, I was still in excruciating pain. I had exploratory surgery where the doctor found my lumbar discs had dissolved but a piece of my lumbar disc was still imbedded

in my spine, outside of the reach of the chymopapain injection. This trauma to my spine would be the start of my spinal problems and continue as I aged.

I found that common sense became the rule of thumb. If something caused me pain, I stopped it. No more snow & water skiing. No bowling. I had to take more care in what I lifted and how I lifted it, including my baby boy!

As my children became school and preschool age, I went back to work at the preschool level. After a few years, the demands of preschool were putting too much pressure on my back. In 1991, I left preschool to become the Admissions Director at CCA.

In 1997, I developed burning pain and tingling in my arms and legs. Everyday tasks got harder and harder to do such as shampooing my hair, using a blow dyer, vacuuming, using a computer mouse. An MRI of my neck had my primary physician referring me to a neurosurgeon. I had direct compression on my cervical spine. Eventually I would lose the use of my limbs (arms & legs) unless I had corrective surgery. So, in October 1997 I had two cervical discectomies with fusions at the C4/5 C5/6 levels. The main pain was relieved by the surgery but now my lumbar and my cervical spine had reduced movement. Scar tissue was irritating my spine. Spinal stenosis (the narrowing of the spinal cord) and spondylosis (arthritis spurred by wear and tear to the spine when discs and joints degenerate) set in.

In April 2002, my primary doctor referred me to a neurologist when my daily pain issues progressed to my experiencing full body burning, more muscle tightness, fatigue, and muscle cramping in my thighs & calves. He started me on muscle relaxers. A Brain MRI showed legions and large ventricles. I was then referred to a Multiple Sclerosis specialist. I was under her care from 2002 through 2004 with a one year follow up in November 2005.

To hopefully help with my ongoing pain and lack of flexibility, the MS specialist referred me to a physiatrist (*Dr. Michael Geraci, Jr.*—possible relative?) in March 2003. He worked in conjunction with a master degreed physical therapist (MSPT), who was also an Orthopedic Clinical Specialist (OCS). They worked together to design a physical therapy program for me. Fibromyalgia was then added to my growing list of diagnoses. A year and a half later, it was determined that my physical progress had plateaued and my pain level was not lessening. These medical professionals then suggested I see "the best pain specialist" and neurologist in the Buffalo area, Dr. Gosy.

September 2004, I had my first consultation with Dr. Gosy. After reviewing my medical file (reports from doctors, therapists, x-rays, MRI's, medicine's, etc.), giving me a neurologic evaluation, and talking with my husband and myself, Dr. Gosy wanted to do some additional tests to rule out other causes for my condition. In addition, he realized I was in much pain and had been for some time. We discussed trying to teak my medications to bring me more relief without hampering my ability to function. I was willing to try anything he could suggest. I was so tired of being in pain.

I then saw various providers in Dr. Gosy's practice through the years. I tried anti-inflammatories, muscle relaxers and medicines to help lessen nerve pain. As it became necessary, we discussed the use of opioids, the benefits and the risks. I always started a new pain medicine in low doses, only increasing if deemed medically prudent. Great caution was always taken when starting a new medication. One had to be sure he/she was not experiencing side effects and determine the effectiveness of the medication. Random drug testing also helped to insure one was using the medication properly.

The opioids helped to lessen the pain and I am forever grateful to Dr. Gosy for his vast knowledge, medical expertise, and compassion for his patients. He does not promise a pill as the answer.

Dr. Gosy referred me for water therapy in 2005, trying to find some form of exercise that would not cause pain but, to no avail. Even walking stimulates my pain centers. I tried using a back brace and a TENS/IF unit prescribed by Dr. Gosy, to help bring relief. We even purchased an air bed, at the suggestion of his staff, when I mentioned we needed a new mattress.

I have had trigger point injections, lumbar epidurals, lumbar facet blocks on multiple levels and both sides of my spine for years. When combined with my medications I would get more long lasting relief but for a limited time. Without the injections, there were times I could hardly walk or get out of a chair.

In July 2014. I herniated my L3/4 disc. At Dr. Gosy's urging, I tried PT again from September through December 2014. A year later, my L5/S1 was degrading and I tried PT with the same response.

2016 was a nightmare for Dr. Gosy's patients. My May 5th appointment was canceled by the doctor's office. July 7th was the soonest it could be re-scheduled. Then on June 30th, after 12 years as a patient, I was told I could no longer be a patient of the practice! Dr. Gosy was in the middle of a consultation with my primary physician and a hematologist over blood test results. Now, I had to drop everything and find a pain specialist that would take me on as a new patient, immediately, so I could get my methadone script and not go through withdrawal. In addition, The hematologist called and wanted an appointment because I now had cancer!

On July 5, I went to the hospital to have a medical port put in so I could start cancer treatments on July 6. Right after getting the port, my husband and I stopped by Dr. Gosy's office to see if there was any way I could stay on as a patient, at least until I was finished with my first round of treatment. Dr. Gosy, whom at that point had plenty on his mind and plate, agreed to take me on, personally, as a patient. I am forever grateful that he cares so deeply for his patients and their needs.

While the cancer did account for some of the symptoms I had been experiencing, Dr. Gosy still was testing to find answers for me. So many neurologic diseases share many of the same symptoms and sometimes it just means ruling one thing out and then moving on to the next possible diagnosis. In October, I had lumbar punctures and an EMG. The EMG ruled out CIDP (Chronic Inflammatory Demyelinating Polyneuropathy). The lumbar puncture revealed I needed Intravenous Immunoglobulin therapy (IVIG), as my body was not making antibodies. Those infusions started in 2017, alternating each month with my cancer treatments.

In 2017 and 2018, I tried another procedure to hopefully lessen my pain, a rhizotomy where Dr. Gosy used radio frequency waves to burn the offending nerve roots. Again, the relief was temporary. Since then, every muscle in my body feels cramped, tightly closed. My legs will suddenly, violently cramp, in sleep and when awake. I cannot stay in one position for more than an hour or two. I move from the bed to the reclining chair and back again. Dr. Gosy prescribed a muscle relaxer that is used to treat muscle spasticity (stiffness and spasms). Unfortunately, I experienced severe side effects and had to stop the medication. I tried physical therapy again. This time. Dr. Gosy referred me to a Doctor of Osteopathy who is also a degreed physical therapist with pain management experience. That specialist also recommended I stop PT based on how my body responded.

Fall of 2018, I found myself looking at another neck surgery. The discs above and below the first surgery sites were now degrading, such that I needed two cervical discectomies with two fusions and cages. In 2019, a Brain MRI showed new legions and in conjunction with other symptoms I was manifesting, I found myself being evaluated again for the possibility of Multiple Sclerosis.

Since then, I have continued to look for answers. Most recently, trying acupuncture, although without success. Having just been diagnosed with sleep apnea, I am hopeful some of my pain issues will resolve with BiPAP treatment. Of course, I continue under Dr. Gosy's watchful care, still on opioids to help lessen the pain and allow me to function and enjoy life as I am able.

Might I interject, I am grieved for those who have overdosed, for their families who suffer the loss of a loved one every day. I am sure Dr. Gosy is grieved too. Perhaps, I am just one of "the lucky ones". I did however make the choice to legally use opioids for pain control under the guidance of a licensed, experienced professional who has been helping patients for years and I believe saving lives. The lives he saved were also patients who followed the directions they had been given about the use of opioids.

I am grateful that Dr. Gosy chose a profession that not every doctor would choose. One where he dared to help those suffering immense pain, knowing narcotics would bring some relief to the patient, yet distain from some professionals who could only discharge that same patient, leaving them to suffer, but for pain specialists, like Dr.

Gosy. I am thankful too for the medical professionals that stand by Dr. Gosy, in a world that finds it all too easy to blame someone else or something else, rather than take responsibility for their choices.

I am grieved to be living in a world where facts can be misconstrued for political gain, with no thought of how it will affect others, Should every charge against Dr. Gosy be dropped today, there will still be those who will always believe he is guilty, all because they "read the facts" in a newspaper or heard them on radio or TV.

I am uninformed about the details of the charges Dr. Gosy plead guilty to. I wonder if he felt forced to plead guilty to these charges to avoid the possibility of more serious charges, should he plead innocent but be found guilty, a risk he would not want to take. I would like to hear his response to the charges, uninhibited by courtroom legalese and lawyers seeking to sway verbal answers and limit verbal answers to follow their desired outcome. The courtroom should not be about the best argument. It should be about the truth.

I feel this case is more than just about Dr. Gosy as an individual. It comes at a time when the media and political powers are "fighting an opioid war". I find it interesting that the number of opioid deaths does not detail how many were due to illegal drug use and how many in that number may have been using prescribed opioids but died from cancer or other health reasons. We can use statistics to say what we want to say. I believe Dr. Gosy's practice has been used to sway the facts.

How quickly non-medical professionals are telling us we are supposed to just stop using opioids (which is impossible to do!) and jump on the untested medical marijuana band wagon! This case is also about medical professionals who are thinking twice about liability, whether they want to take the risk as to whether they will be sued or brought to trial because they prescribed medicine or a treatment and the patient died. It is about whether any person will want to enter any field where the personal liability is so great because we live in such a litigious society.

My experience over the years with Dr. Gosy, finds a dedicated, caring doctor who desires to help those who are suffering with medical issues that are accompanied with much pain. I cannot believe he would ever think his patients are just an easy way to make money or that he would treat their lives so callously.

Selfishly, I do not want to have another pain specialist try and "catch up" on my medical history and ask me to start again with physical therapy, etc. (I went through that when my cancer specialist's office was abruptly closed. My records were supposed to be transferred to my new hematologist/oncologist. There was nothing in the transferred records from the first specialist that diagnosed and treated me for almost two years. There was one summary sheet from the last physician, who I had seen only twice, and that report did not even have my proper diagnosis!).

I believe Dr. Gosy has already lost much financially-his practice, his home, some belongings, and legal fees yet to be paid. I am sure there has been an emotional price paid by and for his family personally and professionally for all of his patients and employees. All of this, even before a plea.

Your Honor, as you deliberate the action you will take in this case, I thank you for taking the time to read this lengthy letter. My hope is that it will help you to see the Dr. Gosy I know. The doctor who has only had my best interest at heart since the time I became a patient of his practice, like each and every one of his patients.

I'm writing to you on behalf of Dr. Eugene Gosy. He has told me he plead guilty to Conspiracy to Distribute Prescriptions for Controlled Substance Medications Not For Legitimate Medical Purpose, in addition to Health Care Fraud.

My name is Kevin Ceroky, husband, father of two, and grandfather of four. I am a mechanical engineer, licensed in NY State, retired from Xylem Inc. as Manager of Research and Development. My wife, Anita, has been a patient of Dr. Gosy for many years and is also writing to you. My wife's letter details her medical experience with chronic pain. I would like to share my viewpoint, as I have always accompanied my wife to all medical appointments. We both find two sets of ears helpful when digesting and recalling what the medical professional is telling us. I usually write notes while she interacts with the doctors. Her journey has been rather a protracted one.

The role of "pain management doctor" is a unique one. Such a doctor is usually the last resort for chronic pain patients. My wife had visited any and all doctors that were referred or recommended and even just suggested, in order to attempt to relieve the pain issues she has been dealing with. As each doctor went through their process to attempt to find a specific diagnosis and treat a root cause and then failed, we would ask what to try next. We would try to get as many options from them as possible and many practitioners would end their advice by mentioning a pain management specialist. When asked for a name we might look up in order to pursue each of the possibilities, the most frequent name mentioned for pain management in the western New York area was Dr. Gosy. After seeing neurologists at both the Dent and Jacobs Neurological Institutes, a physiatrist at Buffalo Spine and Sports as well as their best chiropractor, two spine surgeons, a handful of specialized physical therapists each with targeted therapies, a massage therapist, acupressure practitioner, acupuncture practitioner, and a Dr. of Osteopathy, the only avenue that continued to have promise was pain management.

I have been impressed by Dr. Gosy's approach to my wife's well-being. He and his staff have been very knowledgeable and thorough. He would key in on small snippets of a comment either my wife or I would make about her health and pursue the possible application to improving things. My distinct impression is that administering drugs is not his first choice of treatment. In fact, more than once he's tried to lessen her dosing to assure the rate was not in excess. He has used other methods in order to avoid increasing any drugs in an effort to control her increasing pain levels. He has counselled us on the efficacy of other ideas either he brought up, or we've brought up, such as various surgeries, yoga, medical marijuana (THC) and also CBD. For each potential treatment he would discuss how it applied to my wife's very specific issues, and how the treatment may or may not help her. He strikes me as being only interested

in administering a workable effort and not wasting our time or money on something with little likelihood of helping my wife's specific situation. His demeanor is always kind, thoughtful, empathetic, and supportive.

I believe this is the character quality I've observed in him that I want to communicate. I find it difficult to believe that this man would risk his practice just to make money on the side selling the medications illegally, or performing other fraudulent actions. It is hard for an individual to act totally out of character and I find it difficult to believe these charges against Dr. Gosy.

I am saddened that the news media and politicians only use the phrase "opioid crisis". In my estimation it is more accurately named "illegal opioid crisis". The legal medications are extremely valuable to the persons requiring them. The pain management doctors are a key participant in our society's health, and western New York appears to not have enough doctors with sufficient skill and experience to help the many ailing people. However, with the present political climate in New York, many practitioners seem to be shying away from making their skills available, as we experienced when we attempted to have a backup plan for my wife, if Dr. Gosy's practice was stopped. After calling each doctor on a long list of possibilities provided to us, none were taking new patients, and many were not interested in helping any of Dr. Gosy's patients. It would appear the media has negatively swayed the medical profession in this area.

Your Honor, as you review the information before you concerning this case, my hope is that you will be looking for truthful facts, and find them in that information. Then, whatever the facts lead you to conclude will determine the direction justice needs to take.

Please accept this letter of support for Dr. Gosy. He saved my life—and for that I will be eternally grateful.

I suffered debilitating migraines since I was a young girl. They intensified after I had children. I sought treatment from my primary physician, from a renowned local neurologist and then another neurology practice—the largest neuroscience center in the country—and continued to struggle. My quality of life was poor and getting worse.

In 2010 I began treatment with Dr. Gosy. He was kind, sympathetic and understanding, willing to try different treatment approaches that I had never even heard about despite my ongoing google research. He never once tried to treat me with narcotics or painkillers. He tried to eradicate my migraine problem instead of simply putting a band aid on it. As a longtime recovering addict, I was extremely heartened by his attention and methodology. Addiction is a terrible disease. Dr. Gosy treated me with respect and ensured I would not be exposed in any way to medication that could trigger a relapse.

Within a few months of treatment, Dr. Gosy prescribed the medication that I have now taken for the past nine years. My life has improved immeasurably. Prior to this, I would have 2-3 migraines per week. I would miss work but even worse, miss time with my little girls. I feel like Dr. Gosy gave me my life back—and he gave my daughters their mom back. He is a wonderful person. I am so fortunate to have found him.

I am aware that Dr. Gosy has pled guilty to Conspiracy to Distribute Prescriptions for Controlled Substance Medications Not for Legitimate Medical Purpose, as well as Health Care Fraud. This upsets me greatly. From the minute his office was suddenly and brutally locked down—impacting thousands of patients like me who were forced into relentless pain and unwanted medication withdrawal—until now, I have wondered why Dr. Gosy has been vilified as he has. Any and all actions toward him rippled outward, affecting so many of us...causing unnecessary anguish and distress. Dr. Gosy is human. He may have made mistakes. Plenty of other doctors have made mistakes as well yet they have not been excoriated as he has been. His entire practice was dedicated to helping those in chronic pain, people just like me, live better lives. By this very nature, it means that medication designed to ease pain would be used. And until the past few years, best practices in medicine viewed pain an essential indicator that necessitated management.

The fact that individuals abused their medication should not be held against Dr. Gosy. I know firsthand how addiction hijacks the brain, leading to poor judgment and impulsivity. Trust me, I have been there and it is horrific. In recovery I learned to take responsibility for my actions. I did not choose to be an addict but I have the ability to make healthy decisions. If a doctor prescribes medication that says to take one per day, that is what I am supposed to do. When I take more than that, I am choosing to risk my health and possibly my life. It is tragic that anyone, anywhere dies from addiction or overdose but the blame cannot be placed on a doctor. Ingesting the medication is a choice made by the individual which cannot be attributed to someone else. From everything I have heard about this case, I do not think Dr. Gosy did anything wrong.

My experience as a patient of Dr. Gosy who struggled with chronic migraines and who is also a recovering addict is unique and valuable. I cannot stress enough how much he helped me. If it weren't for him, I can honestly say I do not know what my life would be like now though I am pretty sure it would be terrible. Thanks to Dr. Gosy, I no longer have migraines and I live a happy life. I run my own successful consulting business, have two wonderful teenage daughters, a beautiful home, loving husband and contribute to my community through volunteer work and other service. Not too long before I began seeing Dr. Gosy, I was an inpatient at Bry Lin and Clearview Treatment Center. Clearly my life has changed for the better.

Thank you for considering this letter. I fully support Dr. Gosy and hope that he does not have to serve any type of sentence. I am quite certain that it is a foregone conclusion (tragically) but please exercise the utmost leniency of which you are able.

To begin, we want to make it clear that we are fully aware that Dr. Gosy plead guilty to Conspiracy to Distribute Prescriptions for Controlled Substance Medications Not for Legitimate Purpose, as well as Health Care Fraud.

Our son Cameron's story started in the January 1985. Cameron suffered a stroke at birth causing severe brain damage which led to his initial diagnosis of Cerebral Palsy. At age 11 Cameron developed a very serious case of Secondary Generalized Dystonia.

After seeing many neurologists, it was suggested to us to have Cam seen by Dr. Gosy. Cameron was about 14 years of age at the time and in severe pain caused by the constant pulling and twisting of his muscles from the dystonia. His dystonia was not at all being controlled by oral meds or botox injections. Nothing was helping; he was in terrible pain and his entire body was wracked by spasms. Dr. Gosy immediately recognized that Cameron was a unique case and quickly came to the conclusion that he would more than likely be a candidate for a surgically implanted Baclofen Pump which would hopefully be able to get his dystonia under control.

Once the pump was successfully implanted Cameron's life was greatly improved. Dr. Gosy managed Cameron's pump (refills and adjustments) for many years until restrictions were applied to his practice.

Along with pump management, Dr. Gosy often referred us to other wonderful doctors for various issues. And of course, Dr. Gosy provided pain management when required over all those years. Along with all his other issues, Cameron has severe arthritis which required a great deal of pain management.

Dr. Gosy has always been Cameron's go to doctor. When no one else had any suggestions or told us that there was nothing else they could do for Cameron, Dr. Gosy was always there. Even now, he is trying to understand and figure out what is causing Cameron's latest issues. He never gives up on his patients. His vast knowledge and desire to help his patients is what makes him such an exceptional doctor and an incredible asset to the medical community in the Buffalo Area. We really do not know what Cameron, who is now 35 years old, will do without him!

My name is Pamela A. Gaglione. I have been a patient of Dr. Gosy beginning in 2008. I have suffered from leg, back and left hip pain which commenced when I was sandwiched in between a car and a van in an accident in 1977. Since then my pain had progressed to the point where it was impeding my functioning on a daily basis, hence I sought the help of Dr. Eugene Gosy.

I have a bachelors degree in human services/gerontology as well as a masters degree in social work from the University of Buffalo. I have worked in rehabilitation programs, mental health clinics as well as programs for children with special needs.

I am a skull based, brain tumor cancer survivor, undergoing an extensive surgery at Roswell Park Cancer Institute in 2001.

I respectfully submit this letter to you for consideration in the sentencing of Dr. Eugene Gosy, M.D., who recently pleaded guilty to Conspiracy to Distribute Prescriptions for Controlled Substance Medications Not for Legitimate Medical Purpose, as well as Health Care Fraud.

I am a lifelong resident of the City of Buffalo, a graduate of Medaille College, a wife of 35 years to a Buffalo Firefighter, and mother of two adult children. Until my disability forced my retirement in 2010, I was employed as an administrative professional.

In 1979 I was involved as a pedestrian in an auto accident with injuries that lead to my right leg below knee amputation. The usual result of traumatic amputation is phantom limb feeling, phantom limb and nerve pain. In addition to all of that I deal with recurring skin breakdown and sores from wearing a prosthesis, cervical and lumbar disc degeneration causing pain and exacerbated by my uneven gait. For many years I lived with untreated severe pain while I raised my family, went to school, and worked outside the home. Whenever I attempted to discuss my pain and discomfort with medical professionals, I was either treated dismissively or told that I was just going to have to bear it. I was younger and fairly healthy, so I just put up with it because I was given no other options.

Since the initial amputation in 1979 I have had to undergo several amputation revision surgeries to try to correct some of the issues I was experiencing. By 2010 I was facing additional surgeries and, the pain was getting so bad that even taking care of mundane household tasks was proving difficult. Most days after work I would return home exhausted from the pain and take to my bed which severely impacted my family and social relationships, so I was advised to retire. After I recovered from the surgeries and settled into retirement my situation had not much improved so in the Fall of 2011 my primary care doctor referred me to Dr. Gosy's practice to seek other treatment options.

After my very first visit I felt confident I could get my life back because Dr. Gosy listened to my story, and understood what was happening to my body and mind as a result of years of living with pain and a treatment plan was put in place. It was the first time in decades that my health situation and pain were not minimized or dismissed. In addition to pain alleviating injections and use of medication, Dr. Gosy supported me in seeking chiropractic and massage therapies.

Dr. Gosy's approach to my care assisted in reversing the downward spiral of my health so l could get back to living a fuller, healthier, and more engaging life. I have resumed household chores, spend more time with family and friends, travel, volunteer, and assist in the care of aging relatives on a regular basis. I move forward in life with hope again.

A good doctor/patient relationship is built on trust and takes years to establish. I trust that Dr. Gosy has my overall health and well-being as his primary concern. I trust that his compassion and concern for my personal situation is genuine, and that he wants nothing more than for me to be well as he had once shared with me his observation that our society was beginning to lose compassion for those suffering with chronic pain and that would lead to a failure to address and treat it. I trust that he believes that I will always live with some amount of pain, but that through a multidisciplinary approach it will be bearable and minimally impact my life. I trust Dr. Gosy so much so that I stayed with him and followed him when he left his old practice and moved to Invision Health.

I thank you for the opportunity to share my personal experience as a patient who has benefitted greatly from Dr. Gosy's compassionate treatment.

I am writing this in support of Dr. Gosy. Initially, I need to say that I understand that Dr. Gosy has plead guilty to Conspiracy to Distribute Prescriptions for Controlled Substance Medications Not for Legitimate Medical Purpose, as well as Health Care Fraud.

My problems began in 1998 while I was living in South Carolina. While driving along a lake on a Sunday afternoon, I had a head on collision with a drunk driver. This left me with multiple health problems, including epilepsy and nerve damage in my legs and back injuries.

I worked in Information Technology and was able to continue working until 2005, while being treated by a Doctor in South Carolina. By that time my health issues had gotten worse, mostly the pain which was constant even with treatment; so, I was forced to go out on disability.

In 2007 we moved back to the Buffalo area. Initially, I was treated for pain by a different practitioner. I had to have three significant surgeries, all at Millard Fillmore Suburban Hospital. The surgeon could not handle treatment for pain after surgery because I was in pain management. The only doctor associated with the hospital at that time for pain management was Dr. Gosy, so he handled my pain treatment.

By this time, I had begun to feel that the person I was being treated by was overmedicating me. I had been happy with the way I had been treated in the hospital and decided to start seeing Dr. Gosy. I explained my problems; and he went through my records. He agreed that my medication should be reduced and the began the necessary adjustments so that my pain was at a manageable level with the least possible medication. Perhaps most importantly, he had listened to me and worked with me on my concerns. Doctors do not always do this.

On a different note, I did not like the way the DEA handled this at all. Someone said that Dr. Gosy's office was like a 19th century opium den. This creates in peoples minds a dark dingy place with a lot of wasted people laying around popping pills and smoking opium. In truth, his office was always clean and brightly lit. I never saw anyone with any drugs of any sort there. Dr. Gosy was meticulous in doing drug tests and pill counts. Comparing this to an opium den gives the impression to people in general that all pain management patients are just drug addicts looking for a fix. This just isn't true. It is stigmatizing and makes the life of those of us already living in pain more difficult.

There is added stress now for those of us who still see Dr. Gosy. We do not know what will happen or who will treat us if Dr. Gosy loses his license and goes to jail.

In closing, I just want to say that I have always found Dr. Gosy to be a good man and an excellent doctor.

I am an 85 year old widow patient of Dr. Eugene Gooy. I am aware that Dr. Gooy plead quilty to two charges under counsel of his lawyer. I taught in the Catholic ochool system for 28 years, and know well there are two sides to each problem and only a very wise person weighs both before making a decision. The prosecutors have taken 7+ years. They dismissed many charges; perhaps there will be an end to his many losses especially his reputation.

After 17 years of compassionate care from Dr. Gooy for damaged bones (five in my spine from an accident in 1954) with no constant narcolics. Dr. Gooy treated my knees, back, shoulders and most recently my hip; after other orthopedic doctors all wanted to operate. Dr. Gooy felt the pain from recovery would necessitate heavy medicines and we discussed my options. I did not want surgery.

Bayer aspirin is my drug of choice. They work well enough for me; combined with injections in my knees, shoulders and lumbar region. Dr. Gosy is extremely gentle and has tried new solutions. He spaces these injections so there are no "side effects". Where else would we seniors find a compassionate doctor who understands we don't all want to sit in nursing homes.

As a final plea for allowing Dr. Gosy to continue helping so many people, I'd like to explain how I was referred by Dr, Irshad Ali, (retired) because he knew my deceased husband, Michael, was helped after many work related accidents from 1990 to 2008 by Dr. Gosy with no strong narcotics. I have been for forced to apply for disability benefits since I have been unable to work for so long, even though I truly wanted to go back to work.

After treatment in New Jersey for my tailbone, I could not find another doctor locally who would treat me for either my back or my tailbone pain. I searched for many months before I contacted Dr. Gosy's office and he agreed to see me. He was the only doctor that was willing to try to help me.

Dr. Gosy has done several injections that none of the other doctors have tried. Unfortunately, they did not have the results that we hoped for, but he did not give up on trying to help me. I have tried two medications that I have never tried before and am waiting to see the results of one medication that takes many months to increase slowly. Dr. Gosy has also sought to treat both my back pain and my tailbone pain. This is something that none of the other doctor have tried to do. He is focusing on all of the pain I experience, and is trying to help me with it. He is compassionate and willing to talk about what has happened to my life as a result of living with chronic pain. This is something that is also unique to treating with him. He has told me that even if the current medication that I am taking is ineffective, he still has some other things that he would like to try. This letter is written with reference to the litigation concerning Dr. Eugene Gosy MD who has plead guilty to Distribute Prescriptions for Controlled Substance Medications Not For Legitimate Medical Purpose and to Health Care Fraud. I have been a patient of Dr. Gosy for the past five years for pain management.

I am a 77 year old retired professional registered nurse with a background in health care for over 40 years including practice as a registered nurse, certified nurse-midwife, and professor of nursing. My teaching experience includes UCSF School of Nursing, UCSF School of Medicine, San Jose State University, Stanford University School of Medicine, University at Buffalo School of Nursing and Daemen College School of Nursing. I practiced nurse-midwifery primarily in California from 1971 to 2006 providing services to underserved and impoverished women.

Since 1975 I have suffered from degenerative intervertebral disc disease resulting in spinal stenosis, bulging discs, compression of the spinal cord and spinal nerve roots in my back and lumbar spine and complicated by osteoarthritis. As a result I have chronic moderate and occasionally severe nerve pain in my neck, back, arms and legs associated with muscular weakness, sciatic pain in both legs, neuropathy in my hands and feet, and difficulty with balance and coordination. I use a cane daily and a walker on bad days because I can't walk for more than 100 feet without assistance and cannot stand for long periods of time. I have had spinal fusions in my neck and lumbar spine resulting better balance but no reduction in pain. I have used a variety of alternative modes of therapy including physical therapy, yoga, meditation, nerve stimulators and a wide assortment of OTC drugs and ointments without any significant change in the level of pain.

I was referred for pain management by my primary care physician when it became apparent that I needed more aggressive pain management. I have been in Dr. Gosy's practice for the past five years because, as a neurologist of high repute and a pain management specialist, he was able to offer me more effective pharmaceuticals and also epidural injections of steroids and local anesthetics for severe pain. Under Dr. Gosy's care. I have been able to continue to live independently with the help of my sons and other family members. When I started with Dr. Gosy, he put me on daily doses of sustained release opiates at very low doses. I believe that his plan worked for me because my blood level of opiates was regulated to avoid rapid changes in blood level. Five years later my dose of opiates has not increased. Indeed it has decreased slightly to avoid liver complications. Dr. Gosy has been able to further offer me his exceptional skills in epidural injections. He uses advanced visualization techniques to place the needle to avoid touching or piercing the nerve. I have lost count of the number of injections I have received but I can assure you that there has never been an occasion of severe pain like that I have experienced with other providers.

I feel that the practice of pain management requires the integration of related skills such as offering a wide selection of alternative therapies, and the highly competent provision of surgical techniques. These skills are the hallmark of Dr. Gosy's practice. I am asking that you consider, in your determination of the sentence for his guilty pleas, any possible way that he can be permitted to continue his professional practice as he has for the past 2 years under supervision. His services are desperately needed in this community where medical management of pain is hard to find.

Thank you for the opportunity to submit this letter and for your careful consideration of the above issues. I am more than willing to assist in any other way you deem necessary.

Dear Justice Geraci.

I would like to thank you in advance for taking the time to read my letter in regards to Dr. Eugene Gosy who's sentencing is now before you. Being a retired Buffalo Police Detective I fully understand Dr. Gosy's guilt or innocence is no longer a matter in question as he has pleaded guilty to Federal charges in his case. From my almost 25 years of experience I realize the challenges a Judge faces in taking into consideration the totality of a person before them to determine an appropriate and just sentence. Thus I would like to share with you my experiences, observations, and interactions which has led to my personal conclusions based upon what I have witnessed with Dr. Gosy as a patient of his since 2006. For almost 10 years (2006-2016) I was treated in Dr. Gosy's office every 3 weeks right up until the time of his arrest. Thus I have witnessed countless interactions with Dr. Gosy. I hope sharing such will serve your Honor well in arriving at a sentence that is just and appropriate for the man now before you.

As Dr. Gosy's crimes entail narcotics it is appropriate to share my background as a Police Officer with your Honor, for you to decide my credibility and relative level of expertise in dealing with thousands of narcotic addicts, dealers, victims, etc. Most importantly my over all sense of an understanding of deviant human behavior in relation to individuals involved with narcotics I believe is relevant here.

I started my Police Career with the Buffalo Housing Police in 1989 at 20 years of age. I was quickly assigned to a plain clothes detail with the NY State Police targeting street level narcotic sales. Working directly under and as assigned to the State Police CNET (Community Narcotics Enforcement Team) I learned how to conduct Narcotic investigations with the utmost level of professionalism and integrity. In June of 1993 I completed the United States Department of Justice's D.E.A. Drug Law Enforcement Training School. I now had almost 5 years of street experience along with two training academies, In July of 1993 I was hired by the Buffalo Police Department as a Police Officer and now I was entering into a third Police training Academy. Thus I submit to your Honor I have extensive training at a level not found in many Police Officers. I graduated from said academy in December of 1993 and within months of my first Patrol assignment at then Precinct Six I was approached by the Precinct Commander and was offered an Acting Detective Position to be assigned to Narcotics and Intelligence. I humbly and respectfully turned the offer to this position down on more then one occasion for one simple reason. My integrity as a Police Officer would never allow me to be beholden to the politics of the Police Department. I have always lived my life never allowing myself to be indebted to anyone. Thus I waited as I knew that for the first time in the history of the Buffalo Police the Position of Detective would finally be based upon a competitive Civil Service Exam and not politics. In 1999 I took the very first competitive exam in the history of the B.P.D. for the rank of Detective and I was subsequently hired for such and attained the rank of Police Detective on my own merits. My Detective assignments were as follows, Special Frauds where I learned extensively about theft and profit though deviant criminal behavior, E District on Bailey Ave. which is the busiest Police District in the City of Buffalo and finally I was transferred to the Narcotics and Intelligence Unit where I worked right up until my retirement. During my tenure as a Narcotics Detective I made countless arrests, authored literally thousands of search warrants where in I would only use "in camera" testimony for my application thus the highest level of probably cause. I participated in several federal DEA and FBI wire tap investigations, was temporarily sworn in as Federal Officer to work said investigations in which I have received letters of commendation and praise from the US Attorneys Office. Throughout my career I have always valued my professionalism, integrity, honesty, and humble human decency. Thus I

have earned the respect and friendship of nearly every Judge, Prosecutor, and many criminal defense attorneys.

At this time I would like to speak in regards to my medical condition that brought me to Dr. Gosy's. Between 1998 and 2004 I had suffered various on duty injuries that necessitated 3 surgical procedures to my left shoulder. In June of 2006 while executing a Narcotics search warrant I was with Officers from the NY State Police and Federal ICE Officers. A staircase leading to the basement of the dwelling unbeknownst to me was rotted and collapsed from under my feet causing me to fall head first into the basement. I suffered extensive cervical spine, shoulder, knee, and back injuries from said fall. Within in a short period of time my Orthopedic Surgeon had ordered MRI's of my left shoulder which revealed amongst other medical injuries an "in operative" re injury of my left shoulder. With in a month or so of said MRI my employer the City of Buffalo Police Department ordered me to report for an Independent Medical Exam. Where I was told by Dr. John Ring who was conducting the IME that it was the City of Buffalo's intent to pension me out on a disability retirement because of the extensive injuries. Having never even taken a day off sick in my entire career I had no intention of retiring from a job I absolutely loved going into day in and day out where I had the opportunity to help others while serving a community I love. My Orthopedic Surgeon Dr. John Marzo who is highly regarded in Medical Community cautioned me and had reservations about my returning to work as well, although he did agree with me that I should be at least allowed an opportunity to try to resume my career. Knowing I was in sever pain with no surgical options, Dr. Marzo referred me to Dr. Gosy to manage my medical condition and pain. Having consulted with Dr. Gosy in 2006 he also cautioned me in regards to the severity of my injuries and the likely painful debilitating condition of my cervical spine that I now had. However at my insistence of returning to my career Dr. Gosy agreed to support my choice in returning to work with the understanding he would closely monitor me. Dr. Gosy offered me a treatment plan of trigger point injections along with cervical epidurals which did help me greatly enough to be able to return to work in January of 2007. In short it is because of Dr. Gosy I was able to continue a career I loved, continue a life of self worth as I can not even begin to explain the negative feelings of being told one can no longer work especially at a job they love. Dr. Gosy listened to this aspect and understood the serious negative implications of a disability retirement upon a person and showed me compassion in allowing my to try and return to work.

From 2006 thought 2011 I was treated in Dr. Gosy's office every 3 weeks for injections which alleviated my pain level to a tolerable amount that kept me working in my capacity of a Narcotics Detective. Finally in 2011 my cervical and shoulder condition debilitated to a point of amongst other issues loosing function in my hands, intense headaches, intense pain and vision problems. Dr. Gosy's Office repeated the MRI's and informed me they could no longer allow me to work. I subsequently went back to my Orthopedic Surgeon to see if there was a surgical alternative and Dr. Marzo said to me I needed to see a Neurosurgeon and that he agreed with Dr. Gosy in that he also could no longer support me in my desire to continue my career and that I needed to accept retirement. I was subsequently given a disability retirement by the State of NY in less then a year from that point, in fact I was retired a month before my cervical surgery was approved and scheduled.

My point to all of this is this. It was only because of Dr. Gosy's compassion, care, and expertise I was able to continue serving the Citizens of Buffalo for another 4 years. I was able to continue the feeling of self worth in working a job I loved. It was Dr. Gosy who was able to help me through accepting my medical condition by candidly and with compassion make me understand that I should take comfort and pride in knowing I did my best and tried my hardest to continue. Although still upsetting today it was his wise and compassionate words then that helped me through one of the most difficult times in my life.

Please allow me to also share the following personal and some of the numerous observations of mine with Dr. Gosy, as again I was in his office every 3 weeks for 10 years.

Dr. Gosy would always come into the waiting room and greet each of his patients. I have never seen or even heard of any other Doctor doing this. As many of his patients needed help just to walk he would often offer a hand at getting up or walking and always had a smile and a

kind greeting for each of his patients. Once I remember him setting his tablet down in the waiting room and getting on his hands and knees instinctively on a salty and slushy rug to tie a mans shoes who obviously couldn't physically tie his own shoes. Are these not the actions of a humble and compassionate man? I humbly and with the deepest respect ask your Honor to ponder if you have ever witnessed such actions from a Doctor let alone any other man? Would any member of your Court including yourself spontaneously kneel in salty slush and do such for a disabled man? Please allow me to humbly and again with great respect ask your Honor to ponder the Biblical story of Christ washing the feet of a sinner.

Often one would hear Dr. Gosy singing to his patients. He did this silly act to distract ones mind for a brief moment away from their pain and get his patients to smile even if for a brief moment it helped those in pain to remember how to smile and sometimes laugh. I know as it is how he got me to forget my pain for a brief moment or two while injecting my cervical spine.

While a patient of Dr. Gosy I was routinely drug tested. During the time of my cervical surgery I was put on a opioid for pain. My neurosurgeon, Dr. Kevin Gibbons was elated I was already a patient of Dr. Gosy as he informed me he did not like dispensing such medications for pain and wanted Dr. Gosy to manage such. I was counseled about the dangers of such. The pills in my prescription were counted by his Nurse Practitioner at my appointments and when the time came for me to go off the medication his office required me to bring in the unused amount of pills to be destroyed. As a Narcotics Detective I was impressed with the precautions Dr. Gosy's office had in place for opioid perscriptions. I don't know of any other precautions a physician could reasonably take.

Your Honor I know better then most the smell of crack cocaine that permeates through ones skin. I know the hollow and drawn out look of a heroine / opined addict. Of all the countless times I was in Dr. Gosy's waiting room I can attest I never seen such an individual in his office. What I saw was on every occasion a waiting room packed full of individuals in great pain. Individuals with sever debilitating conditions. Dr. Gosy was said individual's only hope in living a life with some degree of comfort and self respect.

Another point I believe the Court is well aware of is this. There is a large percentage of patients who have exhausted all known medical treatments for their affliction. They are simply going to suffer a painful existence. Regrettably very few if any physicians out of fear will step forward to alleviate these individual's suffering with Pain Management.

What I believe the Court is not aware of is the near impossibility (as a result of Dr. Gosy's arrest) for a person to be treated competently for a work related injury let alone Pain Management. When ones injury is related to a workers compensation case physicians are refusing to accept the patient. Be it for pain management or basic medical treatment many physicians today are refusing to even see the person for any form of treatment. My son who is now a Buffalo Police Officer (the Commissioner of Police made sure my son received my actual original Patrol Badge at his swearing in) recently suffered a broken finger with detached ligaments at work. Our family Doctor of almost 30 years refused to see him for it. When I spoke with our Doctor he informed me that now the complexity of seeing patients for a work related injury simply puts his license at risk. This was only for a broken finger yet our Doctor said he could no longer see patients for any work related injuries. This should not be.

The City of Buffalo is self insured and I am not covered by NYS Workers Compensation Insurance and yet still it is extremely difficult even for me to be treated for my injuries today. Since Dr. Gosy's arrest I have been turned away by many highly regarded physicians. Physicians are mindfully watching the Court on this case and I fear the damage for individuals to receive competent medical care, for pain management or any injury that arises out of a work related injury case has already been done. Physicians are simply no longer accepting these cases. My hope is there is an outcome from the Court that re assures physicians that it is ok to once again treat individuals who suffer from a work related injury. Thus I ask your Honor to here in consider the weight, of the needs of the many on the scales of justice. The extensive damage now done and consider a way, if possible to rectify this injustice.

Lastly your Honor there is no question of the opioid epidemic in this Country today. I have witnessed it first hand. I have witnessed more overdoses, suicides, families torn apart, death,

young people needlessly turning to pills, etc. then I care to remember. Many of their faces forever engraved in my mind. Nearly every suicide or overdose had two common denominators. One said person was living such a painful existence that death was the only alternative to peace. Two it is natural human behavior for the family of such to place blame anywhere other then the person who made the choice.

I humbly ask your Honor to consider one last point here. It is evident now, that I believe was not evident during the investigation and arrest of Dr. Gosy that large pharmaceutical companies have been found guilty of engaging in the manufacturing of pill dosing that does cause severe addiction to sell more pills. It is evident now such high dosages done by the manufacture is not needed by a patient. These dosages were manufactured with FDA approval. Physicians rely upon the approval of the FDA and expertise in the Pharmacology industry in administering the level of dosage. Is it not reasonable for a physician to accept such in prescribing medication? It is a point I believe for your Honor to consider in the determination of Dr. Gosy's intent and scope of his practice in prescribing opioid medication.

In closing I would again like to thank your Honor for reading my letter and simply say this. As Dr. Gosy has always shown great compassion and the utmost care for his patients I humbly beseech your Honor to show Dr. Gosy compassion through your mercy. As there is a great need for physicians like Dr. Gosy I ask your Honor to consider the message being sent to physicians here for the good of all who live a life of pain. For these reasons and lastly from all my personal experiences as a patient of Dr. Gosy and as one who spent a career enforcing illegal narcotics I humbly say anything but great mercy from your Honor I resolutely believe will be a great injustice.

I am writing in support of Eugene Gosy, MD. I am aware that Dr Gosy plead guilty to Conspiracy to Distribute Prescriptions for Controlled Substance Medications Not For Legitimate Purpose, as well as Health Care Fraud.

I am retired from SUNY Buffalo, where I was employed as the Assistant to the Chair in the Department of Radiology. My work was as support to the chairman, including networking with other SUNY departments, keeping the chairman's calendar, facilitating all correspondence and interactions with Radiology residents.

In 2002, I was diagnosed with Trigeminal Neuralgia, a chronic pain disorder once called "The Suicide Disease." TN, as the disease is referred to, has two main categories. The first, known as "typical," results in severe, sudden shock-like pain in one side of the face, lasting from several seconds to several minutes. The "atypical" form results in constant, burning pain. Episodes are triggered by touching the face, a light breeze, the cold. I am one of the unfortunate who have both conditions. In 2003, I had a Microvascular Decompression, brain surgery to relieve the pain. My surgery failed, as well as leaving chronic vertigo. When it became obvious surgery was not my solution, I turned to medicine. Dr. Gosy came highly recommended as a pain specialist. Dr. Gosy ran many tests to confirm the condition. He then began to introduce medications to help relieve the pain. Not being an exact science, he tried several medications as well as dosages. Dr. Gosy has treated me for 17 years, he's knowledgeable about my reactions to medications, and carefully monitors my care.

It will be difficult to find a Pain Management doctor who is as knowledgeable and compassionate as Dr. Gosy. My condition is so painful that I had to take a disability retirement in 2007, Primary Care physicians do not understand TN.

I was in a Motor Vehicle Accident back in 1988 sustaining 12 fractures with additional injuries, and I have severe arthritis and pain as a result. Someone suggested I see Dr. Gosy but prior to that time, I was generally immobile except for self care. Dr. Gosy has been able to remediate my pain without my becoming addicted in any way to pain killers. I might add that I am allergic anaphylactically to all NSAIDS including Aspirin and can take only Tylenol which simply does not work for the pain.

To summarize, Dr. Gosy has been a blessing to me. I also receive injections in my Lumbar area and bilaterally in my pelvis which help with the pain. I receive these injections approximately twice a year usually in the Springtime and in the Fall when the pain is at its worse. Unfortunately, my health took a turn with an exacerbation of migraines and CVS which lead to other health issues. Ultimately I had to leave my position with the DOT and applied for Social Security Disability in 2010.

While I was waiting for diagnosis and treatment/surgery for trigeminal neuralgia in 2013, I required necessary pain medication in liquid form to insert into my Gtube. After the second surgery in 2018 and following my recovery in 2019 with Dr. Gosy's assistance, I was able to wean off of that medication and now am prescribed a pain medication PRN. I currently am also receiving home care and nursing services.

Both my parents, Karen and Richard Popson are Licensed Clinical Social Workers in private practice since 1986. Both received their MSW in 1977 from SUNY-UB, certification and licensure in 1983. Despite a three year change of residence after graduating and after the Blizzard of 77, we returned to WNY to practice what our educational base was in New York. We have provided mental health and substance abuse services to children, adults and families.

Aside from my specialists and surgeons, Dr. Gosy has been the one constant compassionate, understanding, comforting, intelligent, physician by my side! Honestly, I would not be alive if it were not for Dr. Gosy and his expertise! The point to all of this is that despite what the legal system has said and done, we believe in and continue to support Dr. Eugene Gosy and the lives that he has saved! Dear Honorable Frank P. Geraci. Jr.,

I have been in the music industry most of my life...I served as a performer, talent scout, and music manager, from NY to LA.

All this came to a crashing halt in 2019 when I was in a major motor vehicle accident. The car I was driving was T-boned by a car going approximately 55 mph. Due to the accident, my knee cap was broken, I suffered back, and a wrist injury that has left me with a tremor in my hand. I am facing surgeries after covid 19 crisis is under control (my surgery was postponed due to covid 19)...which means I have to wait even longer to have some of these issues addressed.

Dr. Gosy has been my pain management doctor through this. I am absolutely terrified if Dr. Gosy won't be able to take care of me. Please find it necessary to keep Dr. Gosy out of prison...my wife Gail and I rely on him wholeheartedly. I have seen how he has helped Gail through her injuries over the years.

I acknowledge that Dr. Gosy has plead guilty to conspiracy to distribute prescriptions for controlled substance medications as well as health care fraud. I have not personally witnessed this. I am extremely anxious about possibly going through my surgeries and recovery without him. Please let Dr. Gosy be available to us and all his patients.

Dear Honorable Frank P. Geraci Jr.:

I have been a patient of Dr. Gosy's since September 2018 at Invision Health. I want to be clear in saying that Dr. Gosy did not ask me to write this letter. It is something I wanted to do. I cannot simply just sit back and watch Dr. Gosy be vilified and painted as someone and something he is not. I am aware that Dr. Gosy pleaded guilty to Conspiracy to Distribute Prescriptions for controlled substance medications not for legitimate purpose, as well as Health Care fraud. I am aware that I am not in a place to speak to those specific charges, but I would like to discuss my experience with Dr. Gosy. I would also like to discuss the other perspective regarding opioid use for chronic pain. It is a side that is, unfortunately, often forgotten and has been misconstrued. A side that Dr. Gosy understands and has empathy for, when so many others in society do not.

I would like to share a little of my medical background, and what it has been like to be a patient of Dr. Gosy's. I have nerve damage from unfortunate complications from a dental procedure, and overtime the damage has created other painful comorbidities, such as chronic migraines. I was already a part of the pain management program at Invision Health, when I began to see Dr. Gosy in the neurology department for the neurological aspects of my chronic pain conditions.

In my appointments with Dr. Gosy, he takes the time to truly listen to all my concerns and ensures they have all been addressed. I have never once felt rushed. Anyone in healthcare knows that is rare. Additionally, he makes sure to ask how my mood is, which this too, is also something rare to be asked from a doctor, who is not specifically in the mental health field. You can tell he is asking from a point of compassion and concern.

My case is particularly complex with a lot of variables. He has been great with thinking outside the box. He comes up with ideas other specialists have not. For instance, he has had me try neurofeedback, a form of biofeedback, as a different approach to improve my chronic muscle tension. He is also having me take monthly injections to help cut down on the number of migraines and another medication for my nerve pain. I have become more stable under his care. I have been dealing with my condition for 8 years and I have seen doctors and specialists all over the country. I have to say his knowledge and expertise far exceeds others. He has been the first doctor to be able to explain to me what is really going on and how everything connects.

He looks at my entire situation, not just the neurological aspects. For instance, he noticed how my heart rate was consistently in the 90s or 100s. He said this is not something that can be

ignored, as it could lead to heart problems later in life. When I had brought this to other doctors' attention, it was ignored. He came to the conclusion that it was due to a medication. I got off the medication and my heart rate returned to normal.

He does not settle with where things are at with my health. He is always striving to get me to a better place. He realizes that I am young, and that I still have a lot I want to accomplish. He has given me a renewed sense of hope, which is truly a gift. It is usually the other way around with doctors telling me that I need to accept things, which leaves me feeling defeated.

Then I would like to briefly talk about the other perspective regarding opioids, as there is a considerable amount of misconception and stigma surrounding those who are in chronic pain. It is really just about individuals who have debilitating pain, trying to get some relief. If over the counter pain relief helped, pain management would not be sought out. For most, it is the last resort. Think about pain that is unrelenting, with no end in sight. It steals from you so many of life's moments, especially if it does not become medically managed. People in pain are shamed and looked down upon. They are painted as drug addicts, dramatic and lazy, but this is truly the minority. Prior to my unfortunate nerve injury, I was a director at the largest nonprofit in Colorado. I have two degrees. I have personally tried countless alternative therapies gaining little to no relief. Sadly, when I am not taking opioids, I cannot function, as the pain becomes excruciating.

Chronic pain is no respecter of persons. Anyone could wake up tomorrow and get in a car accident, and end up in lifelong debilitating pain. I am simply striving for a better quality of life. When you have a doctor genuinely fighting for that as well, with considerable knowledge and expertise, then that is a fight that can be won, and Dr. Gosy is that doctor.

The average number of hours dedicated to teaching about pain management in medical schools is 11 hours, which results in a gross lack of knowledge on how to treat chronic pain. Dr. Gosy has had countless years of experience, which has led to a better understanding of pain and pain management for his patients. The U.S. has a pain problem, with over 50 million in chronic pain. It will take brilliant minds, such as Dr. Gosy, to be able to successfully address this high prevalence of pain, as it is such a complex matter.

Putting Dr. Gosy in prison would be a complete disservice to the community. I can honestly say it will prevent patients, like myself, with complex and disabling conditions, from achieving a better quality of life.

To be able to make an informed decision, it is always best to gather all the facts and to contemplate both sides of the situation. I would hope that all who are involved will pause and take a moment to look at this situation from a different perspective.

Dear Honorable Judge Frank P. Geraci, Jr.

I want you to know that Dr. Eugene Gosy saved my life.

I have been a patient of Dr. Gosy for 27 years, since December of 1992.

At the time of my first visit with him, I had been suffering for two and a half years from a debilitating left knee sprain. No one close to me knew that on that December day, if Dr. Gosy could not help ease the excruciating pain I was living with, I was going to commit suicide that night to finally put a permanent end to my suffering. I just couldn't take it anymore. The pain was overwhelming. It was like no other pain I had experienced before, and difficult to comprehend what was happening with my leg from what should have been a simple sprain. At times, my leg would be numb to the touch, but yet it would feel like someone was stabbing it with a lit cigarette. Other times, my leg would feel ice cold, stinging, with a bluish/purple coloring to it, unable to tolerate any touch. Sometimes the pain would be the tingling sensation of pins and needles, the kind you get when you hit your elbow. The pain would last several minutes to hours, oftentimes making sleep impossible.

The doctors I had seen locally, my primary doctor and two orthopedics, did not know why I was having so much pain when, tests showed, my knee seemed to heal. The orthopedics assumed I was exaggerating the pain level I "claimed" to be in. Their treatments included physical therapy, a full leg cast, and unnecessary surgery where synovial tissue was needlessly removed. These only exacerbated my condition, requiring me to use crutches or a cane to walk. They told me there was nothing more they could do, and that I would "just have to live with it (the pain)". But in late November 1992, I went to Johns Hopkins Hospital in Baltimore, MD where I was officially diagnosed by an orthopedic and a neurologist with the, relatively little known at that time, chronic neurological pain disorder Reflex Sympathetic Dystrophy (RSD). My knee sprain had traumatized the saphenous nerve resulting in excruciating pain.

Upon returning home, my primary doctor referred me to Dr. Eugene Gosy. I was fortunate that he was familiar with the two doctors who diagnosed me at Johns Hopkins. I remember at my first visit with Dr. Gosy, after he read my medical reports from Johns Hopkins, and examined me, him saying that he concurred with the diagnosis, and knew he could help me. Then came the infamous "but....." and the feeling of dread. I remember Dr. Gosy's exact words, "but, I will need you to be patient until

I can find the medication or combination of medications that will work". I remember crying. I couldn't believe I was finally going to get the help I desperately needed. The relief that there was a name for what was wrong with me. That there was proof I wasn't faking. But most of all, that treatment was possible. Dr. Gosy then scheduled a nerve block and gave me a prescription that was not an opioid. I had learned that drugs such as those for hypertension, heart conditions, epilepsy, calcium channel blockers and beta blockers work effectively on nerve pain. Those were the type of drugs Dr. Gosy had prescribed for me for the first six years of treatment.

With the very first medication he prescribed, I experienced pain relief, but unfortunately I discovered that I was hypersensitive to many pharmaceutical drugs. I couldn't tolerate the side effects that came with many of them that were prescribed, all of which did provide me with pain relief. I became discouraged and depressed. Dr. Gosy assured me he would find a medication that I would be able to tolerate, and he did. He never gave up on me. It was a drug usually intended for heart arrhythmia that works on the nervous system. I did not have a heart condition. Along with medications, periodic nerve blocks and a lidocaine infusion, my pain had eased incredibly. At every office visit, Dr. Gosy would always tell me to exercise and "keep moving" no matter how much pain I was in. Inactivity would exacerbate my pain. I had improved so much that I felt like a human being again, able to function, rarely needing a brace or cane. My outlook on life became more positive.

I was feeling great, and ready to go back to work, when, on May 20, 1993, I got into a car accident the day before my appointment with Dr. Gosy for a lidocaine infusion. I had injured my right foot and ankle which affected the calcaneus nerve. Although, my physical injuries (including numerous bruises) had healed, Reflex Sympathetic Dystrophy (RSD) had set in. Seeing Dr. Gosy the next day, gave me confidence that catching it early would make for quick recovery. But the medication I was taking for my left knee pain did not ease my right foot/ankle pain. I was back to square one, unable to go back to work, with Dr. Gosy trying to find another medication that would help the RSD pain in my right foot/ankle. It wasn't long before he found a medication intended for epilepsy, that I could tolerate, that helped ease the pain.

After two years, the epilepsy drug had become less effective in relieving my right foot/ankle pain, and Dr. Gosy had to find another drug which proved difficult because of my sensitivity to some medications. But through it all, Dr. Gosy never prescribed an opiate when other medications proved helpful. As time passed with nothing else working, my right foot/ankle was becoming increasingly more difficult to walk on requiring the use of a cane or crutches. Finally, as a last resort, Dr. Gosy felt I was an excellent candidate for a spinal cord stimulator to be implanted in my spinal column that would send electrical impulses to block the pain messenger to the brain. I was referred to a local neurosurgeon with experience in this fairly new procedure. In September 1999, the surgical procedure was so successful, it not only relieved most of the pain in my right foot and ankle, but completely relieved the pain in my left knee allowing me to get off of that medication. At a post-surgery appointment with Dr. Gosy in October 1999, we discussed the success of the operation but that I still had some pain in my lower right ankle. He told me about a new drug, Ultram (Tramadol), that works specifically on nerve related pain. At this time, Ultram (Tramadol) was not originally classified an opiate. I was concerned about side effects but he asked me to try it. It worked and continues to alleviate what little pain I have. It is unfortunate, though, that due to the controversy surrounding opioid abuse, Ultram (Tramadol) has now been classified an opiate.

Between the spinal stimulator implant I continue to live with in my spine, along with the Tramadol medication, I can function like a normal human being. But due to physical limitations with the spinal

implant, such as heavy lifting, frequent bending or twisting, I was unable to return to work as a data entry/computer operator at the law firm where I once worked.

Today, I continue to be a patient of Dr. Gosy. As years passed, arthritis pain from previous auto accident injuries have set in in areas of my neck and lower back. A herniated neck disc now causes numbness and tingling in both my hands. Even though I have lived with some degree of pain for 27 years, Dr. Gosy's care and encouragement to never give up, allow me to continue living a functional life. 27 years ago I needed to use a cane or crutches in order to walk. Today, if you saw me, you wouldn't know there was anything physically wrong with me. I owe all that to Dr. Gosy's care and perseverance in finding the right treatments to ease my pain, even today.

Drug abuse and self- medicating is a personal choice, and has vastly contributed to the opioid problem we have today. No doctor, family, orthopedic, anesthesiologist, neurologist or even dentist can be responsible for what a patient does with a prescription they are given. They can't babysit their patients every minute of the day. Patients will lie.

I understand that Dr. Gosy has pled guilty to Conspiracy to Distribute Prescriptions for Controlled Substance Medications, as well as Health Care Fraud.

I am asking you to please be as lenient as possible in your sentencing of Dr. Gosy. He has proven, to those who know and work with him, that medical care of patients was the primary factor in his practice.

After 27 years of his excellent care, I don't know what I will do without Dr. Eugene Gosy as my pain management doctor. He has never lost my trust.

I, John Reynolds, am writing to you on behalf of Eugene Gosy, M.D. My wife, Mary, has been under pain management for more than thirty years., the last ten or so with Dr. Gosy. She has had several surgeries for cervical spondylosis, most recently within the last year. She requires the use of a rollator and a Vista MultiPost collar for movement outside the home. His care has consistently been capable and compassionate. He requires routine urinalysis to ensure his patients take no alcohol which would have serious consequences if taking opioid medications. He and his staff will not send new or refill prescriptions even one day before required. He was instrumental in seeing that she had her recent surgery and had treatment by a wound care specialist for a MRSA-related lesion on her ankle bone in an effort to ameliorate her pain.

Dear Counselor:

My wife, Marsha Schifferli, age 62; suffers from multiple sclerosis, lung cancer and trigeminal neuralgia and is under the care of your client Eugene J. Gosy, M.D.

Dr. Gosy has prescribed three drugs, two of which are opioids: Oxycontin, Hydrocodone and Movantik.

Contrary to the allegations of the U.S. Attorney, DEA and FBI; the physician is <u>not</u> Dr. Feel-Good. Prescriptions are issued for 30 days supply only with no refills allowed. Our pharmacy must contact the doctor's office to request refills and they are sent electronically; there is no such thing as just calling for scripts as stated by U.S. Attorney William J. Hochul, Jr. on television last night. In my wife's case, three prescriptions for 12 months would account for a total of 36 for a single patient!

The doctor's office verifies the patient is actually taking the prescribed drugs by means of mandatory toxicology and urine tests as well as periodic pill counts and fill dates are precisely determined so that not one extra pill accrues. A personal visit with a nurse practitioner every two or three months is also required.

Kindly note well that many other physicians are referring patients to Dr. Gosy for pain management and will not write scripts for opioids out of fear of being prosecuted like your client. This includes both Marsha's primary doctor and neurologist.

I am my wife's sole care giver and believe that if it were not for Dr. Gosy, she would be confined to a skilled nursing facility rather than remaining at home.

Prescribions are issued for 30 days supply only with no refilis allowed.

I have 34 years in the Buffalo Education system; 10 years as a special education teacher, and 24 years as an administrator, serving as assistant principal. I also have a degree for superintendent qualifications.

I have been a patient of Dr. Gosy for approximately 25 years. He has addressed many of my medical issues over the years. I have rheumatoid arthritis, fibromyalgia, and hyperthyroidism. As you will see in this letter, these conditions were further exacerbated by an assault in 2004, and a major motor vehicle accident in 2019.

In 2004, during my administrative duties as assistant principal at Lafayette High School in Buffalo, I was assaulted by 4 very large girls during a fight among approximately 100 students. I was the only administrator available to try and break up the situation. I tried calling for help. But the next thing I know, I was pushed to the ground and beaten, kicked and stomped with the heels of their boots by the 4 girls...I lost all my teeth in this assault, they almost broke my back which required surgery by Dr. Landi. Dr. Gosy was instrumental in managing my pain during this crisis, which took away my livelihood in education. Dr. Gosy understood the pain, both physically and emotionally. He came to the hospital to take care of me. He would be at my bedside waiting for me to wake up at 6:00 am to address the pain.

In 2008, He again took care of me when I had my hysterectomy, again waiting at my bedside in the early hours of the day.

In 2019, I was in a severe car accident, just a block from home. We were T-boned by a car going approximately 55 mph. I suffered a torn achilles, tendon, additional back injuries that leave me in horrific pain 24/7. I have difficulty sitting, standing, laying down, and walking in my own home causes a tremendous amount of pain. I am currently under Dr. Gosy's care for this as well. He has me on the appropriate medications along with spinal injections to help alleviate some of the pain. I am facing major back surgery to help with these injuries. I truly need Dr. Gosy once again to manage my pain throughout my recovery.

I acknowledge that Dr. Gosy has plead guilty to conspiracy to distribute prescriptions for controlled substance medications as well as health care fraud. I have not personally witnessed this. Dr. Gosy is one of the finest people I have ever known, both personally and professionally. It breaks my heart to think of a man like him to face possible prison time. I don't know what I would do without him caring for me.

I feel he needs to stay right where he is helping people through their medical issues that they face. I truly consider him my friend. I am asking to please not send him to jail...I can't do it without him.

My name is Michael Stafford; I am a 71-year-old retiree, and long time patient of Dr. Gosy. He has been treating me for at least 7-8 years, for chronic pain. I have severe stenosis in my neck and lower back, as well as no cartilage in my knees (just bone on bone). Additionally, I have a severe nerve condition in my feet and hands called RSD, as well as severe osteoarthritis in my back, knees, hands, and feet. I have been living a life of constant pain for 20 years, and have had 8 surgeries in the past 15 years. Pain has destroyed my life, and I am basically a cripple.

You don't know me, so none of this will mean much to you; but it has been my life to endure this pain. Frankly, Dr. Gosy and his expertise is the only one to have given me any relief for my pain, and made my life even halfway livable again.

I am sure he has made some mistakes along the way, some pretty serious. As we all know, everyone wants a scapegoat for the opioid mess in this Country; to me it appears the Justice system is trying to make him the target. The one thing I know is that he has always been forthright with me about the pain drugs I take, and has always advised me of the dangers. I have asked him on many occasions to increase my pain medication, and he never submitted to my requests, always erring in the side of caution. He is a <u>GREAT</u> Doctor in my opinion, and I likely would have ended my life long ago if not for his help. There are many many stories like mine in the patient portfolio of Doctor Gosy, and I know some personally. The public doesn't. All they see these days are the dangers of opioids. I believe he is a fine man, and does not deserve the treatment he has been receiving in the Justice system.

So far, he has lost his business, his home, his standing in the community, and apparently many hundreds of thousands of dollars in the past 3 years - I think he has been punished quite enough. If more is called for, is it not possible for other measures to be employed to satisfy that determination and still enable Dr. Gosy to be a contributor to our society?

My name is Philip Whiting and I am writing this letter to strongly urge leniency in the sentencing of Dr. Eugene Gosy. I was born and raised in Akron, NY. I grew up in a family that emphasized a strong work ethic and high moral standards. Our company, Whiting Door, manufactures doors for the truck/trailer industry and has been in business for 67 years. Just having the last name does not mean I automatically have a job. I started working summers at our company at the age of 14 and, over the years, worked every job on the plant floor. I earned a bachelor's degree in Manufacturing Management and have worked my way up to the position of Vice President of Facilities and Logistics.

We employ over six hundred people nationwide, five hundred of which are right here in Akron. My position requires me to do a lot of daily as well as long-range planning. Our people look to me to organize freight in and out of the plant, monitor a number of inside operations, coordinate with various departments and much more. When I am not there, a lot of things can get thrown off. The only thing that has ever kept me from my job has been the chronic pain of migraines.

I began to suffer chronic migraines in my teens. Migraine pain continued to affect me through college and followed me into my adult years. MRI's, CT scans, consultations with numerous doctors, trying various "migraine drugs" all did little to help me. I often tried to work through the pain but my vision would become so blurred that I could not continue.

Two years ago, one of my employees told me about Dr. Gosy helping him with his chronic back pain and thought the doctor might be able to help me. I went to Dr. Gosy and finally got relief with his expertise and care. He prescribed me a Sumatriptan Injection USP auto injector system Most importantly, his follow-up care was second to no other doctor I encountered throughout the history of my condition. I'm happy to say that I haven't missed a day of work since due to migraine pain, but I was fortunate that my pain was not something I dealt with every day.

I am writing on behalf of Dr. Eugene Gosy and what I and others believe is a total mischaracterization of a man who tried to take on the impossible task of helping everyone who suffers from chronic pain. I am aware that Dr. Gosy has pleaded guilty to one count of Conspiracy to Unlawfully Distribute Controlled Substances and to another count of Health Care Fraud. I also believe it was his best course of action because he had to look out for himself and his family.

I would like to tell you a little bit about myself and why I believe Dr. Gosy saved my life. I can honestly say I don't know what my life would be had I not received the managed care for my chronic pain from Dr Gosy. On February 26, 2001 I was an independent contractor for Fed-X ground making business and home deliveries. I was delivering a package when I was attacked by a dog. Trying to get away the dog jumped on my back as I was running down the stairs. I lost my balance – shouldered the ground and destroyed my right shoulder. I had two surgeries to repair the damage, but the serious pain persisted. Finally, my orthopedic doctor sent me to a pain management specialist at DeGraff Hospital and Dr. Wagmarie diagnosed a disorder called Reflex Sympathetic Dystrophy (RSD). It is a debilitating disorder that effects the nervous system and one of the major affects is chronic pain. Dr Wagmarie wanted to insert a Spinal Stimulator which would have effectively ended me from doing anything physical again.

At that time my wife who is a nurse heard that Dr. Gosy was about to give a talk to other professionals about RSD and we were able to talk to him after and subsequently became a patient. I spent years seeing him every 2-3 months and adjusting and changing medications in the hope of having a quality of life worth living. I also had epidurals in my back to also help with the chronic pain. I was never able to return to the work I once did. Between the damage and the chronic pain, it was impossible. However, I did not as some people claim that "us drug addicts sit around and get high." I *started* my college education and earned a bachelor's degree in human resource development with a 3.91 GPA and graduated Summa Cum Laude. I then continued my education and earned a master's degree in Student Personnel Administration with the same GPA and worked for Medaille College as a college administrator and taught as a college adjunct instructor until my chronic pain and chronic migraines became to much.

None of what I just talked about would have been possible without Dr Gosy's care. He not only did whatever he could for me to have a quality of life, he encouraged me in my education quest. Were there people who abused the pain medications they were receiving? I would certainly have to say yes, however chronic pain in many cases is some nebulous condition. Nobody can see chronic pain. It's not like a broken bone in can x-ray and say, "oh that's the problem" and set it back in place. You can't look at me and say that you can see my chronic pain. That is the issue. So, how do you treat and separate those who genuinely need pain medication and those who abused medications. I unfortunately don't have an answer to that question, but what I can tell you that the most unethical thing that could have been done was to take it away from everyone.

People question the number of patient's Dr Gosy had. That reason should be evidently very clear. Where were all the people who suffer from chronic pain go when very few other doctors wanted to treat their own patients with chronic pain. I have talked to countless people who said their doctor would only refer them to Dr Gosy. As I stated in the beginning of this letter, it was an impossible task that only a few doctors tried to do the responsible thing for all those suffering people and Dr Gosy was one of them. He should not be victimized for what he tried to do. He should be praised for trying to help all of us.

It is a shame that some people abused their pain medications. Dr Gosy and his staff also tried to make sure that was not happening. I have had countless urine tests to make sure I was not. We were not allowed to consume alcohol and other drugs. We were warned that if that happened, we would be removed as a patient. However, in "every" case, when someone did abuse the pain medications they received, it was their choice. They made an active decision to abuse their medication. There would have never-ever been a case where pain medication was forced upon them. Through management at my highest dose, I used to take 45mg of morphine three times a day. I currently now only take 15mg twice a day. I believe those real bad days are behind me, and there is only one person on this planet who I can thank for the quality of life I have today, and that person is Dr. Eugene Gosy. I pray that common sense prevails in this case. He does not deserve to spend one hour in prison for what he did. Dr. Gosy deserves everyone's thanks and admiration.

The purpose of my letter is to ask that you grant leniency in Your sentencing of Dr. Gosy. I am aware that Dr. Gosy plead guilty to Conspiracy to Distribute Prescriptions for Controlled Substance Medications Not for Legitimate Medical Purpose, as well as Health Care Fraud and I understand the seriousness of these crimes.

I am a 43-year old paralegal who came to see Dr. Gosy after an accident in June 2019. I was driving through an intersection where I had the right-of-way when a car made a left-hand turn into the front of my vehicle causing it to veer and hit a utility pole head on. I had a conversation with my neurosurgeon about this appointment and her exact quote was, "Dr. Gosy is a wonderful man who I would let treat my children if it was necessary." During my first meeting with Dr. Gosy, he explained to me the physiology of why my body was experiencing the things it was. He also explained to me that as part of my treatment, I needed to let go of the animosity I felt towards the driver that hit me. He told me that there was a range of things that we could do to address each issue I was having.

It was the first time in 7 months that someone sat down, listened to what I had to say, reviewed my previous treatment and came up with a plan to give me some relief.

It's been roughly 3 months since I began treating with Dr. Gosy and I can truthfully say that I feel as though, with his help and guidance, that I am starting to feel that relief. Besides being extremely knowledgeable, he is also very kind and genuine. You do not see the type of bed side manner that he displays often by physicians.

In conclusion, I am asking you to take into consideration the things that I have mentioned above in sentencing Dr. Gosy. He truly has been a gift to me and my recovery will be at a severe disadvantage without the benefit of his experience.
