On May 24, 2022, your affiant received an affidavit from Beth Evans, who is the FDACS Chief of Compliance Division of Consumer Services. Evans stated that as of May 24, 2022, after a diligent search and inquiry, the records of the Division of Consumer Services show that the Robert L. Zore Foundation, Inc. d/b/a Fallen Officers have never filed an application for license/registration and does not have a valid current license/registration issued by the department pursuant to Chapter 496, Florida Statutes.

A review of bank records by your affiant along with RIS Senior Financial Investigator Mirisasha A. Velez revealed multiple transactions from the nonprofit's bank account to the personal bank account of Rosemary Zore from 2019 to 2020 totaling \$34,938.15. The review of the bank records also revealed additional charges not consistent with the operation of a charity such as, a Ohio Child Support Payment made on 09/03/2019 for \$500.00, Fedorko Chiropractic Center on 09/23/2019 for \$100.00, on 10/11/2019, Serenity Massage - Naples for \$216.00, and two pool services, one by Bracken Pools on 04/02/2020 and Aqua Pool Pro Services 08/14/2020 for \$100.00 dollars each. On 9-1-2020, 10-1-2020, and 11-1-2020 payroll payments of \$1500.00 were made to Rosemary Zore, A review of her 2018 990 Tax Form revealed she claimed Zero for any compensation or reimbursement from the charity. No new 990 Tax Forms have been completed by Rosemary Zore or any Department forms to show compensation for Rosemary Zore. This is a violation of F.S.S 496.415(16) Fail to Apply Contributions in a Manner Substantially Consistent with the Solicitation.

A search of Robert L. Zore Foundation Dba The Fallen Officers is a not-for-profit organization filed with the Florida Division of Corporations on September 04, 2018. The principal address listed is 4330 Tamiami Trail East Naples, FL 34112. Rosemary Zore is listed as the President/Founder of Robert L. Zore Foundation Dba The Fallen Officers.

A search of the State of Florida Database DAVID revealed that driver's license number Z600-720-76-867-1 is issued to a Rosemary Zore DOB: 10-07-1976 of 125 Big Springs Drive, Naples, FL 34113.

On 6/21/2022, I arrested Rosemary Zore with the assistance of Collier County Sheriff Office. Rosemary Zore was transported to Collier County Jail without

Your affiant has probable cause to believe and does believe that Rosemary Zore did knowingly and unlawfully commit the crime of Fail to Apply Contributions in a Manner Substantially Consistent with the Solicitation., F.S.S. 496.415(16) – A Felony 3rd Degree – one (1) count.
