NARRATIVE

Narrative:

On 3/22/22, at 1631 hours, I was dispatched to 32330 Tamiami Trail East(Wootens), in reference to a medical call, in which an employee was bit by a tiger.

Upon arrival, I located the subject, Ignacio Meabe Martinez, laying on his back, just south of the tiger enclosure. He was conscious and breathing, but had large open wounds to both of his forearms. There was no active bleeding, but tendons were visible. A few moments later, Cpl Boylan(ID# 2698) arrived on scene, and we applied gauze bandages to both arms. The subject began to pass out, but we kept him awake until Collier County EMS(Medic 60-run# 32167), arrived on scene, and took over treatment for the subject.

I requested to be contacted by General Crimes, and received a call from Sgt Amorosi(ID# 2853). After briefing him on the situation, he said a Spanish speaking detective would be responding, since the witness is Spanish speaking only.

The injured subject was taken to the National Park Service helicopter pad by Collier EMS, to be taken by to the hospital by Lee Med Flight.

Contact was made with the witness, who relayed to us through a translator, that the injured subject, entered the outer tiger enclosure, and followed him as he approached the enclosure containing two tigers. He said he was feeding the tigers their dinner, when the subject approached and attempted to put his hands through the fence to pet a tiger. He said he told the subject to stop what he was doing, but the subject ignored him. Once again, he attempted to put his hand through fence, and succeeded, As a result, he said the tiger grabbed both of the subjects arms with his mouth, and briefly held them, before letting go. After the tiger let the subject go, he said he removed the subject from the fenced in area, placed him on the ground, and

At 1818 hours, Detective Leatherwood(ID# 2487), arrived on scene, and took over the investigation.
