We are looking at this with LDOT . Releasing more water to an area already at capacity may shift a flood burden. Their outfall is ultimately the Six Mile Cypress Slough which then moves into Ten Mile Canal . We appreciate the SFWMD seeking our advice before allowing modifications to individual communities. Our priority in flood events is protection of home and building flooding . Evacuation routes are next priority. Neighborhood road and common area flooding can be expected in large storm events and we respond to obstructions in the County maintained system to assist in overall flood relief. Individual communities should review their internal infrastructure as well.

impassable with water standing 15" deep at the intersection with the flowway. With another potential tropical storm or hurricane forecasted to be heading towards the Gulf and SW Florida, the District needs to take immediate action NOW to lower the level in our main flowway and ponds in both Basins 4 and 5. We need to be permitted by SFWMD to open the slide gates at both of these weir locations. If we start this process immediately, we should be able to lower pond levels by 4-6" before next Tuesday and provide us with additional "holding" capacity to weather this storm event.

Our 1993 Water Management Plan prepared by Johnson Engineering established that the magnitude of allowable flows not exceed 37 cfs per square mile. The same Plan estimates, based on this allowance, a peak flow of 400 cfs from our District at the Treeline Drive flowway intersection. I would propose and request an opening of our gates at Weirs 4 and 5 and monitor the flows at Weir 2 to verify that this rate is not exceeded. By my calculations, 400 cfs over that 25' weir equates to a height of about 36". The District can easily monitor this weir and when the flow reaches a height of say 30", we close the gates! We don't have a lot of time, please allow our District to immediately open these two gates and avoid a flooding of Gateway Greens and other communities in the greater CDD District. Thanks for your consideration of this request.

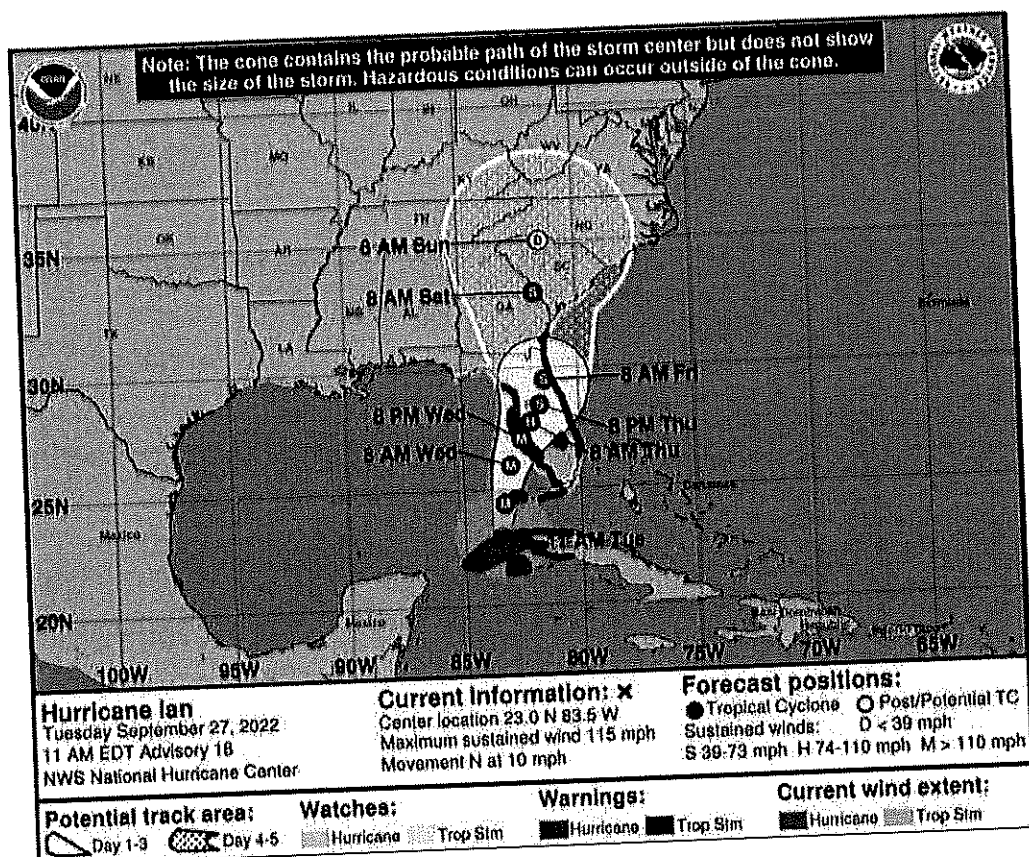

INCIDENT OVERVIEW

Hurricane Ian is currently a Category 3 hurricane with 115 mph sustained winds. Ian's eye has passed over Cuba and is now 155 miles southwest of Fort Myers and moving at a northern trajectory toward Florida's west coast at 10 mph.

The National Hurricane Center has placed Lee County under a Hurricane Warning. The most likely time of arrival of tropical-storm-force winds is 2200 tonight. Hurricane-force-winds are expected to arrive sometime tomorrow (Wednesday) morning.

Life threatening storm surge is increasingly likely for Lee County, with a possibility of up to 15 feet in some coastal areas.

Heavy rainfall is expected over the next few days. Lee County is anticipated to receive 5-10 inches of rainfall. This could cause flooding in areas that are already saturated from prior rain events.

Good evening Commissioners,
It's been a long day watching and reacting to the National Weather Service Hurricane Ian updates. Early this morning we announced mandatory evacuation for Zone A and partial Zone B. Through out the day Hurricane Ian's forecast track inched it's way east and the weather service placed more and more emphasis on storm surges from 6 to 10 feet. As a result it became necessary to order mandatory evacuation of the balance of Zone B and all of Zone C. Shelter openings went from 10 to 14 by mid to late afternoon. Ian is expected to make landfall tomorrow during daylight hours. The exact location is still unknown but the weather service continues to report a Category 4 landfalling storm near Lee County and storm surges continue as a major concern. The forward speed of Hurricane Ian has slowed to 8 mph which means storm impacts will affect Lee County for longer than originally anticipated. Because Ian is expected to linger and because response and recovery operations will be in full swing we have announced that Lee County offices will be closed for the balance of the week. We continue to make operational adjustments based on changing conditions.

The first briefing with the National Weather Service will be at 11:15 AM tomorrow. We have received a number of requests from network tv news programs for interviews throughout the day but mostly in the afternoon. Betsy is creating a schedule that she will share with you in the morning. If you are interested in participating, please let her know so she can coordinate accordingly.
