On 06/01/2020, from 1600Hrs to 2300Hrs, at 3315 Tamiami Trl E, Collier County Government Center, there was a protest, which started off peaceful with no law enforcement action necessary. As the protest went on throughout the night, several people became disorderly, committing such acts as to corrupt public morals, outrage the sense of public decency, affect the peace and quiet of persons who may witness them, or engages in such conduct as to constitute a breach of the peace or disorderly conduct.
Deputies on scene encountered a male later identified as Jordan M. Cook (DOB:05/27/97) was participating in disruptive behavior, which corrupted the public morals and peacefulness of the protests. Cook drew attention to himself causing a scene and forcing deputies to take Cook into custody.
During the course of this protest, several people were removed due to disruptive and disorderly behavior borderline of inciting riots.
Cook was transported by Jail van to the Collier County Jail Center where he was booked in on a Disorderly Conduct charge, F.S.S. 877.03.
